The undersigned is informed and believes that:

COUNT 1

On or about and between November 28, 2025 and November 30, 2025, in the County of Santa Clara, State of California, the crime of ACCESSORY, in violation of PENAL CODE SECTION 32, a Felony, was committed by ALLANA NEVAEH MURILLO, CHRISTIAN JOEL DURAN AND EVAN JOHN MONIZ who did harbor, conceal, and aid Cayleb D, a principal in a felony or felonies, Attempted Murder, in violation of 664-187 of the Penal Code of the State of California, after the felony had been committed, and with knowledge that Cayleb D had committed the felony with the intent that s/he might avoid and escape arrest, trial, conviction, and punishment.

PENAL CODE SECTION 12022.1(b) ENHANCEMENT

(CJIC-BOR, JRS-MM) It is further alleged that at the time of the commission of the offense(s) charged in Count(s) 1, the defendant, ALLANA NEVAEH MURILLO, was out of custody on supervised own recognizance, on a felony, Assault with a Deadly Weapon or by Force Likely to Commit Great Bodily Injury, a violation of 245(a)(1) of the California Penal, within the meaning of Penal Code section 12022.1(b).

PENAL CODE SECTION 12022.1(b) ENHANCEMENT

(CJIC-BOR, JRS-MM) It is further alleged that at the time of the commission of the offense(s) charged in Count(s) 1, the minor, CHRISTIAN JOEL DURAN, was out of custody on supervised own recognizance, on a felony, Assault with a deadly weapon or by force likely to commit great bodily injury, a violation of section 245(a)(1) of the California Penal Code, within the meaning of Penal Code section 12022.1(b).

Any defendant, including a juvenile, who is convicted of and pleads guilty and no contest to any felony offense, including any attempt to commit the offense, charged in this complaint or information is required to provide buccal swab samples, right thumbprints and a full palm print impression of each hand, and any blood specimens or other biological samples required pursuant to the DNA and Forensic Identification Database and Data Bank Act of 1998 and Penal Code section 296, et seq.
