Thank you all for stopping by my office this morning. I'm sorry I'm not able to greet you in person today as I am in Washington, D.C. conducting official legislative business.

I truly appreciate the work that you are doing to advocate for one of the most important issues facing our country and the world, climate change. Your activism plays an essential role in our democracy and it is inspiring to see young folks like yourselves participating.

I have no doubt that climate change is real, human-made, and that we are feeling its devastating effects. We continue to see disruption in our communities and damage to our homes, businesses and communities caused by historic flooding and severe weather that will take years to recover from. Climate change is already impacting Iowa's economy and it will only get worse if we don't act.

One of the most important first steps our country can take is to meet our commitment to the Paris Climate Agreement. As I'm sure you all know, President Trump has announced his intention to unilaterally withdraw the United States from the agreement in 2020. I strongly oppose this action. That's why I was proud to have cosponsored and voted for the Climate Action Now Act, which would prevent the President from withdrawing from the agreement. This legislation passed the U.S. House.

Additionally, I was proud to support the reestablishment of the House Select Committee on the Climate Crisis. This committee is tasked with developing ambitious climate policy recommendations in order to achieve substantial and permanent reductions in pollution. I look forward to seeing what the Select Committee recommends and working to implement these suggestions to address the climate crisis.
