Airlines flight Victim 1 was taking up to much room on the aircraft and was being disrespectful. Suspect 1 asked Victim 1 if he could make room so more people could get off and told Victim 1 that he should not be rude to the customer's since he works for Suspect 1 then followed Victim 1 outside the secure area and was attempting to take a picture with his cell phone of Victim 1's badge when Victim 1 used his left hand in an upward motion hitting his cell phone out of his hand causing his cell phone to land on the floor. Suspect 1 then grabbed Victim 1 and pushed him away and followed Victim 1 out to his vehicle to take a picture of the license plate of the vehicle that Victim 1 was getting into. Suspect 1 then waited on the curb by Victim 1's vehicle until Airport Police arrived on scene.

I made contact with Witness 1, who stated that he did not see Victim 1 hit the cell phone out of Suspect 1's hand. Witness 1 stated that he did see Suspect 1 grab Victim 1 and push him causing Victim 1 to stumble over his bags and Suspect 1 continued to aggressively get into Victim 1's face and followed him out to the curb.

A computer check for wants and warrants was completed on Suspect 1 and Victim 1, both parties responded back negative results for wants or warrants. The incident was captured on video from the security cameras in the area and the video was saved for further review. The security video was saved and stored at 1 International Sq.

Victim 1 stated that his left arm where Suspect 1 grabbed him was sore but stated that he was fine and did not need medical attention. Victim 1 had a small visible bruise on his left arm just above the elbow. Victim 1 stated on scene that at this time he did not want to prosecute and a waiver of prosecution was completed and signed by Victim 1.
