This report includes exempt information On 11/29/2023 at approximately 1945hrs, I was conducting patrol of the park located at 1795 Indian Creek Dr E, Jupiter, Palm Beach County, Florida. I was in full police uniform operating a fully marked Jupiter Police vehicle with red and blue emergency lights. Upon driving into the closed park, I noticed a 2013 Lexus bearing FL Tag Y30ART parked in a parking spot. Due to the vehicle being in a closed park after hours, I activated my red and blue "cruise lights" on my patrol vehicle and began approaching the vehicle. Initially it appeared that the vehicle was unoccupied and as I began providing the license plate to Northcom via my police radio, I noticed a younger white female, later positively identified to be WF [REDACTED] 8/24/2006 (Victim 1), jump from the rear seat to the front seat while pulling her shirt back on. I also noticed a male in the backseat who was later positively identified by FL DL to be WM Sebastiano A. Scionti (2/5/1998). Scionti immediately attempted to exit the vehicle and I gave him lawful orders to sit back in the vehicle and he stated he was just trying to get into the front seat. Scionti complied and sat back down in the rear seat of the vehicle. I identified myself and informed Scionti and Victim 1 that the park was closed and informed them this was not an appropriate place to be at with their clothing off. At this point I asked Victim 1 how old she was as she appeared to be under the age of 18 and she advised she was 18 but when she provided me her name and date of birth it was discovered she was in fact 17. Scionti provided me with his Florida Driver License and advised he was 25 years old. I then began conducting records checks of both subjects and initially Victim 1's information did not return. I again approached the vehicle and as I began walking up to the vehicle I noticed I inadvertently did not activate my Axon BWC and I immediately activated it. After confirming Victim 1's information I returned to my vehicle and was

able to locate her Florida Driver License information confirming she was 17 years old. I verbally confirmed with Victim 1 that she was 17 years old and told her to call her parents however, she stated she did not have her cell phone on her. Victim 1 provided her parents contact information to Ofc. Seier. At this point due to observing Victim 1 jumping into the front seat while putting her shirt back on, and Scionti being 25 years old, I contacted Sgt Brandt to inform him the incident. I then asked Victim 1 to move to the rear of my police vehicle in order to speak with her about what was going on away from Scionti. Victim 1 explained to me that she works with Scionti at Jupiter Farms Elementary. I asked Victim 1 what they were doing in the park and she told me that they were "making out." I asked what else they were doing and she immediately stated that they did not have sex but they were making out and touching each other sexually. Victim 1 told me that she had her clothes off because they were "touching each other sexually." I asked Victim 1 how long she has known Scionti and she told me that she first met him when she was in middle school and he was [REDACTED] Victim 1 continued that she started working at the elementary school with Scionti and have [REDACTED] about a month. Victim 1 stated that Scionti was 25 years old. I asked Victim 1 to expand more on what she meant by touching each other sexually. She said that they touched each other's "private parts." Victim 1 again stated "we did not have sex", so I asked her what she would consider to be sex. Victim 1 said his penis in her vagina. Victim 1 also stated that the male knows how old she is. I then made contact with Scionti and asked him to step out of the vehicle and asked him to sit down on the fence. I read Scionti his Miranda Warnings from a preprinted agency issued card. Scionti stated he understood his rights. I again identified myself and informed him that the park was closed and that's why I was making contact with him. I asked Scionti what they were doing in the back seat and he replied "making out" and said "foreplay with hands." I asked Scionti to clarify what he meant and he said "her hands on me down here..." I again asked for more detail and he said she was touching his penis and he touched her vagina on the outside. Scionti said that he works with her at Jupiter Farms Elementary. Scionti initially stated that hes known her for about 7 months. I asked Scionti if he knew her before work and he said "as badly as this sounds she was [REDACTED] a few years ago." Scionti told me that Victim 1 is 18 and she has told him that she is 18. I again called Sgt. Brandt to keep him updated about this incident and he advised that he was responding to the scene. I again made contact with Victim 1 and she told me that she is employed through the school district. Victim 1 told me that Scionti knew she is 17 because she has told him that she is 17. I informed Victim 1 that we would be standing by for a short time while we waited for Sgt. Brandt to arrive on scene. At this point I began asking Victim 1 unrelated questions about herself and what she wanted to do for her career. A short time later, Victim 1 was relocated to the other side of the

park away from Scionti while completing the rest of the investigation. I also called Victim 1s father to come to the scene. I made contact with WM [REDACTED] (5/6/1969) who arrived on scene and is the father of Victim 1. Sgt. Brandt and I spoke with [REDACTED] and informed him that his daughter Victim 1 was with a 25 year old having a sexual encounter. [REDACTED] told me that he wanted to press charges on the male if he was able to. [REDACTED] was also concerned that the Scionti worked at the school and wanted to ensure that's reported. I collected [REDACTED] information and stood by with him for a short time. I later spoke with Victim 1 again to get a sworn statement about the incident in more detail. Victim 1 was sworn in and stated that they were making out and she was partially undressed and explained her underwear were off during portions of the time. Victim 1 said that they were touching each other's genitals. I asked Victim 1 if she was touching his penis and she said yes. Victim 1 said she was touching his penis while his pants were on but her hand was inside of his pants. Victim 1 told me that they continued to make out and were getting ready to leave. Victim 1 said that Scionti touched her vagina inside of her pants but did not penetrate her. Victim 1 also told me that Scionti was touching her breasts under her bra with her shirt being off. I asked Victim 1 if they performed oral sex and she said yes. I asked Victim 1 how and she said that he performed oral sex on her but she did not perform oral sex on him. Victim 1 said that at this point they were getting ready to go back to her vehicle and her phone. I again asked Victim 1 how long they have known each other and she said a few months. Victim 1 clarified that she knew Scionti in the past but did not actually meet each other. Victim 1 said she is an after school counselor and helps out with different groups of kids and told me that Scionti is not her boss or supervisor. Victim 1 again stated that Scionti knows that she is 17 years old because she has told him. Victim 1 said that she started her job in August and Scionti returned in September and have [REDACTED] about a month. Victim 1 denied ever having sex with Scionti in the past and said that they have only done what they did tonight in the past. Victim 1 said that she has never been forced to do anything by Scionti and did not feel uncomfortable around him. Sgt. Brandt also told me that during his conversation with Victim 1, she told him that she [REDACTED] Scionti for about four days but has been "fooling around" for approximately a month. Victim 1 also told Sgt. Brandt that they "fool around" inside the school after everyone leaves and this is the first time they have done this in a public place. Sgt. Brandt also completed a supplemental report for this case. I later provided [REDACTED] and Victim 1 with a Victims Rights Brochure and also explained with [REDACTED] a consent to search Victim 1's phone. Ofc. Seier later recovered Victim 1's phone and had [REDACTED] sign the consent to search and provided [REDACTED] with a copy of the consent to search.

Based upon the totality of circumstances and my entire investigation, I developed probable cause to arrest WM Sebastiano A. Scionti (2/5/1998) for Unlawful Sexual Activity with a Minor as Sebastiano A. Scionti did, while 24 years of age or older, engage in oral, anal, or vaginal penetration by, or union with, the sexual organ of * [REDACTED] a person 16 or 17 years of age, contrary to Florida Statute 794.05(1). I also developed probable cause to arrest WM Sebastiano A. Scionti (2/5/1998) for Indecent, lewd, or lascivious touching of certain minors as Sebastiano A. Scionti did, while 24 years of age or older, intentionally touch in a lewd or lascivious manner, the breasts, genitals, genital area, or buttocks, or the clothing covering them, of a person 16 or 17 years of age, or forces or entices a person 16 or 17 years of age to so touch the perpetrator, contrary to Florida Statute 794.051(1). Scionti was placed into handcuffs which were double locked and checked for spacing. He was advised that he was under arrest as Victim 1 was a minor. Scionti again stated that she was 18. Scionti was also searched and he was secured in my patrol vehicle. Scionti was later transported to the Jupiter Police Department for processing and later transported to the Palm Beach County Jail and turned over to booking staff. I later went through messages between Victim 1 and Scionti on Victim 1s cell phone and in multiple messages Victim 1 states she is 17 and Scionti acknowledges those messages multiple times. In particular on 10/22/23 Victim 1 states "AHM 17 AHM" and Scionti replies "AHM IDGAF AHM." Victim 1 states "AHM JAIL AHM." Scionti replies "AHM EH WORTH IT AHM." There are also multiple messages eluding to sexual activity between Victim 1 and Scionti. Sciontis phone was also taken and placed into Jupiter Police Evidence. Victim 1's cell phone was later placed into evidence along with the consent to search. Sciontis vehicle was later removed from the scene by Kauffs Towing. Palm Beach County School Board Police was notified of the incident by Sgt. Brandt.
