On the **15** day of **October**, **2020** at **19:32** (Specifically include facts constituting cause for arrest.)

On October 15th, 2020 at approximately 10:00 hours - uniformed patrol Officer L. Gordon ID# 1257 and Officer R. Venier ID#1835 responded to the Red Roof Inn Hotel ROOM #112, located at 2421 Metrocentre Blvd E, West Palm Beach, Florida, 33407 in reference to a welfare check of a black female identified by the 911 caller as Barbara Walker born 11-23-85.

Barbara Walker was a registered guest at this hotel. Upon arrival, Officers announced their presence at the front door of room #112. Officers noted the door was locked and there was no answer from within. Officers then contacted Hotel Manager Kevin Hurst for access into the room.

Further, the initial allegations made by the 911 caller who identified himself as Paul Padillo were that his goddaughter, Barbara Walker, was being held against her will inside of room #112 and not allowed to leave. Padillo disclosed to WPBPD-911 Dispatchers that Barbara Walker was paraplegic unable to leave on her own without any assistance hence why he contacted WPBPD for further assistance.

Prior to unlocking and opening the door to room #112 with the assistance of Hotel Manager Kevin Hurst, Officers announced themselves as "POLICE". Kevin Hurst also announced, "I have the police here." Upon the room door slightly opening, the occupant(s) of room #112 shot 1 gunshot at Officers Venier, Officer Gordon and Hotel Manager Kevin Hurst who were standing within close proximity of the front door. In fear of losing their lives, uniformed Officers and Kevin Hurst ran away from room #112 and away from active gunfire. It is then when the occupants of room 112 shot at least 3 more times from within the room.

Further investigation revealed that Barbara Walker was the lone occupant of room #112. Walker barricaded herself while armed with a firearm and refused to exit the room. Walker actively continued shooting from within the room as WPBPD Officers began

evacuating adjacent hotel rooms. This incident was now deemed an active shooter situation. Multiple attempts were made to speak with Barbara Walker via hotel landline phone and cellphone with no success.

At approximately 1200 hours, WPBPD Special Weapons and Tactics SWAT responded to this incident and began deploying non-lethal force in attempts for Barbara Walker to surrender. A loud speaker was utilize to communicate with Barbara Walker, she refused cooperation and continued shooting from within room 112. At 13:20 hours, WPBPD SWAT was able to subdue Walker and took her into custody without any further incident. Walker was transported to Good Samaritan Hospital for medical clearance, and ultimately taken to the WPBPD Criminal Investigation Division for further investigation and interview.

A search of room #112 revealed a loaded, chromed, Colt .380 under the bed. In addition, at least 6 spent casings were located within the room. Further room inspection revealed 3 projectiles, 1 projectile was lodged in the wall slightly above the front room door. 2 projectiles were lodged into the wall of the adjacent room.

An independent witness, Courtney Honeycutt, disclosed to your Affiant that she heard when WPBPD Officer Gordon and Officer Venier announced themselves as the POLICE while they were standing in front of room 112. Honeycutt was outside of her room #118 when she witnessed the Hotel Manager and the Officer attempting to make contact with the occupant(s) of room 112. Shortly thereafter, Honeycutt heard the gunshots coming from room #112. In fear of losing her life, Honeycutt ran back into her room.

During a sworn recorded statement, Hotel Manager Kevin Furst stated he feared for his life when Barbara Walker began shooting from within the room. WPBPD Officers Gordon and Venier also provided sworn recorded statements to your Affiant.

During a post Miranda recorded statement, Barbara Walker denied being in possession of a loaded firearm and denied shooting at WPBPD Officers and Kevin Hurst. Walker admitted she heard when the uniformed Officers were at the door. Walker requested an attorney and refused to answer any further questions.

Lastly, Defendant Barbara Walker, although handicapped, was offered countless opportunities to surrender to the WPBPD Officers on-scene during a 4 hour time period. In addition, Walker's life was not in any immediate threat or danger upon the arrival of Officer Gordon and Officer Venier. Barbara Walker willfully, knowingly and unprovokedly shot at law enforcement officers using a chrome, Colt .380. Barbara Walkers actions displayed disregard for the lives of WPBPD Officers on scene, and hotel employees and guests.

At this time based on Your Affiants thorough investigation, witness statements, suspect identification, all aforementioned facts, Your Affiant finds probable cause to charge
