AMENDED FELONY
COMPLAINT

The People of the State of California upon oath of the undersigned, upon information and belief complain against the defendant above named for the crime(s) as follows:

COUNT ONE

On or about and between June 17, 2024, and June 18, 2024, at and in the County of Sacramento, State of California, the defendant, DARRIN LAWRENCE BELL, did commit a felony, namely: a violation of Section 311.11(a)(1) of the Penal Code of the State of California, in that said defendant did unlawfully and knowingly possess and control any matter, representation of information, data, or image depicting a person under the age of 18 years personally engaging in or simulating sexual conduct as defined in Penal Code Section 311.4(d).

It is further alleged, as to Count One, that the matter contains more than 600 images that violate Penal Code 311.11(a)(1), and the matter contains 10 or more images involving a prepubescent minor or a minor who has not attained 12 years of age, within the meaning of Penal Code 311.11(c)(1).

5 For a further and separate cause of action, being a different offense from but connected in its
6 commission as the charges set forth in Count One hereof: On or about January 15, 2025, at and
7 in the County of Sacramento, State of California, the defendant, DARRIN LAWRENCE BELL,
8 did commit a felony, namely: a violation of Section 311.11(a)(2) of the Penal Code of the State
9 of California, in that said defendant, did unlawfully and knowingly possess and control any
10 matter, representation of information, data, image, or digitally altered or artificial-intelligence-
11 generated data depicting what appears to be a person under 18 years of age, personally engaging
12 in or simulating sexual conduct as defined in Penal Code Section 311.4(d).
