On 05/25/2023, the Wisconsin Department of Justice (DOJ) assigned National Center for Missing and Exploited Children (NCMEC) Cyber Tip #157646981 to the Waukesha County Sheriff's Department. The Cyber Tip was from the Electronic Service Provider "Reddit."

On 03/07/2023 at approximately 9:29 pm, Reddit username "Rickyslick698" uploaded one image of apparent child pornography via a Reddit chat message. Reddit reported the apparent child pornography to the National Center for Missing and Exploited Children (NCMEC), and NCMEC subsequently created cyber tip #157646981.

Reddit identified the username to be "Rickyslick698[,]" with an associated email address of "smithrucky569@gmail.com[.]" Reddit provided the IP address for the upload, which was 173.89.7.1.

NCMEC Cyber Tip provided a geo-lookup of the suspect IP Address, which indicated it was in Wisconsin. This case was then referred to the Wisconsin Department of Justice (DOJ). On 05/21/23, DOJ served an administrative subpoena to Charter, requesting subscriber information for the IP address 173.89.7.1.

On 05/25/2023, Charter indicated that IP address 173.89.7.1 had a Subscriber Name whom was later identified as Witness A. The Charter Lease Log showed a lease start date of 07/01/2022 and a lease end date of 04/05/2023. The address provided was a residential address in Pewaukee. The case was assigned to the Waukesha County Sheriff's Department on 05/25/2023.

Count 1:

Detective Mensah reviewed the image that was the subject of the Cyber Tip and it is described as follows:

This file is a still image. The image depicts a fully nude prepubescent light skinned female, with brown pigtalls with white hair ties, sitting on what appeared to be a dresser. Her left Jeg was tucked under her, and she was sitting on her left foot/ankle, while her right leg was hanging off the dresser. She was leaning toward her right side, with her right hand on her right thigh, and her left hand/wrist, holding/wrapped around the left side of her waist/hip area. Her upper body was slanted slightly to her left, while she looked at the camera, smiling, with what appeared to be lipstick on her lips. The prepubescent female had no pubic hair growth. The female's chest and right nipple were exposed and there was no breast development. Her legs were open at an approximately 45-degree angle, exposing and drawing attention to her genitals. In the upper right corner of the photo was a watermark/image of an angel with wings and a halo, with the words "Ukrainian Angels" above the angel, and www.ukranian-angels.com below the angel.

Detective Mensah conducted a CLEAR search on the Hunters Court address, which showed a subject identified as Jonathan W Angle (M/W, 02/14/2000, hereinafter referred to as the defendant and Witness A. Detective Mensah learned that an associated email address for the defendant was "angljon698@gmail.com". The "698" in that email address, also appeared in the Reddit Screen name on the Cyber Tip of "Rickyslick698".

A residential search warrant was executed on 7/31/23 and the Defendant was taken into custody, was given his constitutional rights and agreed to waive the same. During the interview, the defendant stated that he watched porn daily and that he had a porn addiction to the point that he has communicated with people through Reddit to discover new Snapchat premium accounts, sexting accounts and to get amateur nudes. The defendant admitted that a common email address he used was Anglejon698@gmail.com. The defendant stated that he used Kik, Telegram, and Instagram in the past to obtain pornography and used Instagram private message to get people to sell him their nudes. The defendant stated that he used Telegram to get nudes of college students and used Reddit to talk to girls and message them.

The defendant admitted that he messaged girls on Reddit a lot and believed that since he messaged so many girls, he was kicked off of Reddit. The defendant stated that he was looking for girls that would talk for free instead of him having to pay for porn, but he also said he would trade pictures including "dick pics". The defendant stated that some of the forums he was on included topics about role playing and rape fantasies. The defendant was asked about Rickyslick698, and he stated he was pretty sure that was the account he got banned on and that he uses a similar account name now. The defendant was informed that the Reddit account that he admitted was his had been used to send an illegal image. The defendant stated that he searched on Reddit and talked to many people in an attempt to get rape and fantasy rape videos. The defendant stated at one point he was told by another Reddit user that if he wanted real rape videos, he needed to use a Tor browser. The defendant stated over a two year period, he would go on Tor to find rape porn, and he wanted real videos. The defendant stated when he searched for rape videos on Tor, he would click on links he thought would take him to rape videos. The defendant stated on several occasions over that two year time period the Tor links he clicked on contained child pornography. The defendant claimed when he saw the illegal images, he would exit out of Tor and deleted the app. The defendant said every few weeks, he would redownload Tor to look for rape videos, and if he saw child pornography, he would exit the app and delete it. The defendant also admitted to talking to girls that initially told him they were 18, but later said they were 16, and that, "I probably should have not kept communicating with that girl."

During the interview, the defendant was asked why he thought the SWAT team was at his house that morning, and the defendant stated that he assumed he'd be the target of the search warrant, because the only time the SWAT team shows up from his experience, is either drugs or child pornography. The defendant stated that anytime he was on Tor and "accidentally" clicked on child pornography, he got off the site right away. The defendant further said, "Obviously, I sent it to somebody and that's why I'm here. Like I said, you guys don't just, don't arrest people for no fucking reason."

Witness A was interviewed and indicated that she and the defendant had lived at the residence in Pewaukee for the last year. Witness A confirmed that the Wi-Fi at the residence was password protected and that the email the defendant used was JonAngle698@gmail.com.

A forensic examination was completed on the cell phone that was recovered belonging to the defendant. The follow images were located during the forensic examination.

On 03/07/2023 at approximately 9:29 pm, Reddit username "Rickyslick698" uploaded one image of apparent child pornography via a Reddit chat message. Reddit reported the apparent child pornography to the National Center for Missing and Exploited Children (NCMEC), and NCMEC subsequently created cyber tip #157646981.

Reddit identified the username to be "Rickyslick698[,]" with an associated email address of "smithrucky569@gmail.com[.]" Reddit provided the IP address for the upload, which was 173.89.7,1.

NCMEC Cyber Tip provided a geo-lookup of the suspect IP Address, which indicated it was in Wisconsin. This case was then referred to the Wisconsin Department of Justice (DOJ). On 05/21/23, DOJ served an administrative subpoena to Charter, requesting subscriber information for the IP address 173.89.7.1.

On 05/25/2023, Charter indicated that IP address 173.89,7.1 had a Subscriber Name whom was later identified as Witness A. The Charter Lease Log showed a lease start date of 07/01/2022 and a lease end date of 04/05/2023. The address provided was a residential address in Pewaukee. The case was assigned to the Waukesha County Sheriff's Department on 05/25/2023.

Count 1:

Detective Mensah reviewed the image that was the subject of the Cyber Tip and it is described as follows:

This file is a still image. The image depicts a fully nude prepubescent light skinned female, with brown pigtails with white hair ties, sitting on what appeared to be a dresser. Her left Jeg was tucked under her, and she was sitting on her left foot/ankle, while her right leg was hanging off the dresser. She was leaning toward her right side, with her right hand on her right thigh, and her left hand/wrist, holding/wrapped around the left side of her waist/hip area. Her upper body was slanted slightly to her left, while she looked at the camera, smiling, with what appeared to be lipstick on her lips. The prepubescent female had no pubic hair growth. The female's chest and right nipple were exposed and there was no breast development. Her legs were open at an approximately 45-degree angle, exposing and drawing attention to her genitals. In the upper right corner of the photo was a watermark/image of an angel with wings and a halo, with the words "Ukrainian Angels" above the angel, and www.ukranian-angels.com below the angel.

Detective Mensah conducted a CLEAR search on the Hunters Court address, which showed a subject identified as Jonathan W Angle (M/W, 02/14/2000, hereinafter referred to as the defendant and Witness A. Detective Mensah learned that an associated email address for the defendant was "angljon698@gmail.com". The "698" in that email address, also appeared in the Reddit Screen name on the Cyber Tip of "Rickyslick698".

A residential search warrant was executed on 7/31/23 and the Defendant was taken into custody, was given his constitutional rights and agreed to waive the same. During the interview, the defendant stated that he watched porn daily and that he had a porn addiction to the point that he has communicated with people through Reddit to discover new Snapchat premium accounts, sexting accounts and to get amateur nudes. The defendant admitted that a common email address he used was Anglejon698@gmail.com. The defendant stated that he used Kik, Telegram, and Instagram in the past to obtain pornography and used Instagram private message to get people to sell him their nudes. The defendant stated that he used Telegram to get nudes of college students and used Reddit to talk to girls and message them.

The defendant admitted that he messaged girls on Reddit a lot and believed that since he messaged so many girls, he was kicked off of Reddit. The defendant stated that he was looking for girls that would talk for free instead of him having to pay for porn, but he also said he would trade pictures including "dick pics". The defendant stated that some of the forums he was on included topics about role playing and rape fantasies. The defendant was asked about Rickyslick698, and he stated he was pretty sure that was the account he got banned on and that he uses a similar account name now. The defendant was informed that the Reddit account that he admitted was his had been used to send an illegal image. The defendant stated that he searched on Reddit and talked to many people in an attempt to get rape and fantasy rape videos. The defendant stated at one point he was told by another Reddit user that if he wanted real rape videos, he needed to use a Tor browser. The defendant stated over a two year period, he would go on Tor to find rape porn, and he wanted real videos. The defendant stated when he searched for rape videos on Tor, he would click on links he thought would take him to rape videos. The defendant stated on several occasions over that two year time period the Tor links he clicked on contained child pornography. The defendant claimed when he saw the illegal images, he would exit out of Tor and deleted the app. The defendant said every few weeks, he would redownload Tor to look for rape videos, and if he saw child pornography, he would exit the app and delete it. The defendant also admitted to talking to girls that initially told him they were 18, but later said they were 16, and that, "I probably should have not kept communicating with that girl."

During the interview, the defendant was asked why he thought the SWAT team was at his house that morning, and the defendant stated that he assumed he'd be the target of the search warrant, because the only time the SWAT team shows up from his experience, is either drugs or child pornography. The defendant stated that anytime he was on Tor and "accidentally" clicked on child pornography, he got off the site right away. The defendant further said, "Obviously, I sent it to somebody and that's why I'm here. Like I said, you guys don't just, don't arrest people for no fucking reason,"

Witness A was interviewed and indicated that she and the defendant had lived at the residence in Pewaukee for the last year. Witness A confirmed that the Wi-Fi at the residence was password protected and that the email the defendant used was JonAngle698@gmail.com.

A forensic examination was completed on the cell phone that was recovered belonging to the defendant. The follow images were located during the forensic examination.

exposing her genitals. The prepubescent female had no pubic hair growth. The female's nipples were covered by her legs but you could see no breast development. She held her left foot by the arch of her foot with her left hand, and held her right foot by the arch of her foot with her right hand.

Your complainant is aware that in 2010, NCMEC identified "BD-COMPANY" as a known magazine for child pornography.

A forensic examination of the defendant's computer is ongoing.
