## **Body Camera Timeline**

## Officer Webster

- Officer Webster asks if he and Anton Black are brothers. Anton Black tells Officer Webster they are brothers but says they are not by yelling "he's not my brother Bro".
- 00:11 Officer Webster asks Anton Black to place his hands behind his back. Anton Black then tells Officer Webster "I love you".
- 00:17 Anton flees on foot running North on Route 313.
- 00:31 Officer Webster gets inside his patrol vehicle, and makes a U turn to pursue Anton Black.
- 0043: Officer Webster notifies 911 center that Anton has fled on foot and that he is schizophrenic.
- 00:47 Officer Webster stops vehicle and observes Anton Black running South on Route 313. Anton is being pursued by Officer Lannon who is in an off duty capacity. You can observe this on the body camera as they run past officers Webster's vehicle.
- 00:49 An unidentified civilian is seen crossing over Route 313 in an effort to assist Officer Lannon.
- 00:52 Officer Webster exits his vehicle and pursues Anton Black on foot, leaving his vehicle along Route 313.
- 01:06 Officer Webster notifies 911 center that he is in a foot pursuit of a "black male" who tried to abduct
- 01:17 Officer Webster continues to pursue Anton black on foot. As Officer Webster is pursuing Anton Black he passes Officer Lannon who standing alongside Route 313. Officer Lannon has stopped pursuing Anton black at this time.
- 01:29 Officer Webster call out description of Anton Black to 911 Center.
- 01:36 Motorcycle travels past Officer Webster in a slow manner. Civilian motorcyclist identified as
- 01:45 Motorcyclist pulls off the road in front of Anton Black as Anton Black continues running.
- 01:54 Officer Webster approaches Gary Wyatts trailer park.
- 01:57 Officer Webster's silver patrol vehicle is seen pulling in front of trailer park. Vehicle is being operated by Chief Manos, Ridgely Police Department.
- 02:05 Both the motorcyclist and Chief Manos stop their vehicles on roadside before entering trailer park.
- 02:11 Officer Webster is still in pursuit of Anton Black as they run towards lot #2. You can observe Anton Black in distance.

- 02:13 Chief Manos pulls up next to Officer Webster as he is running. Officer Webster asks Chief Manos to continue pursuing Anton Black.
- 02:28 As Anton Black and Officer Webster reach lot #2, Anton Black gets into the driver's seat of a white Honda Accord.
- O2:35 Anton Black is seated in the driver's seat of the white Honda and locks the door. Officer Webster pulls his ASP baton and strikes the drives window twice, shattering the glass.
- 02:42 Chief Manos yells "watch his hands" and Officer Webster draws his Taser and fires once thorough the driver's window. The Taser strikes Anton with one prong and the circuit does not complete. At the time the Taser is discharged, Anton is climbing across the center console in an effort to exit the vehicle via passenger door. Officer Webster says "Taser, Taser, Taser on body cam".
- 02:42 Anton Black exits the vehicle and becomes involved in a physical altercation with Chief Manos. Chief Manos is wearing tan shorts and blue shirt. The altercation continues as Anton Black resists arrest. As Anton Black and Chief Manos continue to struggle they work their way up the handicap ramp to the front door of the residence. Chief Manos continues telling Anton Black to "stop, you're under arrest".
- O3:23 Officer Webster has now begun to assist Chief Manos with placing Anton Black under arrest. It was during this struggle that Anton is talking out loud asking someone to open the door. Officer Webster informs Chief Manos that Anton Black is schizophrenic and Chief Manos acknowledges.
- Officer Webster asks someone to grab Anton Blacks leg and pull it under him as they try to secure Anton Black. It's at this time that Kevin Clark, (civilian motorcyclist) assists with securing Anton Black.
- O3:51 Anton Black is now on the ground, and assisting with cuffing is Officer Webster, Chief Manos, Officer Lannon (off duty) and (civilian motorcyclist.)
- O3:56 Chlef Manos asks Officer Lannon to "prone him out" and Officer Lannon straightens Anton's leg out onto the ramp. At this time Chief Manos appears to be laying partially across Antons Back, Officer Lannon is at his legs and civilian is near Anton's head. Chief Manos tells Anton to "stop fighting" and Officer Webster cautions everyone that Anton is "schizophrenic".
- 04:49 Anton Blacks mother exits the trailer and then goes back inside.
- 05:05 Anton Black is handcuffed and his mother comes back outside the trailer.
- 05:15 Officer Webster narrates to the body camera that Anton tried to abduct a twelve-year-old and then fled from the police. Anton is still on his stomach at this time.
- 05:23 Anton Blacks legs are still moving and a male exits the residence.
- 05:30 Anton's leg hits Officer Lannon in the face and Chief Manos tells Anton to "stop".
- 05:33 Anton's mother tells him to stop.
- 05:43 Officer Webster instructs someone to go get leg shackles out of the trunk of the car. Also at this time you hear Anton telling his mother that he loves her.

- 05:57 Chief Manos tells Anton to "relax".
- 06:52 Officer Webster asks Anton's mother if she has a diagnosis for him. Anton's mother responds but I cannot understand what is said on bodycam.
- 07:50 Officer Webster instructs off duty officer, Sgt. Baker, Caroline county Sheriffs Dept. to place the legs restraints on Anton Black. Officer Webster also informs officers that this will be an EP. (Emergency Petition)
- 09:00 Officers are unable to get the leg restraints to secure properly.
- 09:18 Officer Webster explains to Anton's mother that this is a mental health emergency, and they are not treating this as a crime.
- 09:44 Officers are able to secure Anton's legs.
- 10:00 Officer Webster and Chief Manos roll Anton Black onto his side.
- 10:09 Anton appears to be unresponsive. Chief Manos informs officers that he is breathing and has a pulse.
- 10:21 A request is made that someone check Anton's wrist for a pulse. Chief Manos informs Sgt. Baker that he can feel his heart beating.
- 10:40 Officer Webster relays patient information for EMS
- 10:48 Officers take Anton out of recovery position and place him so that he is sitting in the upright position.
- 11:49 Officer Webster notifies 911 that Anton is not conscious and alert.
- 12:49 Anton's mother says "he is turning dark" Chief Manos then puts Anton on his back and removes his handcuffs.
- 13:20 Officer Webster instructs officers to start with compressions and Chief Manos informs Officer Webster to have EMS "step it up" (expedite).
- 13:52 EMS acknowledges to expedite.
- 14:09 CPR is started. Chief Manos is assisting with breathing and Sgt. Baker is performing chest compressions.
- 14:57 Chief Manos requests an AED.
- 15:51 EMS walks up ramp and notifies officers that Anton could of possibly smoked laced marijuana.
- 17:10 CPR is continuous
- 17:22 AED advises "no shock"
- 17:59 Deputy Thamert takes over chest compressions.
- 18:25 Officers attempt to use AED a second time but instrument advises to continue CPR.

- 19:00 Dep. Thamert switches with EMT, for chest compressions.
- 20:45 EMS arrives and continues CPR and advanced life support.
- 38:09 Anton Black is placed on ambulance and Body camera is turned off
