Probable Cause:

On or about October 24, 2019, Auburn Police met with family members of Aniah Haley Blanchard, alias, in reference to a missing person complaint. Blanchard was last seen by a family member the evening of October 23, 2019, at a residence in the

Jordan, Auburn, Lee County, Alabama. The victim's vehicle, a black 2017 Honda CRV bearing Alabama license 49BS356 and VIN 5J6RW5H32HL004086, was later located abandoned in Montgomery, Alabama. Blood evidence was discovered in the passenger's compartment of the vehicle that was indicative of someone suffering a life-threatening injury. The evidence was submitted to the Alabama Department of Forensic Sciences and confirmed to be that of Aniah Blanchard. Video evidence from a convenience store located at 1599 South College Street, Auburn, Lee County, Alabama placed both Blanchard and a black male, later positively identified as Ibraheem Yazeed, alias at the store during the same time; this was the last time she was seen. During the subsequent investigation a vehicle. Blanchard has not been located at this time.

Further investigation revealed that Antwain Shamar Fisher, alias, "Squirmy", alias, provided material assistance to Yazeed by providing transportation to Yazeed, and disposing of evidence.
