NARRATIVE:

On October 24, 2022, Palm Beach County Animal Care and Control (ACC) Officer Coutts received a phone call from a man, later identified as Leandro Jubilut, who advised he was calling for his wife who only speaks Portuguese. Leandro stated his wife is a dog groomer at American Dog Pet Grooming located in Boca Raton and she was devastated about witnessing animal cruelty and abuse from one of the groomers at the salon who inflicted pain and suffering to dogs in his care. Leandro sent Officer Coutts five videos. Officer Coutts reported that he viewed the videos and determined the abuse to be criminal. ACC Sgt. Cueto followed up with Leandro.

On October 25, 2022, Palm Beach County ACC Sgt. Cueto reported the following: Sgt. Cueto made contact with Leandro Jubilut in regards to the complaint against American Dog Pet Grooming, located at 6909 SW 18th St. A114 Boca Raton, FL 33433. The actual name of the corporation is Bresciani Camargo, LLC and the owners are Alessandra Bresciani Barreto and Plinio Roberto De Camargo Jr. of Deerfield Beach, FL according to the Florida Division of Corporations. Leandro provided video recordings that his wife, Edione Silva, recorded. Edione is currently employed by the establishment. Leandro stated a few groomers resigned due to the abuse De Camargo was inflicting on the dogs. Sgt. Cueto explained the investigation process to Leandro who Edione is fully committed to cooperating with the investigation.

NARRATIVE CONTINUATION

Leandro said he previously contacted Crimestopper's and reported abuse by De Camargo (Crimestopper's tip ID #324-C17062, ACC Case #A22-005660). The allegation was that De Camargo abused a dog that later passed away at the veterinarians office. ACC conducted an investigation however; it appears due to insufficient evidence the case was closed. Leandro stated the dog in the earlier case was abused, causing it to have a heart attack. Leandro explained that when De Camargo abuses a dog, Alessandra Bresciani Barreto informs the dog owner their dog was stressed and had a difficult time being groomed. Alessandra tells the owner to keep an eye on their dog and to take it to their veterinarian. Sgt. Cueto informed Leandro he would be sending a sworn statement for Edione to complete. Sgt. Cueto requested Leandro contact any witnesses that may have recordings or observed the abuse first hand so their account can be documented. Sgt. Cueto advised Leandro an investigator would be contacting him and Edione for further questioning. Sgt. Cueto briefed ACC Sgt. Sharpe and ACC Lt. Kelso on the case. Sgt. Cueto's case number related to this incident is A22-010899.

On May 31, 2022, ACC received an anonymous Crimestopper's complaint stating the owner (Plinio) of a pet grooming establishment, located at 6909 SW 18th St. Boca Raton, FL, is very abusive to animals, manhandles, chokes, and punches animals that do not behave. The caller advised an incident occurred the day before the complaint where a dog had to be treated by a veterinarian and later died. ACC Sgt. Moulton conducted an investigation related to this complaint and documented his findings in ACC case #A22-005660. Sgt. Moulton concluded there was no evidence of physical abuse at the time, and the investigation was closed.

On October 26, 2022, ACC Sgt. Sharpe informed me of the animal abuse complaint from Edione and Leandro. Sgt. Sharpe emailed me the videos provided by Edione and Leandro. The first video shows a white male using an air compressor to blow-dry a black puddle in the sink. The male appears to be forcefully manhandling the dog, grabbing the dog by the back of the head, pulling the dogs hair, and pushing the dog down into the sink. The second video shows the same male subject grooming a small tan dog on a table. The subject forcefully pushes the dog down onto the table while combing the dog's hair. The subject raises his right arm and hand, and with a closed fist punches the dog. The subject then looks back before striking the dog a second time with his right hand. The dog yelps and cries, and appears to be in pain from the man hitting it. The third video shows the same male subject using an air compressor to blow-dry a small white dog in the sink. The subject is grabbing the dog by the back of the head and twisting the dog's hair while lifting it up to blow-dry it. The fourth video shows the same male subject lifting a small dog off a table and bringing it over to the sink.

NARRATIVE CONTINUATION

The subject picks the dog up by the hair on the back of its head and the hair on the dog's body to carry it over to the sink. The dog yelps when the subject picks it up by the hair. The fifth video shows the same male subject holding a small tan dog by the hair on the back of its head while he was attempting to groom the dog on a grooming table.

On October 27, 2022 at approximately 7:45AM, I met with Edione Silva and Leandro Jubilut. Leandro said he is Edione's husband, and Edione told him about the animal abuse at American Dog Pet Grooming. Leandro advised he would be translating because Edione's first language is Portuguese. Edione said she has been employed by American Dog Pet Grooming since January 2022. Edione is responsible for bathing the animals and assisting with their grooming. Edione stated the owners of the grooming salon are Alessandra Bresciani Barreto and Plinio Roberto Jr. De Camargo. Edione confirmed she took the five videos animal care and control sent me. Edione said she recently took the videos over the course of several days. Edione said the male subject abusing the dogs in the five videos is the owner Plinio. I showed Edione the videos presented to me by ACC and Edione identified the male subject in the videos as Plinio. Edione further advised Plinio abuses dogs on a daily basis by hitting them with his hand, a brush, a nail file, clipper, or other grooming items. Edione has witnessed the abuse first hand and observed Plinio on multiple occasions twist a dog's paws and limbs, and pull on a dog's hair while striking it. Edione said the dogs Plinio grooms tremble in fear and often cry. Edione believes Plinio gets frustrated when dogs misbehave and hits them so they will stop moving. There are times Plinio stopped grooming a dog and another groomer would take over due to his frustration from the dog not keeping still. When the other groomer takes over the dogs' are fine. Edione said it is obvious the dogs do not like Plinio. Edione constantly hears dogs' Plinio is grooming cry and yelp from him striking them, and has only been able to capture a small amount of the abuse on video. Edione explained she usually hears the dogs crying and yelping and then will try recording the abuse by Plinio. Edione is uncertain who the owners of the abused dogs' are. Edione provided the names of two former employees of American Dog Pet Grooming who may have witnessed the abuse. Edione provided the names Marivone (phone # 954-856-0846) and Bernardo (phone # 954-225-9515). Edione said they both speak Portuguese. Edione said she would try to take video of any additional animal abuse she witnesses and have Leandro email them to me.

On October 27, 2022, Leandro emailed me a video clip and said Edione took the video on October 27, 2022 while she was working. Edione told Leonardo Plinio abused the white medium sized dog in the video.

NARRATIVE CONTINUATION

The video shows the male subject Edione previously identified as Plinio blow-drying what appears to be a medium sized white Golden Doodle in the sink. Plinio is pulling of the dog's hair with his hand. Plinio raises his left arm and with his left hand smacks the dog in the face. In the video, I can hear the dog yelping and crying.

On October 27, 2022, Palm Beach County Deputy Sheriff Mauricio Vasconcelos (ID #23113) spoke with Marivone Marcolino Jorge Roncato in Portuguese. Marivone advised she was working for Plinio at American Dog Pet Grooming in August 2022. Whenever Plinio was grooming a dog, Marivone would constantly hear dogs crying as if they were in pain. Marivone said the crying was not normal crying or whimpering, but a crying as if someone was hurting them.

On October 27, 2022, I spoke with Bernardo Neto and Mario Loureiro via telephone. Mario stated Bernardo's primary language is Portuguese. Mario advised he is married to Bernardo and offered to translate the conversation. Bernardo works as a groomer for Plinio at American Dog Pet Grooming. Bernardo has heard dogs' in Plinio's care yelp and cry as if they were in pain. Bernardo has not visibly seen the abuse, but can knows Plinio has been abusive with the dogs based on the dogs reaction to him and the crying and yelping only exhibited by the dogs Plinio grooms.

Based on the statement and video provided by Edione, and the information provided by Marivone and Bernardo, probable cause exists to believe Plinio Roberto De Camargo Jr. committed at least two counts of cruelty to animals pursuant to Florida State Statute 828.12(1). Plinio Roberto De Camargo Jr. intentionally tormented two dogs' in his care by punching and striking the dogs' multiple times, while pulling the dogs hair in a cruel and inhumane manner. I am requesting an arrest warrant through the Palm Beach County State Attorney's Office for the charges against Plinio Roberto De Camargo Jr.
