



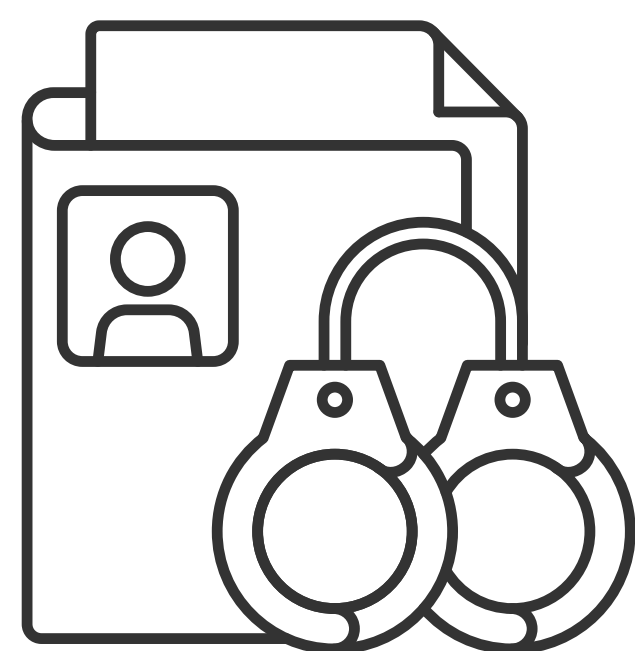

ARRESTS UNDER OPERATION ROUTE 66:

Mr. Boriff was arrested by the BCSO Auto Theft Unit on 05/01/2025 for **Receiving and Transferring Stolen Motor Vehicles**. He was then *Released on Recognizance (ROR)* on 05/02/2025 and was placed on pre-trial services (PML2) and required to check in monthly.

Warrant was issued on 06/03/2025 when Boriff **Failed to Appear (FTA)** in court on 05/30/2025.

On 06/11/2025, Boriff was arrested by the BCSO Auto Theft Unit on the **outstanding warrant**. Subject was released from MDC on 06/16/2025, *removed from pre-trial supervision* and the case was bound over to District Court where subject was again placed on pretrial services (PML2) and required to check in monthly.

Boriff is *currently out of custody* awaiting a pre-trial conference set for 01/9/2026 and current trial date set for 02/02/2026.

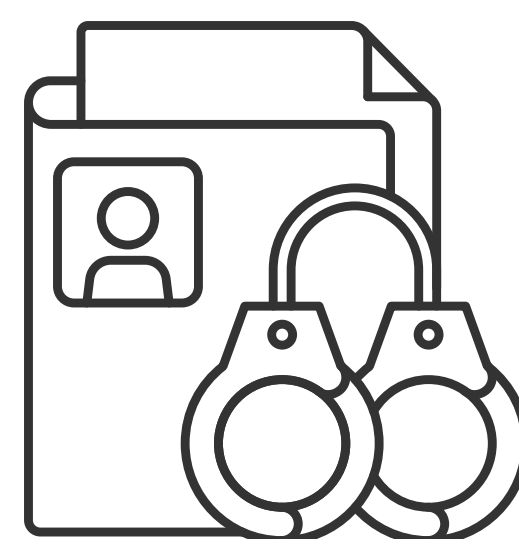

ARRESTS UNDER OPERATION ROUTE 66

Mr. Sena was arrested by the BSCO Auto Theft Unit on 09/24/2024 for **Receipt, Transportation or Possession of a Firearm by a Felon, Trafficking a Controlled Substance (Methamphetamine)** and **Tampering with Evidence**. He was *Released on Recognizance* on 09/25/2024, placed on pre-trial services (PML2), and required to check in monthly.

A warrant was issued on 10/25/2024 when subject *Failed to Appear (FTA)* in court on 10/24/2024 and was arrested by a BCSO Marshal TFO on 02/25/2025 for the **outstanding warrant**. During this arrest, subject as charged with **additional counts of Receipt, Transportation or Possession of a Firearm by a Felon**. Mr. Sena was held until 03/24/2025 while the original case was bound over to District Court.

In the second case, a warrant was issued on 04/07/2025 after Mr. Sena *Failed to Comply (FTC)* with conditions of release. He was arrested on the **outstanding warrant** by BCSO on 04/30/2025 and the case was bound over to District Court.

The two District Court cases were consolidated on 08/26/2025 and on 10/24/2025 subject was sentenced to the DOC for 3 years.

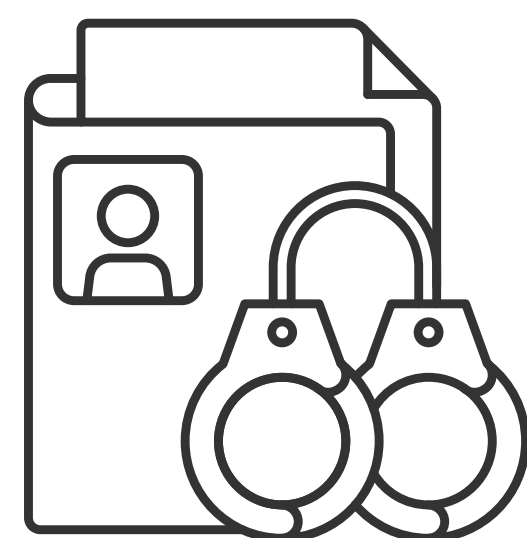

ARRESTS UNDER OPERATION ROUTE 66

Mr. Bradley was arrested by the BCSO Metro Unit on 03/19/2025 for **Possession of a Controlled Substance, Resisting/Evading Law Enforcement, Possession of Drug Paraphernalia, and an outstanding warrant for traffic violations**. He was *Released on Recognizance*, placed on pre-trial services (PML4), and required to check in weekly. Case was bound over to District Court on 04/18/2025.

On 5/20/2025 a **warrant** was issued after subject *Failed to Appear (FTA)* in court. Mr. Bradley was arrested on the **outstanding warrant** by the BCSO Metro unit on 07/16/2025 and charged with **Aggravated Fleeing a Law Enforcement Officer**. He *pled guilty to the PCS charge* on 08/20/2025 and was sentenced to 35 days at MDC, *given credit for time served and released* on 08/21/2025.

On 08/25/2025, he was arrested by APD for **Negligent use of a Deadly Weapon** and *Released on Recognizance* 08/26/2025. A **warrant** was issued on 09/18/2025 when he *Failed to Comply with conditions of release*.

Mr. Bradley was arrested on the **outstanding warrant** on 09/20/2025 by APD and *Released on Recognizance* on 09/22/2025. An **additional warrant** was issued on 10/16/2025 for, again, *Failing to Comply with conditions of release*.

Mr. Bradley was arrested on the **outstanding warrant** by APD on 10/16/2025 and charged with **PCS and Resisting/Evading Law Enforcement**. Subject was *Released on Recognizance* on 10/21/2025. Subject *remains out of custody pending a trial* in a case which is set for 11/19/2025. One case was dismissed by the court "*pending further investigation into the viability of the case.*"

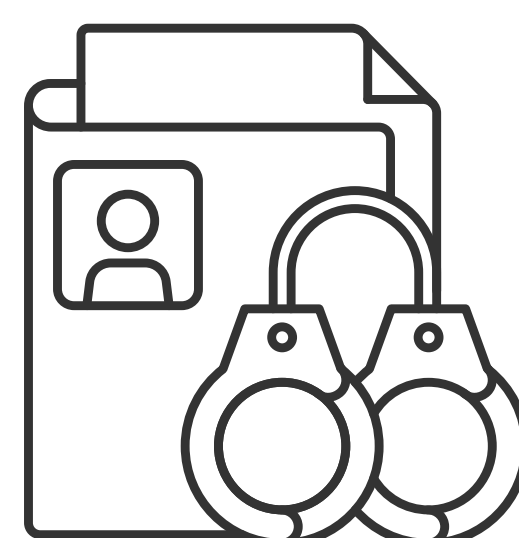

ARRESTS UNDER OPERATION ROUTE 66

On February 24, 2025, the BCSO Metro Unit arrested Roxanne Thompson on new charges of **Possession of a Controlled Substance and Possession of Drug Paraphernalia**. The case was *ultimately nollied for insufficient amount of control substance available for testing* and Thompson was released on February 26, 2025.

On May 13, 2025, the BCSO Metro Unit arrested (summons issued) Ms. Thompson a second time for *additional new charges of Possession of Drug Paraphernalia*.

Ms. Thompson failed to show for court and a **warrant for her arrest** was issued by a Metro Court Judge and Ms. Thompson was arrested on November 12, 2025 by NMSP on her **outstanding warrant**. The case was *ultimately nollied due to the State declining the case at this time* and Thompson was released on November 15, 2025.

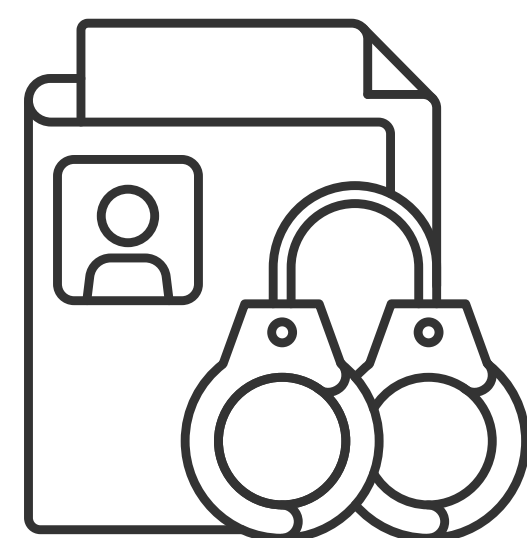

ARRESTS UNDER OPERATION ROUTE 66

On June 1, 2025, the BCSO Auto Theft Unit arrested Jonathan Orozco on new charges of **Unlawful Taking of a Motor Vehicle after stealing a BCSO bait car during** an Auto Theft Operation.

Mr. Orozco was held on a preventative detention due to **additional pending cases (Residential Burglary, Commercial Burglary, Receiving/Transferring a Stolen Motor Vehicle, Felony Criminal Damage to Property, Possession of Burglary tools)**, and was *Released on Recognizance* on August 21, 2025.

On 10/23/2025, the BCSO Auto Theft Unit arrested Mr. Orozco a second time for new charges of **Unlawful Taking of a Motor Vehicle** and an **outstanding warrant**, after **stealing another BCSO bait car** during an Auto Theft Operation.

Orozco was Released on Recognizance (ROR) on October 29, 2025.

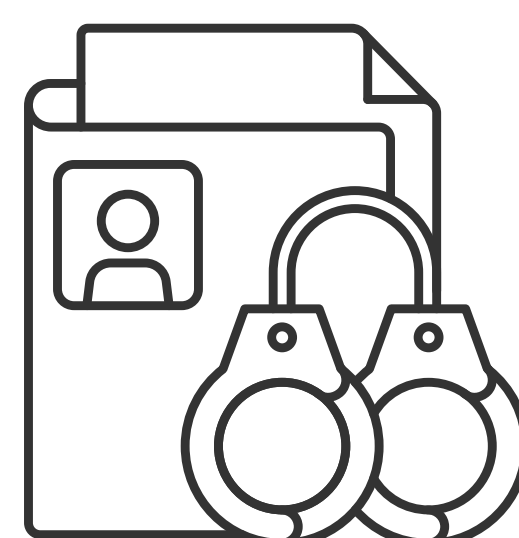

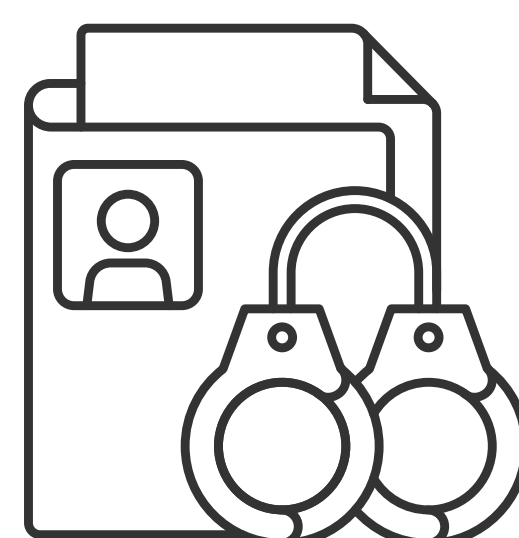

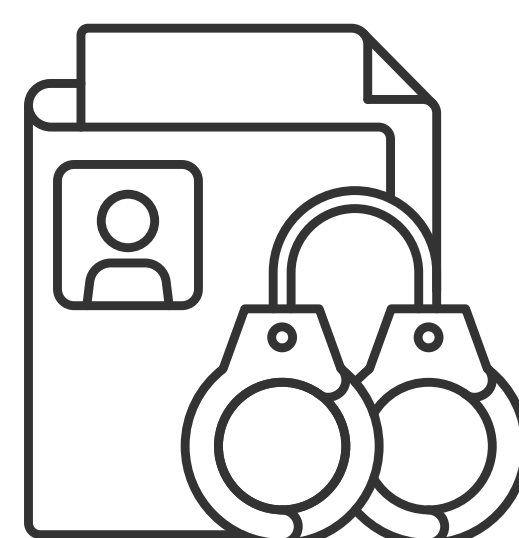

ARRESTS UNDER OPERATION ROUTE 66
