- 1. GENERAL:** No purchase necessary. MAKING A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING. Void where prohibited or restricted by law. The “Blake Shelton Back to the Honky Tonk Tour Tickets Giveaway” (“Sweeps”) is sponsored by WXII 12 and The Greensboro Coliseum (together, “Sponsor”). This Sweeps is subject to all applicable federal, state, and local regulations.

The Promotion Period begins November 28th, 2022 at 5:01p.m. and ends at 11:59 p.m. on December 12th, 2022 (“Promotion Period”). All times are Eastern Daylight Time (EDT).

- 2. PRIZES AND ODDS OF WINNING:** Five (5) Winner will be randomly selected, from all entries received during the Promotion Period. Winners will receive two (2) tickets to “Blake Shelton Back to Honky Tonk ” at the Greensboro Coliseum (“Venue”), 1921 W Gate City Blvd, Greensboro, NC 27403, on Thursday Feb. 23rd, 2023, valued at \$69.00 per ticket. Winner and guests must follow all Venue rules while attending performance, or forfeit prize.

Approximate Retail Value (“ARV”) of Prize: \$138.00

All Prize details will be determined by Sponsors in their sole discretion. In the event the performance is canceled or postponed for any reason, Sponsor shall have no further prize obligation to Winner. Additional restrictions may apply. All taxes and other unspecified expenses, costs, or fees associated with the acceptance and/or use of Prize are the sole responsibility of Winner and their guests. Prize cannot be transferred by Winner or redeemed for cash and is valid only for the items detailed above, with no substitution of Prize by Winner. Winners will be contacted by phone or email by a WXII 12 employee or agent of Sponsor(s). Winner is subject to verification. Upon verification and completion of all prize paperwork (See Section 5 for more information), Winner will receive the tickets electronically.

Odds of winning Prize(s) depend on the number of valid entries submitted during the Promotion Period.

- 3. ELIGIBILITY:** Sweeps is offered only to legal U.S. residents who are 18 years of age or older at the time of entry. Sweeps is offered only to North Carolina residents who reside within the Greensboro-High Point-Winston-Salem Designated Market Area (“DMA”) as determined by Nielsen Media Research Services. Current and former employees of WXII 12, Hearst Television Inc., Hearst Stations Inc., Greensboro Coliseum, Hearst Corporation and current employees of WooBox, and each of their respective parents, subsidiaries, affiliates, franchisees, licenses, directors,

owners, employees and agents, their parent, subsidiary, and affiliated companies, and their advertising or promotional agencies (collectively, the “Sweeps Entities”), and the immediate families or members of the same households of such individuals are not eligible. The term “immediate families” refers to spouses, parents, children, siblings, grandparents, and grandchildren. No groups, clubs, or organizations may participate in this Sweeps or reproduce or distribute any portion of these Rules to their members. Proof of age, identity, and eligibility must be furnished to Sponsors upon request. All entry form information must be complete and accurate. Sponsors will not award a prize to anyone not meeting eligibility requirements at the time of entry. Sponsors reserve the right to disqualify any entrant if these Sweeps Rules are not followed. 4. **HOW TO ENTER:** Viewers may enter by going to www.facebook.com/wxii12news, clicking on the Sweepstakes tab and following the instructions to access, complete, and submit an electronic entry during the entry period. Viewers may also click on the links to the contest on wxii12.com/contests.

In the event of a dispute over the identity of an online entrant, entry will be deemed submitted by the authorized account holder of the email address at time of entry. Sponsors may not verify receipt of entries. Entries become property of Sponsors. Incomplete entries are ineligible. Sponsors are not responsible for entries that are lost, late, misdirected, incomplete, incomprehensible, illegible, damaged, undeliverable or delayed. Entries generated by any automated means and detected as such are void. The authorized account holder is the person to whom the applicable internet service provider or other organization (such as a business or educational institution) has assigned the email address.

Potential winners must respond to notification within twenty-four (24) hours of initial notification, or Prize may be forfeited, and a new winner will be randomly selected by Sponsor. Winner is required to sign and return appropriate electronic forms and/or documentation, including but not limited to an Affidavit of Eligibility, a Liability Release and/or where legally permissible a Publicity Release within three (3) days following the date of first attempted notification. Winner hereby further agrees to sign any documents necessary to transfer copyright of the entry to Sponsor within three (3) days following the date of first attempted notification.
