When you come to the FREE tax location, bring the following:

- A Social Security card for each family member and photo ID for each taxpayer
- Form 1095 A (a health insurance form you may have received in the mail)
- ☑ Form 1099 G Unemployment
- ✓ W-2 forms for all jobs worked in 2022
- All tax forms for other income, if any
- ✓ Letter from child care provider with address, Tax ID number, name of child and amount paid
- All banking account information (voided check and/or savings deposit slip) to direct deposit your refund (up to three separate accounts!)
- ☑ A copy of last year's tax return
- Any document or information about money from the IRS or Maryland
- Any other tax related documents you have received
- Every adult on your return must come to sign
