



Outline of Charged Cases:

Tulare County

- 1 felony count of murder with a sentencing enhancement for personal use of a firearm.
 - **On September 11, 1975**, DeAngelo is accused of murdering Claude Snelling during an attempted kidnapping of the victim's daughter from their Visalia home.

Sacramento County

- 2 felony counts of murder with a sentencing enhancement for personal use of a firearm.
 - **On February 2, 1978**, DeAngelo is accused of murdering Katie Maggoire, 20, and Brian Maggoire, 21, as they walked their dog in their Rancho Cordova neighborhood.
- 9 felony counts of kidnapping to commit robbery with sentencing enhancements for personal use of a firearm and personal use of a knife.
 - **Between September 4, 1976, and October 21, 1977**, DeAngelo is accused of kidnapping and carrying away nine women to commit robbery.

Contra Costa County

- 4 felony counts of kidnapping to commit robbery with sentencing enhancements for personal use of a firearm and personal use of a knife.
 - **Between October 7, 1978, and June 11, 1979**, DeAngelo is accused of kidnapping and carrying away four women to commit robbery.

Santa Barbara County

- 4 felony counts of murder with a sentencing enhancement for personal use of a firearm, and special circumstances allegations for murder committed during the commission of rape and burglary.
 - **On Dec. 30, 1979**, DeAngelo is accused of murdering Robert Offerman, 44, and raping and murdering Debra Manning, 35, of Goleta.
 - **On July 27, 1981**, DeAngelo is accused of murdering Gregory Sanchez, 27, and raping and murdering Cheri Domingo, 35, of Goleta.

Ventura County

- 2 felony counts of murder with special circumstances allegations for murder committed during the commission of rape and robbery.
 - **On or about March 13, 1980**, DeAngelo is accused of murdering Lyman Smith, 43, and raping and murdering Charlene Smith, 33, of Ventura.

Orange County

- 4 felony counts of murder with special circumstances allegations for murder committed during the commission of rape, robbery and burglary.
 - **On August 21, 1980**, DeAngelo is accused of murdering Keith Harrington, 24, and raping and murdering Patrice Harrington, 27, of Dana Point.
 - **On February 6, 1981**, DeAngelo is accused of raping and murdering Manuela Witthuhn, 28, of Irvine.
 - **On May 5, 1986**, DeAngelo is accused of raping and murdering Janelle Cruz, 18, of Irvine.

*As to the first-degree murders that occurred in Sacramento County, Santa Barbara County, Ventura County and Orange County the defendant was also charged with the special circumstances allegation that he committed multiple murders.
