Michael Cashman is a candidate for the public office of Member of New York State Assembly, 115th Assembly District. Mr. Cashman currently serves as Plattsburgh Town Supervisor.

On or about September 2, 2025, Mr. Cashman announced his candidacy for New York State Assembly. Mr. Cashman made this announcement at a campaign event conducted inside the Town of Plattsburgh Town Hall. Mr. Cashman illegally used the government owned Plattsburgh Town Hall for his campaign purposes. It is a violation of state law to use a government owned building to conduct political activities. Further, Mr. Cashman used a podium owned by the Town of Plattsburgh at his political event. Mr. Cashman placed his election banner on said government-owned podium. Mr. Cashman also affixed to the walls of Plattsburgh Town Hall several banners displaying• Michael Cashman for New York State Assembly.• As the current Town Supervisor, Cashman made this political rally indecipherable to voters and taxpayers from a legal government town hall event.

This is a blatant violation of state law and an illegal use of taxpayer funded property for Cashman's personal political endeavors.

There were dozens of witnesses to this violation, including Assemblyman D. Billy Jones and former member Janet Dupree, who both joined Cashman at the campaign rally podium.
