STATE OF OKLAHOMA, COUNTY OF CADDO:

I, Jason M. Hicks, the undersigned District Attorney of said County, in the name and by the authority of the State of Oklahoma, give information that in said County of Caddo and in the State of Oklahoma, **GEORGE FRANKLIN COLE, JR.**, did then and there unlawfully, willfully, knowingly and wrongfully commit the crime(s) of:

- COUNT 1: **CHILD ABUSE, a Class A3 FELONY**, on or about the 1st day of January, 2020 through the 31st day of December, 2025, by willfully/maliciously using unreasonable force R.D., who was under the age of 18 years old, at the time by using zip ties and handcuffs to restrain R.D. in their home overnight.

This crime is punishable by imprisonment in the custody of the Department of Corrections not exceeding life imprisonment, or by imprisonment in a county jail not exceeding one (1) year, or by a fine of not less than Five Hundred Dollars (\$500.00) nor more than Five Thousand Dollars (\$5,000.00) or both such fine and imprisonment.

AFCF x2: This crime is punishable by imprisonment in the custody of the Department of Corrections twenty years to life imprisonment.

- COUNT 2: **CHILD ABUSE, a Class A3 FELONY**, on or about the 1st day of January, 2020 through the 31st day of December, 2025, by willfully/maliciously administering an electrical current with a taser on R.D., who was under the age of 18 years old in Caddo County, Oklahoma.

This crime is punishable by imprisonment in the custody of the Department of Corrections not exceeding life imprisonment, or by imprisonment in a county jail not exceeding one (1) year, or by a fine of not less than Five Hundred Dollars (\$500.00) nor more than Five Thousand Dollars (\$5,000.00) or both such fine and imprisonment.

AFCF x2: This crime is punishable by imprisonment in the custody of the Department of Corrections twenty years to life imprisonment.

COUNT 3: **CHILD ABUSE, a Class A3 FELONY**, on or about the 1st day of January, 2020 through the 31st day of December, 2025, by willfully/maliciously stabbing R.D., who was under the age of 18 years old, with a knife.

This crime is punishable by imprisonment in the custody of the Department of Corrections not exceeding life imprisonment, or by imprisonment in a county jail not exceeding one (1) year, or by a fine of not less than Five Hundred Dollars (\$500.00) nor more than Five Thousand Dollars (\$5,000.00) or both such fine and imprisonment.

AFCF x2: This crime is punishable by imprisonment in the custody of the Department of Corrections twenty years to life imprisonment.

COUNT 4: **CHILD ABUSE, a Class A3 FELONY**, on or about the 1st day of January, 2020 through the 31st day of December, 2025, by willfully/maliciously forcing R.D., who was under the age of 18 years old, to eat Louisiana hot sauce as punishment.

This crime is punishable by imprisonment in the custody of the Department of Corrections not exceeding life imprisonment, or by imprisonment in a county jail not exceeding one (1) year, or by a fine of not less than Five Hundred Dollars (\$500.00) nor more than Five Thousand Dollars (\$5,000.00) or both such fine and imprisonment.

AFCF x2: This crime is punishable by imprisonment in the custody of the Department of Corrections twenty years to life imprisonment.

COUNT 5: **CHILD ABUSE, a Class A3 FELONY**, on or about the 1st day of January, 2020 through the 31st day of December, 2025, by willfully/maliciously slamming R.D.'s head, who was under the age of 18 years old, into a pick up truck.

This crime is punishable by imprisonment in the custody of the Department of Corrections not exceeding life imprisonment, or by imprisonment in a county jail not exceeding one (1) year, or by a fine of not less than Five Hundred Dollars (\$500.00) nor more than Five Thousand Dollars (\$5,000.00) or both such fine and imprisonment.

AFCF x2: This crime is punishable by imprisonment in the custody of the Department of Corrections twenty years to life imprisonment.

COUNT 6: **CHILD ABUSE, a Class A3 FELONY**, on or about the 1st day of January, 2020 through the 31st day of December, 2025, by willfully/maliciously administering an electrical current with a taser on R.D., who was under the age of 18 years old in Chickasha, Oklahoma.

This crime is punishable by imprisonment in the custody of the Department of Corrections not exceeding life imprisonment, or by imprisonment in a county jail not exceeding one (1) year, or by a fine of not less than Five Hundred Dollars (\$500.00) nor more than Five Thousand Dollars (\$5,000.00) or both such fine and imprisonment.

AFCF x2: This crime is punishable by imprisonment in the custody of the Department of Corrections twenty years to life imprisonment.

COUNT 7: **CHILD ABUSE, a Class A3 FELONY**, on or about the 1st day of January, 2020 through the 31st day of December, 2025, by willfully/maliciously striking R.D., who was under the age of 18 years old, with a nightstick.

This crime is punishable by imprisonment in the custody of the Department of Corrections not exceeding life imprisonment, or by imprisonment in a county jail not exceeding one (1) year, or by a fine of not less than Five Hundred Dollars (\$500.00) nor more than Five Thousand Dollars (\$5,000.00) or both such fine and imprisonment.

AFCF x2: This crime is punishable by imprisonment in the custody of the Department of Corrections twenty years to life imprisonment.

COUNT 8: **CHILD ABUSE, a Class A3 FELONY**, on or about the 1st day of January, 2020 through the 31st day of December, 2025, by willfully/maliciously using a cattle probe on R.D., who was under the age of 18 years old, causing R.D. to lose a tooth in Woodward, Oklahoma.

This crime is punishable by imprisonment in the custody of the Department of Corrections not exceeding life imprisonment, or by imprisonment in a county jail not exceeding one (1) year, or by a fine of not less than Five Hundred Dollars (\$500.00) nor more than Five Thousand Dollars (\$5,000.00) or both such fine and imprisonment.

AFCF x2: This crime is punishable by imprisonment in the custody of the Department of

Corrections twenty years to life imprisonment.

COUNT 9: CHILD SEXUAL ABUSE, a Class A3 FELONY, on or about the 1st day of January, 2020 through the 31st day of December, 2025, by willfully/maliciously sexually abusing Z.C., a minor child, who was under the age of 16 years old, with lewd acts by requiring Z.C. to view pornographic videos depicting animals having sex with females.

This crime is punishable by imprisonment in the custody of the Department of Corrections not exceeding life imprisonment, or by imprisonment in a county jail not exceeding one (1) year, or by a fine of not less than Five Hundred Dollars (\$500.00) nor more than Five Thousand Dollars (\$5,000.00) or both such fine and imprisonment.

AFCF x2: This crime is punishable by imprisonment in the custody of the Department of Corrections twenty years to life imprisonment.

COUNT 10: CHILD NEGLECT, a Class B1 FELONY, on or about the 1st day of January, 2020 through the 31st day of December, 2025, by willfully and maliciously neglecting R.D., who was under the age of 18 years old, by not providing an appropriate education

This crime is punishable by imprisonment in the custody of the Department of Corrections not exceeding life imprisonment, or by imprisonment in a county jail not exceeding one (1) year, or by a fine of not less than Five Hundred Dollars (\$500.00) nor more than Five Thousand Dollars (\$5,000.00) or both such fine and imprisonment.

AFCF x2: This crime is punishable by imprisonment in the custody of the Department of Corrections twenty years to life imprisonment.

COUNT 11: CHILD NEGLECT, a Class B1 FELONY, on or about the 1st day of January, 2020 through the 31st day of December, 2025, by willfully and maliciously neglecting Z.C., who was under the age of 18 years old, by not providing an appropriate education.

This crime is punishable by imprisonment in the custody of the Department of Corrections not exceeding life imprisonment, or by imprisonment in a county jail not exceeding one (1) year, or by a fine of not less than Five Hundred Dollars (\$500.00) nor more than Five Thousand Dollars (\$5,000.00) or both such fine and imprisonment.

AFCF x2: This crime is punishable by imprisonment in the custody of the Department of Corrections twenty years to life imprisonment.

COUNT 12: CHILD NEGLECT, a Class B1 FELONY, on or about the 1st day of January, 2020 through the 31st day of December, 2025, by willfully and maliciously neglecting R.D., who was under the age of 18 years old, by failing to provide a lack of supervision.

This crime is punishable by imprisonment in the custody of the Department of Corrections not exceeding life imprisonment, or by imprisonment in a county jail not exceeding one (1) year, or by a fine of not less than Five Hundred Dollars (\$500.00) nor more than Five Thousand Dollars (\$5,000.00) or both such fine and imprisonment.

AFCF x2: This crime is punishable by imprisonment in the custody of the Department of Corrections twenty years to life imprisonment.

COUNT 13: PATTERN OF CRIMINAL OFFENSES, a Class D1 FELONY, on or about the 1st day of January, 2020 through the 31st day of December, 2025, two or more criminal offenses are committed that are a part of the same plan, scheme, or adventure.

This crime is punishable by a fine of up to \$25,000 or imprisonment for up to 5 years of which 20% of the sentence must be served, or both such fine and imprisonment.

AFCF x2: This crime is punishable by imprisonment in the custody of the Department of Corrections four (4) years to life imprisonment.

COUNT 14: CONSPIRACY, a Class C2 FELONY, on or about the 1st day of January, 2020 through the 31st day of December, 2025, by conspiring and agreeing with Kimberly Cole to commit the crime of Child Abuse, a felony, by being a person responsible for a child's health, safety, and welfare willfully and maliciously harmed a child under the age of eighteen, and said defendant and Kimberly Cole did commit child abuse against R.D. in furtherance of the conspiracy.

This crime is punishable by imprisonment for up to 10 years, or a fine of up to \$5,000, or both.

AFCF x2: This crime is punishable by imprisonment in the custody of the Department of Corrections four (4) years to life imprisonment.

Hicks, the undersigned District Attorney of said County, in the name and by the authority of the State of Oklahoma, give information that in said County of Caddo and in the State of Oklahoma, **KIMBERLY KAY COLE ALIAS: KIMBERLY KAY MOORE**, did then and there unlawfully, willfully, knowingly and wrongfully commit the crime(s) of:

COUNT 1: **CHILD ABUSE, a Class A3 FELONY**, on or about the 1st day of January, 2020 through the 31st day of December, 2025, by willfully/maliciously forced R.D., who was under the age of 18 years old at the time, to eat Louisiana hot sauce as punishment.

This crime is punishable by imprisonment in the custody of the Department of Corrections not exceeding life imprisonment, or by imprisonment in a county jail not exceeding one (1) year, or by a fine of not less than Five Hundred Dollars (\$500.00) nor more than Five Thousand Dollars (\$5,000.00) or both such fine and imprisonment.

COUNT 2: **CHILD ABUSE, a Class A3 FELONY**, on or about the 1st day of January, 2020 through the 31st day of December, 2025, by willfully/maliciously using unreasonable force, against Z.C. who was under the age of 18 years old at the time, by placing her hands around Z.C.'s throat choking her.

This crime is punishable by imprisonment in the custody of the Department of Corrections not exceeding life imprisonment, or by imprisonment in a county jail not exceeding one (1) year, or by a fine of not less than Five Hundred Dollars (\$500.00) nor more than Five Thousand Dollars (\$5,000.00) or both such fine and imprisonment.

COUNT 3: **CHILD ABUSE, a Class A3 FELONY**, on or about the 1st day of January, 2020 through the 31st day of December, 2025, by willfully/maliciously using unreasonable force R.D., who was under the age of 18 years old at the time, by using to zip ties and handcuffs to restrain R.D. in their home overnight

This crime is punishable by imprisonment in the custody of the Department of Corrections not exceeding life imprisonment, or by imprisonment in a county jail not exceeding one (1) year, or by a fine of not less than Five Hundred Dollars (\$500.00) nor more than Five Thousand Dollars (\$5,000.00) or both such fine and imprisonment.

COUNT 4: **CHILD SEXUAL ABUSE, a Class A3 FELONY**, on or about the 1st day of January, 2020 through the 31st day of December, 2025, by willfully/maliciously sexually abusing Z.C., a minor child, who was under 16 years old at that time, by exposing Z.C. to sexual acts, specifically the Defendant having sex with a canine.

This crime is punishable by imprisonment in the custody of the Department of Corrections not exceeding life imprisonment, or by imprisonment in a county jail not exceeding one (1) year, or by a fine of not less than Five Hundred Dollars (\$500.00) nor more than Five Thousand Dollars (\$5,000.00) or both such fine and imprisonment.

COUNT 5: **CHILD SEXUAL ABUSE, a Class A3 FELONY**, on or about the 1st day of January, 2020 through the 31st day of December, 2025, by willfully/maliciously sexually abusing Z.C., a minor child, who was under the age of 16 years old at the time, by touching her breasts and looking down her shirt in a lewd and lascivious manner.

This crime is punishable by imprisonment in the custody of the Department of Corrections not exceeding life imprisonment, or by imprisonment in a county jail not exceeding one (1) year, or by a fine of not less than Five Hundred Dollars (\$500.00) nor more than Five Thousand Dollars (\$5,000.00) or both such fine and imprisonment.

COUNT 6: **CHILD NEGLECT, a Class B1 FELONY**, on or about the 1st day of January, 2020 through the 31st day of December, 2025, by willfully and maliciously neglecting R.D., who was under the age of 18 years old at the time, by not providing an appropriate education.

This crime is punishable by imprisonment in the custody of the Department of Corrections not exceeding life imprisonment, or by imprisonment in a county jail not exceeding one (1) year, or by a fine of not less than Five Hundred Dollars (\$500.00) nor more than Five Thousand Dollars (\$5,000.00) or both such fine and imprisonment.

COUNT 7: **CHILD NEGLECT, a Class B1 FELONY**, on or about the 1st day of January, 2020 through the 31st day of December, 2025, by willfully and maliciously neglecting R.D., who was under the age of 18 years old at the time, by lack of proper supervision.

This crime is punishable by imprisonment in the custody of the Department of Corrections not exceeding life imprisonment, or by imprisonment in a county jail not exceeding one (1) year, or by a fine of not less than Five Hundred Dollars (\$500.00) nor more than Five Thousand Dollars (\$5,000.00) or both such fine and imprisonment.

COUNT 8: **CHILD NEGLECT, a Class B1 FELONY**, on or about the 1st day of January, 2020 through the 31st day of December, 2025, by willfully and maliciously neglecting Z.C., who was under the age of 18 years old at the time, by not providing an appropriate education.

This crime is punishable by imprisonment in the custody of the Department of Corrections not exceeding life imprisonment, or by imprisonment in a county jail not exceeding one (1) year, or by a fine of not less than Five Hundred Dollars (\$500.00) nor more than Five Thousand Dollars (\$5,000.00) or both such fine and imprisonment.

COUNT 9: **CONSPIRACY, a Class D1 FELONY**, on or about the 1st day of January, 2020 through the 31st day of December, 2025, by conspiring and agreeing with George Franklin Cole, Jr. to commit the crime of Child Abuse, a felony, as a person responsible for a child's health, safety, or welfare willfully and maliciously harmed a child under the age of 18, and said defendant and George Franklin Cole, Jr. did abuse R.D. in furtherance of the conspiracy.

This crime is punishable by imprisonment for up to 10 years, or a fine of up to \$5,000, or both.

COUNT 10: **CRIME AGAINST NATURE, a Class C2 FELONY**, on or about the 1st day of January, 2020 through the 31st day of December, 2025, by committing the detestable and abominable crime against nature by having unnatural and carnal copulation by committing sexual acts with a canine named Bear.

This crime is punishable by imprisonment for up to 10 years.

COUNT 11: **CRIME AGAINST NATURE, a Class C2 FELONY**, on or about the 1st day of January, 2020 through the 31st day of December, 2025, by committing the detestable and abominable crime against nature by having unnatural and carnal copulation by committing sexual acts with a canine named BB.

This crime is punishable by imprisonment for up to 10 years
