That on December 8, 2025, in the County of Oconee, Defendant Corban Samuel Vander-Ploeg did intentionally, knowingly and unlawfully possess 1504 individual Tetrahydrocannabinol (THC) Dispensers (Vape Pens) containing a 93% concentration of THC, without authority to do so. THC is an isomer analogous to and referenced within 44-53-0370(e)(3)(c). These individual dispensers displays a prominent warning label identifying the contents as a Schedule I Controlled Substance. Each dispenser contains a concentrate of Cannabis Indica, Cannabis Sativa, or a hybrid of both. This incident occurred at 21 Lakeside Circle, Fairplay SC, and was investigated by the OCSO.
