THE BELOW NAMED COMPLAINANT BEING DULY SWORN, ON INFORMATION AND BELIEF STATES THAT:

Count 1: FOURTH DEGREE SEXUAL ASSAULT

The above-named defendant on or about Thursday, January 19, 2023, at 309 North Water Street, in the City of Milwaukee, Milwaukee County, Wisconsin, did have sexual contact with AV1, without consent, contrary to sec. 940.225(3m), 939.51(3)(a) Wis. Stats.

Upon conviction for this offense, a Class A Misdemeanor, the defendant may be fined not more than Ten Thousand Dollars (\$10,000), or imprisoned not more than nine (9) months, or both.

Count 2: DISORDERLY CONDUCT

The above-named defendant on or about Thursday, January 19, 2023, at 309 North Water Street, in the City of Milwaukee, Milwaukee County, Wisconsin, in a public or private place, engages in violent, abusive, indecent, profane, boisterous, unreasonably loud or otherwise disorderly conduct under circumstances in which the conduct tends to cause or provoke a disturbance, contrary to sec. 947.01(1), 939.51(3)(b) Wis. Stats.

Upon conviction for this offense, a Class B Misdemeanor, the defendant may be fined not more than One Thousand Dollars (\$1,000), or imprisoned not more than ninety (90) days, or both.

Probable Cause:

I am a City of Milwaukee Police Officer and base this complaint upon my review of City of Milwaukee Police reports. Said reports state as follows:

On the above date, at the above location, adult victim 1 (herein after AV1) was at a function with other members of the police department. AV1 recognized the defendant from work but didn't personally know him. The defendant was talking to a friend of her and she joined the conversation. The friend walks away and the defendant began making inappropriate comments to AV1. The defendant told AV1 to go dance with his wife and asking if she was coming back to the hotel with them [he and his wife]. Two friends joined the conversation and AV1 began to walk away and the defendant slapped her buttocks. AV1's friends wanted to confront the defendant but AV1 did not want to cause a scene.

AV1 went to the bathroom and saw a woman vomiting. AV1 realized it was the defendant's wife so AV1 went out and told the defendant his wife needed his help. The defendant responded he doesn't care about "that bitch" and asked AV1, "are you coming back to the hotel with us?" AV1 said she had done her part [telling the defendant about his wife vomiting] and walked away from him, returning to her friends.

During a group photo, the defendant jumped into the photo at the last moment and stood behind AV1. The defendant squeezed her buttocks under clothing and then manipulated his hand between her legs and touched her vagina. AV1 turns around, sees the defendant who smiled at her. AV1 then began

crying. AV1 did not consent to the defendant touching her buttock or vagina at anytime that night. AV1 identified the defendant in a photo array. This does not exhaust all the state's information regarding this incident.
