Facts:	

On Sunday, June 1st, 2025 at approximately 0456 hours, Omaha Police Officers assigned to the Uniform Patrol Bureau (UPB) were dispatched to the IHOP restaurant located at 12423 West Center Road in Omaha, Douglas County, Nebraska to respond to a cutting. Upon arrival, UPB Officers located an adult male, later identified as HALL, Michael (black male; DOB: 12-16-200#) suffering CRIM/TRAF DIVISION

from several lacerations consistent with being assaulted with an edged weapon. HALL was transported to CHI Bergan by the Omaha Fire Department where he underwent surgery for his injuries. Officers learned during the preliminary investigation that the suspect, later identified as CUMMINGS, Braylon (black male; DOB: 04-26-2006), was an IHOP employee who remained on scene.

CUMMINGS was transported to OPD Central Headquarters where he was interviewed by Field Investigation Detectives Torey WARREN #2424 and Bryan STRAW #2554. During a post Miranda interview at OPD Central Headquarters, CUMMINGS admitted to stabbing HALL but advised he was acting in self-defense after he witnessed his father being assaulted by an assoicate of HALL's. Interior camera footage was reviewed that showed the entirety of the incident and was inconsistent with CUMMINGS' statement.

A second victim, later identified as VENTURA-MAGANDA, Oswaldo (Hispanic male; DOB: 06-18-2004) self transported to a local hospital with an injury consistent with being assaulted with an edged weapon. The camera footage also showed CUMMINGS knowingly swinging the edged weapon which caused the injury to VENTURA-MAGANDA.

CUMMINGS was transported to DCDC where he was booked for Assault 1st Degree x2.
