ORDER AND NOTICE OF HEARING

Pursuant to A.C.A. §25-15-201, of the Administrative Procedure Act, and A.C.A. §17-95-410 of the Medical Practices Act, the Arkansas State Medical Board issues the following Order and Notice of Hearing charging David Wayne Furr, D.O., with alleged violations of the Medical Practices Act, more specifically:

1. A.C.A. § 17-95-409 (a)(2)(e) that is, violating the laws of the United States and the State of Arkansas regulating the prescribing, possession, distribution and administering of Schedule medication; and
2. A.C.A. § 17-95-409(a)(2)(h) that is, exhibiting a habitual and intemperate or excessive use of habit forming drugs.

The allegations upon which the above charges are based are as follows:

I.

David Wayne Furr, D.O., is a licensed physician in the State of Arkansas under the provisions of the Medical Practices Act.

II.

David Wayne Furr, D.O., is a licensed physician in the State of Oklahoma under the provisions of the Medical Practices Act.

III.

The Arkansas State Medical Board received information from the Director of the Oklahoma Impaired Physicians Program that David Wayne Furr, D.O., was under investigation for illegal drug use.

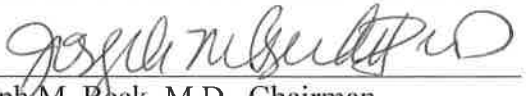
WHEREFORE, it is CONSIDERED, ORDERED, and ADJUDGED by the Arkansas State Medical Board that a hearing should be conducted to determine whether David Wayne Furr, D.O. has violated the Medical Practices Act as alleged hereinabove. If it is found that he has, in fact, violated the Medical Practices Act, then the Board should determine whether the license of David Wayne Furr, D.O. to practice medicine in the State of Arkansas, should be revoked or suspended, or whether other sanctions should be given as punishment pursuant to the authority granted the Board in A.C.A. §17-95-410. Said hearing will be conducted at 9:30 o'clock A m. on the 5 day of December, 2014 at the offices of the Arkansas State Medical Board at 1401 W. Capitol Ave., Suite 340, Little Rock, Arkansas.

David Wayne Furr, D.O. is hereby advised that he may be represented by counsel at the hearing, and that he will be given the opportunity to examine all of the evidence offered to the Board, cross-examine witnesses, and offer evidence and witnesses in his own behalf.

David Wayne Furr, D.O. is further advised that any additional records and/or exhibits that you as a respondent wish to present to the Board at your hearing MUST be supplied to the Board no later than 20 days prior to the hearing date. Failure to do so can result in the Board refusal to allow the information or documentation to be presented by the Respondent.

On this 6th day of August, 2015, comes on for hearing the matter of David Wayne Furr, D.O. The Arkansas State Medical Board appeared together by a quorum of its membership, together with its attorney, Kevin M. O'Dwyer. David Wayne Furr, D.O., appeared together with his attorney, Ron Fields. From the pleadings, testimony of the witnesses and evidence introduced, the Board finds that:

I.

David Wayne Furr, D.O., is licensed to practice medicine in the State of Arkansas pursuant to the provisions of the Medical Practices Act.

II.

The Arkansas State Medical Board issued an Order and Notice of Hearing dated April 23, 2015, alleging that David Wayne Furr, D.O., was under investigation for illegal drug use.

WHEREFORE IT IS CONSIDERED, ORDERED AND ADJUDGED that without admitting to the charges David Wayne Furr, D.O., makes the following offer:

1. David Wayne Furr, D.O., will agree to take courses in Boundaries, Prescribing and Record Keeping at Vanderbilt University within one year of the date of this Order.
2. David Wayne Furr, D.O., will follow all out patient recommendations from his in-patient evaluation.
3. David Wayne Furr, D.O., will sign a contract for monitoring with the Arkansas Medical Foundation, and follow all terms and recommendations of the Foundation;
4. David Wayne Furr, D.O., will not enter into an agreement to supervise a Physician

Assistant, nor will he enter into a collaborative care agreement with a Nurse Practitioner.

5. David Wayne Furr, D.O., will pay the costs of this investigation and hearing of \$1,772.50 within one year of the date of this Order.
6. Failure to comply with this Order including but not limited to the payment of the fine and costs in full within the time frame stated hereinabove, shall be a violation of the Order and be subject to further board action.

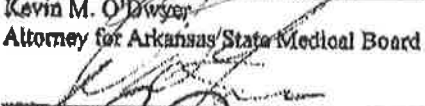

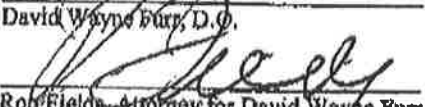

EMERGENCY ORDER OF SUSPENSION AND NOTICE OF HEARING

Pursuant to ACA §25-15-201, and ACA § 25-15-211, both of the Administrative Procedure Act, and ACA § 17-95-410 of the Medical Practices Act, the Arkansas State Medical Board issues the following Emergency Order of Suspension and Notice of Hearing charging David Wayne Furr, D.O., with alleged violations of the Medical Practices Act, more specifically:

1. A.C.A. § 17-95-409 (a)(2)(E) that is, violating the laws of the United States and the State of Arkansas regulating the prescribing, possession, distribution and administering of Schedule medication; and
2. A.C.A. §17-95-409(a)(2)(O) that is, persistent and flagrant overcharging or over treating of patients;

The allegations upon which the above charges are based are as follows:

I.

David Wayne Furr, D.O., is a licensed physician in the State of Arkansas under the provisions of the Medical Practices Act.

II.

David Wayne Furr, D.O., is a licensed physician in the State of Oklahoma under the provisions of the Medical Practices Act.

III.

The owner of Destinations Day Spa in Hot Springs made a statement to the Arkansas State Medical Board accusing David Wayne Furr, D.O., with fraudulent billing, a violation of A.C.A. §17-95-409(a)(2)(O) and Regulation 2.3 of the Board, using expired medication, a

violation of A.C.A. §17-95-409(a)(2)(E) and (O), injecting himself with testosterone, a violation of A.C.A. §17-95-409(a)(2)(H).

IV.

Pursuant to the Administrative Procedure Act, A.C.A. 25-15-211(c) upon an affirmative vote of the majority of the Arkansas State Medical Board, the Board finds that the acts of David Wayne Furr, D.O., described herein above, exhibits a danger to the public and his continued practice of medicine. Therefore, the license to practice medicine in the State of Arkansas of David Wayne Furr, D.O., is suspended on an emergency basis, pending a disciplinary hearing in this matter or further Orders of the Board.

WHEREFORE, IT IS CONSIDERED, ORDERED AND ADJUDGED, by the Arkansas State Medical Board that the license to practice medicine in the State of Arkansas of David Wayne Furr, D.O., is suspended on an emergency basis, pending a disciplinary hearing in this matter or further Orders of the Board.

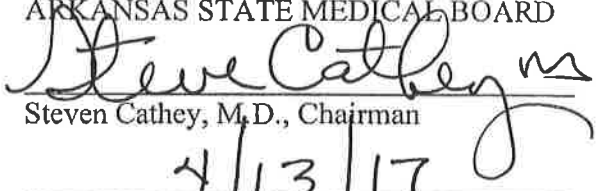

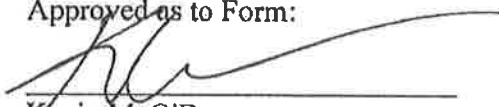
