Description: Under the provisions of §7-213(a), State Finance and Procurement

Article, with the approval of the Board of Public Works, the Governor may reduce, by not more than 25% of the legislative appropriation as approved by the General Assembly for any eight-digit program in the State operating budget in any fiscal year, any

appropriation that the Governor considers unnecessary.

Fund Sources: General Funds

Appropriation Code: See Backup

Requesting Agency Remarks: The Backup to this Item, for BPW approval, is the Governor's list of reductions for fiscal year 2025, by Department and Independent Agency. Consistent with the provisions of §7-213(b) of the State Finance and Procurement Article, no appropriations have been reduced for the payment of the principal and interest on State Debt, public schools mandated funding (including the School for the Deaf and the School for the Blind), or the salary of a public officer during the term of office. No reduction exceeds 25% of the legislative appropriation as approved by the General Assembly for any eight-digit program.

The Backup sets out the total reduction by the eight-digit program and a detailed summary of each reduction, including the name of the program, the amount, the fund source, and a brief description of the impact of the reduction.

Pursuant to §7-213(a) of the State Finance and Procurement Article, notice of the proposed reductions was published on the Department of Budget and Management's website on July 10, 2024.
