The State has been provided video evidence that proves that Garry Owen Langston is not responsible for firing the shot that killed the victim, Charles David Ponthieux.


IT IS, THEREFORE, ORDERED AND ADJUDGED that a Remand to the File be, and the same is hereby entered in this cause.



