


# No Labels Taxes & Spending Study for Chris Pappas, NH1

July 2021



SURVEY METHODOLOGY: This survey was conducted online and by phone within the United States from July 16-21 among 12,673 registered voters in 33 congressional districts (including 350 voters in NH1) within the US. Results were weighted for age by age, gender, party, race, education, and income to align them with their actual proportions in the population for each district. The margin of error for each district is between 4-6 percent.




## **Key Findings**



#### A plurality of voters in NH1 say the country and economy are off on the wrong track; Congressman Pappas is viewed favorably among voters who know him

#### Mood of the District (NH1) – Direction of Country and Economy, Job Approval, and Favorability Ratings









#### There is strong bipartisan support for the Biden-endorsed \$1.2 trillion infrastructure bill



## Voters would prefer an up or down vote on the infrastructure bill without being tied to the larger social spending package





#### Most NH1 voters oppose a \$4.7 trillion package combining infrastructure and social spending



### Voters in NH1 have concerns a \$4.7 trillion plan would increase taxes down the line and create runaway inflation



#### NH1 voters believe a social spending bill should only be passed with bipartisan support



#### Two thirds of NH1 voters say they don't believe services like childcare and elderly care are infrastructure



#### Majorities of voters say Congress should not spend more than \$1 trillion on a new infrastructure bill



#### Voters in NH1 say Congress should not spend more than \$1 trillion on new social spending, including 62% of independents



### A majority of voters in NH1 oppose passing additional spending on social services without significant support from Republicans





## A plurality of voters in NH1 say they would be LESS LIKLEY to support a representative who votes for both the infrastructure and social spending packages





## Democratic messaging that explains the components of the new social spending and that taxes would only fall on the wealthy fails to move the needle



## Voters are likely to REWARD members of Congress who vote AGAINST the combined infrastructure and social spending package even if new taxes only fall on the wealthy









