1. **GENERAL:** No purchase necessary. MAKING A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING. Void where prohibited or restricted by law. This Sweepstakes is subject to all applicable federal, state, and local regulations. The KCCI 28 Days of Christmas Sweepstakes 2025 (“Sweepstakes”) is sponsored by **KCCI** and the Sponsors listed in Section 11 below (“Sponsors”).

The Entry Period runs from 12:01AM on November 28, 2025 to 11:59PM on December 25, 2025 (“Entry Period”), except where noted below in Section 2. All times in these rules refer to Central Standard Time (“CST”).

Sweepstakes is offered only to Iowa residents who reside within the Des Moines-Ames Designated Market Area (“DMA”) as determined by Nielsen Media Research Services.
