

# KCRA, KQCA, Disneyland® Resort "Magic Memories Getaway" Sweepstakes Official Rules

1. **GENERAL:** No purchase necessary. MAKING A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING. Void where prohibited or restricted by law. This Sweepstakes is subject to all applicable federal, state, and local regulations. The "Magic Memories Getaway" Sweepstakes ("Sweepstakes") is sponsored by KCRA 3 and Disneyland Resort Promotions (Together, "Sponsor").

#### 2. PRIZES AND ODDS OF WINNING:

- One (1) Winner will receive: One (1) vacation package to the Disneyland Resort ("Premises") for up to four (4) persons ("Vacation Package") and consisting of the following:
- (i) Up to four (4) round trip coach air fares between the Sacramento (SMF) airport and the Southern California airport as chosen by Disney (with possible layovers); provided, however, if the Winner resides within 250 miles of the Premises, air fare will not be provided to the Winner.
- (ii) A voucher for up to four (4) round trip ground transfers between the Southern California airport and the Premises; provided, however, if the winner resides within 250 miles of the Premises, transfers will not be provided to the Winner.
- (iii) Room accommodations consisting of one (1) standard room (with a maximum of four (4) persons per room) for two (2) consecutive nights at a Premises or Premises area hotel selected by Disney in its sole discretion. (iv) Up to four (4) 3-Day 1-Park Disneyland® Resort Tickets good for admission to Disneyland® Park or Disney California Adventure® Park, but not to both Parks on the same day (subject to restrictions).

Certain restrictions shall apply to the Vacation Package, which restrictions shall be determined by Disney in its sole and absolute discretion. Winner and his/her guests must travel together on the same itinerary. The Vacation Package shall not include the following: airport departure fees; baggage fees; travel insurance; hotel room service; parking fees; laundry service; food; alcoholic beverages; merchandise, souvenirs, etc.; local and long distance telephone calls; tips, gratuities, service charges, resort fees; and any taxes; or all other charges not explicitly included in the packages pursuant to this Agreement. Tickets must be used by March 15, 2020. Vacation Package fulfillment is subject to certain restrictions and is subject to hotel availability at the Disneyland® Resort. Advanced reservations required. Winners must be at least eighteen (18) years of age to enter and win. Travelers under the age of eighteen (18) must be accompanied by a parent/legal guardian who must be at least eighteen (18) years of age. Vacation Package, Vacation Package components and Tickets may not be sold, redeemed for cash, traded, transferred, or rescheduled to dates other than as set forth above. Once booked, the itinerary cannot be changed, or prize will be forfeit. Vacation Package components may not be separated. Certain travel restrictions apply. Sweepstakes is offered only to California residents who reside within the Sacramento-Stockton-Modesto Designated Market Area ("DMA") as determined by Nielsen Media Research Services. Current and former employees of KCRA-TV, KQCA, Hearst Television Inc., Hearst Stations Inc., Disneyland® Resorts (Together "Sponsor") and current employees of Hearst Corporation, Woobox and each of their respective parents, subsidiaries, affiliates, franchisees, licenses, directors, owners, employees and agents, their parent, subsidiary, and affiliated companies, and their advertising or promotional agencies (collectively, the "Sweepstakes Entities"), and the immediate families or members of the same households of such individuals are not eligible. By entering, you agree to comply with all applicable law and these Sweepstakes Rules, and you agree to abide by all decisions of the Sponsor. Internet access is necessary in order to enter. Void where prohibited.

All dates and times are subject to change in the event of human error or technical issues affecting KCRA 3, Sponsor, or entry process, or any other condition that warrants, in KCRA 3's sole discretion, a delay, suspension, revision, or termination of the Sweepstakes.

5. **HOW TO WIN:** One (1) winner will be randomly selected on or soon after March 25, 2019, from all eligible entries and will be contacted by phone or email by an employee or agent of KCRA 3.

Winner must respond to such notification, by calling the Sweepstakes coordinator provided in the notification, within forty-eight (48) hours after the notification is sent by Sponsor, or the Winner will be subject to disqualification, in which case the Prize will be forfeited, and an alternate Winner will be randomly selected from among the remaining eligible entries, time permitting. Winners may be required to sign and return appropriate forms and/or documentation, including an Affidavit of Eligibility, a Liability Release and/or where legally permissible a Publicity Release within thirty (30) days following the date of first attempted Winner hereby further agrees that it will sign any documents notification. necessary to transfer copyright of the entry to Sponsor within thirty (30) days following the date of first attempted notification. Failure to sign and return such forms within the requisite timeframe could result in disqualification.
