25 the crime of FORCIBLE LEWD ACT UPON CHILD in violation of PC288(b)(1), a Felony, was  
26 committed by JOSE GUADALUPE REYES, in that JOSE GUADALUPE REYES did willfully,  
27 unlawfully, and lewdly commit a lewd and lascivious act upon and with the body and certain parts  
28 and members thereof of Jane Doe 1, a child under the age of fourteen years, with the intent of

1 arousing, appealing to, and gratifying the lust, passions, and sexual desires of the said defendant and  
2 the said child, by use of force, violence, duress, menace, and threat of great bodily harm. To Wit:

8 at 15.

18 Guadalupe Reyes.**

19 On or between December 28, 1996 through December 27, 1999, in the County of Monterey,
