COMPLAINT

The People of the State of California upon oath of the undersigned, upon information and belief complain against the defendant above named for the crime(s) as follows:

COUNT ONE

On or about June 11, 2013, or June 12, 2013, at and in the County of Sacramento, State of California, the defendant, MICHAEL ANTHONY MARTIS, did commit a felony, namely: a violation of Section 289(h) of the Penal Code of the State of California, in that said defendant did unlawfully participate in an act of penetration of the genital opening of JANE DOE, under 18 years of age, to wit, 18 years, with a foreign object, substance, instrument, and device and by an unknown object, for the purpose of sexual arousal, gratification, and abuse.

"NOTICE: Conviction of this offense will require you to register pursuant to Penal Code Section 290. Willful failure to register is a crime."

COUNT TWO

For a further and separate cause of action, being a different offense of the same class of crimes and offenses and connected in its commission with the charges set forth in Count One hereof: On or about June 18, 2013, or June 19, 2013, at and in the County of Sacramento, State of California, the defendant, MICHAEL ANTHONY MARTIS, did commit a felony, namely: a <u>violation of Section 261.5(c) of the Penal Code</u> of the State of California, in that said defendant engaged in an act of unlawful sexual intercourse with JANE DOE, age 16 years, not the spouse of the defendant, the minor being more than three years younger than the defendant (first time).

COUNT THREE

For a further and separate cause of action, being a different offense of the same class of crimes and offenses and connected in its commission with the charges set forth in Counts One and Two hereof: On or about August 1, 2013, at and in the County of Sacramento, State of California, the defendant, MICHAEL ANTHONY MARTIS, did commit a felony, namely: aviolation of Section 288a(b)(1) of the Penal Code of the State of California, in that said defendant did unlawfully participate in an act of oral copulation with JANE DOE, to wit, victim orally copulated defendant, a person under the age of eighteen years, to wit, 16 years.

"NOTICE: Conviction of this offense will require the court to order you to submit to a blood test for evidence of antibodies to the probable causative agent of Acquired Immune Deficiency Syndrome (AIDS). Penal Code Section 1202.1."

"NOTICE: Conviction of this offense will require you to register pursuant to Penal Code Section 290. Willful failure to register is a crime."

COUNT FOUR

For a further and separate cause of action, being a different offense of the same class of crimes and offenses and connected in its commission with the charges set forth in Counts One through Three hereof: On or about August 1, 2013, at and in the County of Sacramento, State of California, the defendant, MICHAEL ANTHONY MARTIS, did commit a felony, namely: a violation of Section 288a(b)(1) of the Penal Code of the State of California, in that said defendant did unlawfully participate in an act of oral copulation with JANE DOE, to wit, defendant orally copulated victim, a person under the age of eighteen years, to wit, 16 years.

"NOTICE: Conviction of this offense will require the court to order you to submit to a blood test for evidence of antibodies to the probable causative agent of Acquired Immune Deficiency Syndrome (AIDS). Penal Code Section 1202.1."

"NOTICE: Conviction of this offense will require you to register pursuant to Penal Code Section 290. Willful failure to register is a crime."

COUNT FIVE

For a further and separate cause of action, being a different offense of the same class of crimes and offenses and connected in its commission with the charges set forth in Counts One through Four hereof: On or about and between June 19, 2013, and September 27, 2013, at and in the County of Sacramento, State of California, the defendant, MICHAEL ANTHONY MARTIS, did commit a felony, namely: a violation of Section 261.5(c) of the Penal Code of the State of California, in that said defendant engaged in an act of unlawful sexual intercourse with JANE DOE, age 16 years, not the spouse of the defendant, the minor being more than three years younger than the defendant (different occasion than the first time in Count Two).

COUNT SIX

For a further and separate cause of action, being a different offense of the same class of crimes and offenses and connected in its commission with the charges set forth in Counts One through Five hereof: On or about and between June 19, 2013, and September 27, 2013, at and in the County of Sacramento, State of California, the defendant, MICHAEL ANTHONY MARTIS, did commit a felony, namely: a violation of Section 261.5(c) of the Penal Code of the State of California, in that said defendant engaged in an act of unlawful sexual intercourse with JANE DOE, age 16 years, not the spouse of the defendant, the minor being more than three years younger than the defendant (different occasion than in Counts Two and Five).

COUNT SEVEN

For a further and separate cause of action, being a different offense of the same class of crimes and offenses and connected in its commission with the charges set forth in Counts One through Six hereof: On or about and between September 9, 2006, and September 9, 2007, at and in the County of Sacramento, State of California, the defendant, MICHAEL ANTHONY MARTIS, did commit a felony, namely: a violation of Section 261.5(d) of the Penal Code of the State of California, in that said defendant being over the age of 21 years, did engage in an act of unlawful sexual intercourse with MARY DOE, a person under the age of 16 years, to wit, 15 years.

I declare upon information and belief and under penalty of perjury that the foregoing is true and correct.
