COMPLAINT -- CRIMINAL

SO S25011872

PURSUANT TO CALIFORNIA'S ONE STRIKE LAWS, UNDER PENAL CODE SECTION 667.61, DEFENDANT, ISRAEL MORALES MAY BE SUBJECT TO AN INDETERMINANTE TERM OF LIFE IMPRISONMENT TO BE SERVED IN STATE PRISON.

The undersigned, complains and alleges, upon information and belief, that said defendant(s) did commit the following crime(s) in the County of Stanislaus, State of California.

COUNT I: On or about May 1st, 2025, defendant(s) did commit a felony, ORAL COPULATION BY FORCE, violation of Section 287(c)(2)(A) of the California Penal Code, did willfully, unlawfully and feloniously commit an act of oral copulation upon CONFIDENTIAL VICTIM ONE, and the act was accomplished against the victim's will by means of force, violence, duress, menace, or fear of immediate and unlawful bodily injury on the victim or another person.

<u>NOTICE</u>: Conviction of this offense will require to register pursuant to Penal Code section 290 et seq. Willful failure to register is a crime and could result in future charges.

**<u>MOTICE</u>**: Conviction of this sexual offense will require the court to order you to submit to a blood or oral mucosal transudate saliva test for evidence of antibodies to the probable causative agent of Acquired Immune Deficiency Syndrome (AIDS) pursuant to Penal Code Section 1202.1.

<u>CIRCUMSTANCE IN AGGRAVATION</u>: It is further alleged, pursuant to Rule of Court 4.421(a)(2), defendant **ISRAEL MORALES** was armed with a weapon at the time of the commission of the above crime.

<u>CIRCUMSTANCE IN AGGRAVATION</u>: It is further alleged, pursuant to Rule of Court 4.421(a)(8), the manner in which the crime was carried out indicated planning, sophistication, or professionalism.

<u>CIRCUMSTANCE IN AGGRAVATION</u>: It is further alleged, pursuant to Rule of Court 4.421(a)(11), defendant **ISRAEL MORALES** took advantage of a position of trust or confidence to commit the above offense.

**ENHANCEMENT:** It is further alleged pursuant to Penal Code Section 667.61, that defendant kidnapped the victim of the present offense and the movement of the victim substantially increased the risk of harm to the victim over and above that level of risk necessarily inherent in the underlying offense, within the meaning of 667.61(d)(2).

**ENHANCEMENT:** It is further alleged pursuant to Penal Code Sections 667.61(b) and 667.61(e) that defendant kidnapped the victim of the present offense in violation of Section 207, 209, or 209.5.

**ENHANCEMENT:** It is further alleged, pursuant to Penal Code section 12022.3(b) that the defendant was armed with a firearm, deadly weapon during the commission or attempted commission of the above offense.

COUNT II: On or about May 1st, 2025, defendant(s) did commit a felony, ORAL COPULATION UNDER COLOR OF AUTHORITY, a violation of Section 287(k) of the California Penal Code, in that the defendant(s) did unlawfully commit an act of oral copulation upon CONFIDENTIAL VICTIM ONE against her will by threatening to use the authority of a public official to incarcerate, arrest and deport someone and said CONFIDENTIAL VICTIM ONE had a reasonable belief that the defendant was a public official.

**<u>NOTICE</u>**: Conviction of this offense will require to register pursuant to Penal Code section 290 et seq. Willful failure to register is a crime and could result in future charges.

**NOTICE:** Conviction of this sexual offense will require the court to order you to submit to a blood or oral mucosal transudate saliva test for evidence of antibodies to the probable causative agent of Acquired Immune Deficiency Syndrome (AIDS) pursuant to Penal Code Section 1202.1.

<u>CIRCUMSTANCE IN AGGRAVATION</u>: It is further alleged, pursuant to Rule of Court 4.421(a)(2), defendant **ISRAEL MORALES** was armed with a weapon at the time of the commission of the above crime.

<u>CIRCUMSTANCE IN AGGRAVATION</u>: It is further alleged, pursuant to Rule of Court 4.421(a)(8), the manner in which the crime was carried out indicated planning, sophistication, or professionalism.

<u>COUNT IV</u>: On or about December 16th, 2024, defendant(s) did commit a felony, FALSE IMPRISONMENT, <u>violation of Section 236 of the California Penal Code</u>, in that the defendant(s) did willfully, unlawfully, feloniously violate the personal liberty of **RENE MADRIGAL**, effected by violence, menace, fraud and deceit.

COUNT V: On or about August 28th, 2024, defendant(s) did commit a felony, ORAL COPULATION UNDER COLOR OF AUTHORITY, violation of Section 287(k) of the California Penal Code, in that the defendant(s) did unlawfully commit an act of oral copulation upon CONFIDENTIAL VICTIM TWO against her will by threatening to use the authority of a public official to incarcerate, arrest and deport someone and said CONFIDENTIAL VICTIM TWO had a reasonable belief that the defendant was a public official.

<u>CIRCUMSTANCE IN AGGRAVATION</u>: It is further alleged, pursuant to Rule of Court 4.421(a)(8), the manner in which the crime was carried out indicated planning, sophistication, or professionalism.

<u>CIRCUMSTANCE IN AGGRAVATION</u>: It is further alleged, pursuant to Rule of Court 4.421(a)(11), defendant **ISRAEL MORALES** took advantage of a position of trust or confidence to commit the above offense.

COUNT VI: On or about June 18th, 2024, defendant(s) did commit a misdemeanor, SOLICITATION OF PROSTITUTION, violation of 647(b)(1) of the California Penal Code, in that the defendant(s) did willfully and unlawfully solicit another to engage in an act of prostitution with the intent to receive compensation, money, or anything of value from another person.

COUNT VII: On or about June 7th, 2024, defendant(s) did commit a misdemeanor, SOLICITATION OF PROSTITUTION, violation of 647(b)(1) of the California Penal Code, in that the defendant(s) did willfully and unlawfully solicit another to engage in an act of prostitution with the intent to receive compensation, money, or anything of value from another person.

<u>MOTICE</u>: It is further alleged, pursuant to Penal Code Section 1170(h)(3) and 1170(f) that the defendant **ISRAEL MORALES**, is not eligible to be sentenced to a term of imprisonment in the county jail on an executed sentence. This allegation is not subject to dismissal pursuant to Penal Code Section 1385.
