

# BUTLER COUNTY NOTICE OF DATA SECURITY INCIDENT February 21, 2024

Butler County (the "County") recently determined there had been unauthorized access and acquisition to data stored on the County's computer network. We take this matter very seriously because of our commitment to the privacy and security of all information. Beginning on February 21, 2024, we mailed notification to individuals whose personal information was impacted by this incident. Unfortunately, we did not have sufficient contact information to provide notice to some individuals. We are posting this notice on our website and providing a toll-free telephone number, 833-918-1254, which can be called Monday through Friday, 9 AM to 9 PM EST (excluding major U.S. holidays), to notify those individuals for whom we do not have sufficient contact information. Please be prepared to provide the following Engagement Number: B116747.

## What Happened

On October 2, 2023, federal law enforcement alerted us to suspicious activity involving the County network. We immediately began working with a nationally recognized digital forensics team to secure our network and investigate the scope of the incident. On October 30, 2023, as part of the ongoing investigation, we determined that there was unauthorized access to, and acquisition of personally identifiable information maintained on the County's network. Once we learned this, we began a thorough review of the contents of the identified data to establish what information may have been involved, who may have been affected, and where those people reside so that we can provide notice. On January 22, 2024, we completed the review and began locating mailing addresses for individuals whose information may have been impacted, so that we could provide them with written notice of this incident.

#### What Information Was Involved

Based upon our investigation, the affected data included the following: name, Social Security number, driver's license number, state identification number, individual taxpayer identification number, passport number, medical condition or treatment information, financial account or payment card information, and individual health insurance policy number.

#### What We Are Doing About It

As soon as we learned about this incident, we immediately worked with our team to secure our network and begin an investigation. We notified the Butler County District Attorney and continue to cooperate with federal law enforcement's investigation. To further enhance our security and to help prevent similar occurrences in the future, we have taken or will be taking the following steps:

- 1. Deployed security tools to enhance detection and accelerate response to cyber incidents;
- 2. Actively monitoring our network using end point detection tools to help ensure containment;
- 3. Conducted enterprise-wide password reset; and
- 4. Strengthening network security.

## What You Can Do

We recommend that you take the following preventative measures to help protect your information:

- 1. For those whose Social Security number, driver's license number and/or state identification card number were impacted, enroll in a complimentary, credit monitoring membership with Experian. This membership will provide you with identity monitoring services, including a copy of your credit report at signup; credit monitoring; identity restoration; Experian IdentityWorks ExtendCARE; and up to \$1 million in identity theft insurance.
- 2. Remain vigilant for incidents of fraud and identity theft by regularly reviewing your account statements, free credit reports, and any health insurance Explanation of Benefits (EOB) forms for unauthorized or suspicious activity. Information on additional ways to protect your information, including how to obtain a free credit report and free security freeze, can be found at the end of this letter.
- 3. Report any incidents of suspected identity theft to your local law enforcement, state Attorney General and the major credit bureaus.

# **Obtain Your Credit Report**

You should also monitor your credit reports. You may periodically obtain your credit reports from each of the national consumer reporting agencies. In addition, under federal law, you are entitled to one free copy of your credit report every 12 months from each of the three nationwide consumer reporting agencies listed above. You may obtain a free copy of your credit report by going to <a href="www.AnnualCreditReport.com">www.AnnualCreditReport.com</a> or by calling (877) 322-8228. You also may complete the Annual Credit Report Request Form available from the FTC at <a href="https://www.consumer.ftc.gov/sites/www.consumer.ftc.gov/files/articles/pdf/pdf-0093-annual-report-request-form.pdf">https://www.consumer.ftc.gov/sites/www.consumer.ftc.gov/files/articles/pdf/pdf-0093-annual-report-request-form.pdf</a> and mail it to Annual Credit Report Request Service, P.O. Box 105281, Atlanta, GA 30348-5281. You may also contact any of the three major consumer reporting agencies to request a copy of your credit report. You may be able to obtain one or more (depending on the state) additional copies of your credit report, free of charge. You must contact each of the credit reporting agencies directly.

If you discover inaccurate information or a fraudulent transaction on your credit report, you have the right to request that the consumer reporting agency delete that information from your credit report file.

## **Fraud Alerts**

You may want to consider placing a fraud alert on your credit report. An initial fraud alert is free and will stay on your credit file for one year. The alert informs creditors of possible fraudulent activity within your report and requests that the creditor contact you prior to establishing any new accounts in your name. To place a fraud alert on your credit report, contact any of the three national credit reporting agencies using the contact information listed above. As soon as one credit bureau confirms the fraud alert, they will notify the others. ### **Security Freeze**

You have the ability to place a security freeze on your credit report at no cost to you. A security freeze is intended to prevent credit, loans and services from being approved in your name without your consent. To place a security freeze on your credit report, you may be able to use an online process, an automated telephone line, or a written request to <u>all three</u> of the credit reporting agencies listed above. The following information must be included when requesting a security freeze (note that if you are requesting a credit report for your spouse, this information must be provided for him/her as well): (1) full name, with middle initial and any suffixes; (2) Social Security number; (3) date of birth; (4) current address and any previous addresses for the past five years; (5) a legible copy of a government-issued identification card, (6) proof of current address, such as a legible copy of a recent utility bill or bank or insurance statement, (7) a legible copy of a recent W-2, pay stub, or Social Security card, and (8) if you are a victim of identity theft, a copy of either the police report, investigative report, or complaint to a law enforcement agency concerning identity theft. It is essential that each copy be legible, display your name and current mailing address, and the date of issue. **Under federal law, you cannot be charged to place, lift, or remove a security freeze.** 

After receiving your freeze request, each credit reporting company will send you a confirmation letter containing a unique PIN (personal identification number) or password. Keep the PIN or password in a safe place, you will need it if you choose to lift the freeze.

### **Additional Helpful Information**

Even if you do not find any suspicious activity on your initial credit reports, the Federal Trade Commission (FTC) recommends that you check your credit reports periodically. Checking your credit report periodically can help you spot problems and address them quickly.

If you find suspicious activity on your credit reports or have reason to believe your information is being misused, call your local law enforcement agency and file a police report. Be sure to obtain a copy of the police report, as many creditors will want the information it contains to absolve you of the fraudulent debts. You may also file a complaint with the FTC by contacting them at the information provided above. This notice was not delayed as a result of a law enforcement investigation.

If your personal information has been used to file a false tax return, to open an account or to attempt to open an account in your name, or to commit fraud or other crimes against you, you may file a police report in the city in which you currently reside.
