Executive Summary

AMED proposes to provide exclusive emergency and non-emergency ambulance services for Blount County in full compliance with the October 2025 Invitation to Bid. Our base offering (Option 1) is three (3) Advanced Life Support (ALS) ambulances dedicated to 911 response on a 24/72 schedule, each staffed by a Paramedic and an EMT/AEMT. Option 2 adds a dedicated non-emergency hospital transport/discharge ambulance stationed at UAB Blount to clear beds faster and prevent impact to 911 readiness. Blount 9-1-1 will dispatch all emergency calls at no cost to AMED. This proposal is cost-recovery focused: the County's subsidy is limited to the difference between actual collections and fully burdened operating costs for the agreed coverage level(s).

Proposal Options (Two Options Allowed by RFP)

Option 1: Provide three (4) dedicated ALS ambulances operating 24/72 shifts, each staffed with one Paramedic and one EMT/AEMT.

Option 2: Provide the same three (4) ALS ambulances as in Option 1, PLUS one (1) dedicated non-emergency hospital transport/discharge ambulance stationed at UAB Blount Hospital, supported by a \$150,000 annual subsidy for guaranteed availability without burdening 911 resources.

Staffing & Operations Plan

- Shift model: 24/72 for all ALS units (consistent staffing, rest, retention).
- · Crew per ALS unit. 2 licensed employees

- Total field FTEs: 18 across three ALS units; supervisors provide coverage and surge.
- Training: Initial orientation, annual competencies, targeted QA/QI refreshers (TCC, Stroke, Cardiac Arrest).
- Uniforms/Badges: Company-issued ID with license level visible.
- Office & Supplies: AMED will maintain a Blount County office for records/supplies.

Response Time & Deployment Plan

AMED will meet the Tiered Response Model and response-time expectations:

- Tier 1 (life-threatening): Prioritize ACLS ambulance; 20-minute response at ≥80% fractile averaged over 30-day periods.
- Tier 2 (non-critical/transport): Prioritize AEMT/BLS units; bedside within 45 minutes if resources allow.
- Deployment: AVL-directed closest-unit response; supervisor surge plan; recall protocol for system overload or MCIs.
- Zero-status mitigation: escalate mutual aid per RFP, short-haul to closest appropriate facility if county enters zero-status.

Dispatch & Technology Integration

Blount County 9-1-1 retains full responsibility for emergency call-taking. Blount calls AMED to dispatch service. AMED selects Dispatch Option A. There are no dispatch or CAD costs to AMED. AMED will:

- Equip units with radios compatible with Blount 9-1-1 Fire/EMS channel and provide AVL/Mobile Data.
- Ensure all calls are entered into CAD and notify Blount 9-1-1 on any direct non-911 requests.
- Coordinate unit numbers and statuses in real time with Blount 9-1-1.

Hospital & Non Emergent Operations (Option 2)

- Dedicated hospital discharge/transport unit positioned at UAB Blount.
- Does not interfere with 911 ALS coverage; protects emergency readiness.
- \bullet Recognizes that only \sim 50% of discharge patients are billable; County subsidy guarantees availability.
- AMED continues billing where appropriate; County financial exposure limited to the fixed \$150,000 subsidy.



ZERO SUBSIDY MODEL AS REQUESTED IN UPDATED RFP

While it is Lifeguard's position that three and a half ambulances are not enough to adequately serve the citizens and guests of Blount County, we have included below a zero subsidy model for your review.

Updated System Delivery Model



(ii) Given Blount County's extensive area—which includes portions of St. Clair County—there are significant challenges in providing adequate coverage. The available data provided to our analytics department also show that response time compliance is doubtful under this deployment model. **Option 1:** SFEMS requests a subsidy from Blount County of \$116,000.00 a month. Provide 4 24/7 ALS Trucks. Terms of 1 year, with 90 day out. Allowing time for Blount to determine the EMS model they prefer. We request an additional dialogue for additional services that may be rendered.

Option 2: SFEMS requests a subsidy from Blount County of \$116,000.00 a month. Provide 4/24/7 ALS trucks. Terms two years. We request an additional dialogue additional services that may be rendered. There will be a 3% subsidy increase in the second year of the contract, and each year thereafter .These rates are quoted as a result of having no financial data available at the time of bidding and are negotiable.

Option 3: SFEMS requests a subsidy of \$145,300.00 a month. Term of two years, with 3% increase in year 2.

Survival Flight EMS understands and agrees that except option 1 will be for 2 two years and and may be renewed at the sole discretion of the County for up to 2(two) years upon written agreement of both parties. SFEMS agrees that either party may cancel the contract with a 90 day notice.

Emergency Dispatch Services:

Under both proposals we present we respectfully request Option A. for dispatch as outlined in the RFP.

Ambulance Base Locations:

We intend to utilize the current EMS building in Oneonta at 375 Valley Road as the headquarters. We will also work with the current land owners in Cleveland and Warrior to base units there. We will evaluate these location and high volume areas for possible realignment after an appropriate amount of time.
