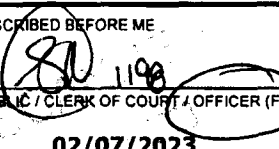
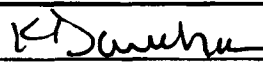

In the state of Florida, the injection of Botox and Fillers is considered the practice of medicine. Thus, a Physician may inject, as well as an Advanced Practice Registered Nurse (Nurse Practitioner) and a Physician Assistant under protocols written and reviewed by a supervising Physician in accordance with Florida Law. OFFICERS OF THE CORPORATION: Dr. Charles Edward Flack- holds the medical license for the practice Donna Feinberg Shuman - President and Owner of Aqua Laser Studio Jonathan Feinberg- Owner of Aqua Laser Studio The Department of Health received a tip from a former employee, Jennifer Tamules, in regards to employee "JLO" who is identified as Johnathan Michael Lopez-Oramas, 09-29-77, who was conducting Platelet Rich Plasma (PRP) injections, Neuromodulator injections (Botox, Dysport and Xeomin) and Hyaluronic Acid Dermal Fillers without a medical license. DOH Agent Luis Inoa and I conducted a sworn taped interview with Jennifer Tamules. Jennifer Tamules advised back in July of 2022 she was working for Harbor Ridge Country Club in Martin County and would coordinate the Aqua Laser Spa to come to the country club for services. Jennifer Tamules' main point of contact for Aqua Laser Studio was the owner/President, Donna Feinberg Shuman. Donna Feinberg Shuman eventually offered Jennifer Tamules a job at Feinberg's Aqua Laser studio located at 775 W. Indiantown Rd., Suite 5, Jupiter, Florida to be her office manager.

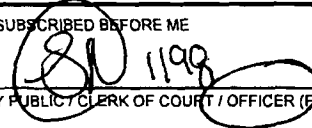
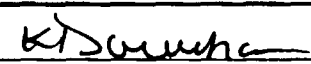

Jennifer Tamules worked at the Aqua Laser Studio from July 2022 to August 2022. Jennifer Tamules advised on two occasions, Lopez-Oramas, known as J-Lo, injected her with a Neuromodulator injection known as Xeomin. During her first session in July, Jennifer Tamules received 70 units of Xeomin from Lopez-Oramas. At her second session, on August 10, 2022, she received less injections as it was a touch up procedure. Jennifer Tamules advised that the owner of the studio, Donna Feinberg Shuman, was present in the office, acting as a medical assistant, during her first injection. Jennifer Tamules said that Lopez-Oramas started working at the business a week after Jennifer did. Jennifer advised that he was brought into the business specifically to do all of the injections as no one else in the business did them. Jennifer Tamules said during her course of working there for 2 months, she personally witnessed Lopez-Oramas conduct at least 50 injections into patients, as she would help Johnathan get the patients ready and be the female assistant in the room. Jennifer Tamules said she never met the doctor, Dr. Charles Edward Flack, who the business licensing is under and she never saw him at the business. Jennifer Tamules said that there were 2 RN's that worked at the business; however, they only worked as an on-call capacity and only came into the office once or twice a month. Jennifer Tamules also noted that in the hallway behind the check-in counter, there is a plastic locked cabinet on the wall containing everyone's licenses and there is not one for Johnathan Michael Lopez-Oramas. Jennifer Tamules advised in the back office of the business there is a small refrigerator that contains the Botox and Lip fillers. Located on top of the refrigerator is a hand-written log that is signed by Johnathan Michael Lopez-Oramas every time he uses a product. According to the Department of Health, Lopez-Oramas does not have a license to perform these injections, nor is he an RN, physician's assistant or doctor. After checking the Google reviews, there are numerous reviews stating the "JLO" administered Botox to patients and did an excellent job. According to Jennifer Tamules, all of the patient files are computerized and the business uses the online portal of "Patient Now". Jennifer Tamules advised her friend, Kayla Berger, also visited Aqua Laser Studio and received Botox treatments from Lopez-Oramas. A sworn recorded statement was taken from Kayla Berger and she confirmed on 2 occasions Lopez-Oramas administered injections to

her face, forehead, eye and nose area, where she received 60 units of Botox. On one occasion, Berger advised that Donna Feinberg Shuman was present in the room for her injections.

Jennifer Tamules said that the Founder/Owner, Donna Feinberg Shuman, works at the business full time and does laser treatments. Donna Feinberg Shuman's son, Jonathan Feinberg, is also listed as an owner of the business on their website www.Aqualaserstudio.com. Jennifer Tamules said Jonathan is at the business in a full-time capacity and runs the office staff, finances and marketing.

On February 3, 2023, an undercover agent with the Department of Health called Aqua Laser Studio and confirmed that "JLo" was doing Botox treatments at the facility. The UC made an appointment for February 7, 2023 at 4:00pm to receive Botox injections. During the undercover operation, the DOH agent posed as a patient and was accompanied by an undercover Jupiter Police Detective. After entering the establishment and filling out patient paperwork, they were shown to an exam room where they met with Johnathan Lopez-Oramas. Lopez-Oramas conducted a consultation with the undercover and started to prep the skin for injections. Lopez-Oramas wiped off her face of makeup, supplied her with ice for the injection sites and prepped the syringe. At this point, the code phase was given and Jupiter Police Officers entered the business and rescued the undercover agents and Lopez-Oramas was handcuffed and detained.

I informed the staff in reference to the search warrant. The staff advised Donna Feinberg Shuman was not present; however, Donna Feinberg Shuman returned to the business and was also placed into custody.

During a post Miranda interview with Lopez-Oramas, he admitted that he has worked for the business since August 2022 and was hired by Donna Feinberg Shuman to conduct Botox and Lip filler injections. Lopez-Oramas advised that Donna Feinberg Shuman knew he did not have a license and she referenced another local spa that also did the same thing. It should be noted that Lopez-Oramas admitted to giving injections to numerous members of the staff as well. Lopez-Oramas also said he has never seen or met Dr. Charles Flack.

Finally, I spoke with Donna Feinberg Shuman. I provided her a copy of the search warrant. I informed her of her charges, which were operating a medical facility without a license. I explained to her that she hired Lopez-Oramas and he did not possession any licenses at all. She looked at me and asked "he doesn't have a license?" I told her she was the owner of the business and it was her responsibility to know these things. I also pointed out that she has a locked clear cabinet displaying everyone's license and Lopez-Oramas is not in there. Her response was she wasn't in charge of that cabinet.

I find probable cause to charge Johnathan Oramas-Lopez with 5 counts of Practicing

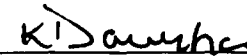
