On Wednesday, February 14, 2024, at approximately at 2:36 p.m. Palm Beach Gardens Police Officer Zimandy was on foot patrol inside the [REDACTED] when he heard multiple gun shots. Officer Zimandy was inside Nordstrom lower level when the shots were fired. Zimandy heard what he believed to be five (5) gun shots come from inside the mall. Officer Zimandy followed the sound of the gunshots to the area of the escalator near [REDACTED] which was located near the Travis Mathew store on the interior of the [REDACTED]. Upon Officer Zimandy's arrival he was unable to locate any potential suspects or victims. A concerned citizen stated she saw a black male run towards entry/exit 5 which is the entry/exit between [REDACTED] [REDACTED] Security assisted investigators with obtaining the [REDACTED] internal surveillance footage, which captured the shooting, along with still photographs of the vehicles that the involved individuals arrived at the mall. In the video, law enforcement was able to observe two black males, one (suspect) wearing a purple sweatshirt with a blue logo on the front, a purple beanie hat with blue on the tip area of the beanie, ripped blue jeans, and distinct blueish purple high top basketball style shoes, and the second (witness/involved other) was wearing a green sweatshirt, going down the escalator to the first floor at the west end of the mall. The two males were quickly followed down the escalator by another black male (victim of gunshot) wearing a black shirt and black shorts. The male that was following appeared to be walking in an aggressive manner with his right hand inside his waistband as if he was retrieving or holding a weapon. The suspect with the purple sweatshirt turned around to see the male coming in his direction and getting within approximately 5 feet away from him. The suspect with the purple shirt then reacted by pulling out a firearm and discharging five shots toward the male in the black shirt that was following him. All males fled on foot from the area. Surveillance videos were able to track all individuals departing the mall on foot. Law enforcement was able to follow a blood trail through

the [REDACTED] in the path that the male in the black shirt ran. Law enforcement later was informed the male in the black shirt was at St Mary's with a gunshot wound from this shooting. He sustained a superficial wound to his right wrist from a bullet grazing his arm. I Detective Adorno (ID 420) visited the St Mary's hospital to make contact with the gunshot victim. The male was positively identified as Kemarcio Mitchell DOB:02/27/1995 from his Florida Department of Highway Safety and Motor Vehicle (DHSMV) Driver and Vehicle Information Database (DAVID) profile. Mitchell's sworn statement was obtained using my agency issued body worn camera. The footage was later uploaded to Evidence.com. His statement was as follows: I started by asking him if he was ok and he stated that he had just been grazed by a bullet. Since he appeared to be a victim of a shooting, I asked him where he was when the shooting occurred. He stated that he was at The [REDACTED] He went on to explain that he arrived that the mall with two other black males and a child, and that he only knew one of them as "Scooter". He did not know the name of the other black male or the child. He said that he was there to help his friend buy a Valentines Day gift for his girlfriend. He said that he remembered going to the Gucci store and the Tommy Bahama store. When he exited the Tommy Bahama store, he said that he went to the escalator located on the west side of the mall and proceeded to head down towards the first floor. This is when he heard multiple gunshots and realized he had been shot. He then left running toward the center of the mall before exiting the mall from one of the stores. He could not remember what store he exited from. He then said that as he was exiting the mall, he called his girlfriend Jessica Morris DOB:03/07/1993 to come pick him up from the mall. He said that he walked towards PGA Blvd (the road directly in front of the mall) and that Morris picked him up from the road. He stated that he did not see the person who shot him, and he did not know who would want to hurt him. While I continued to ask details about the shooting, he became uncooperative and did not provide any further information about the shooting. He consented to provide a DNA Sample and signed a consent form. A West Palm Beach Police CSI Technician obtained the DNA Samples from Mitchell and later transferred them over to me via chain of custody. The samples were later entered into evidence at the Palm Beach Gardens Police Department. On Thursday, February 15, 2024, detectives were informed by a law enforcement officer (Palm Beach County Sheriff's Office) Agent Corey Oliver that he recognized a subject listed in a Palm Beach Gardens Police Department bulletin as Devon Jamal Graham. Agent Oliver told Detectives that the bulletin which depicted a photo of the suspect wearing

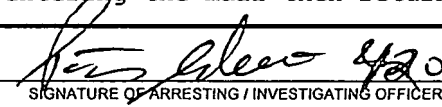
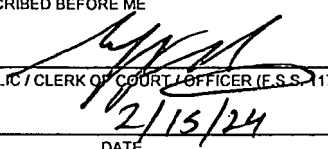

the purple sweatshirt was Graham. Agent Oliver described the circumstances surrounding his past interactions with the suspect shown in the surveillance footage stating that he became familiar with Graham thought prior investigations as he had been listed in other cases. On Thursday, February 15, 2024, detectives were informed by a second law enforcement officer (Palm Beach County Sheriff's Office) Agent Chad Booth that he recognized a subject listed in a Palm Beach Gardens Police Department bulletin as Devon Jamal Graham. Agent Booth told Detectives that the bulletin which depicted a photo of the suspect wearing the purple sweatshirt was Graham. Agent Booth described the circumstances surrounding his past interactions with the suspect shown in the surveillance footage stating that he became familiar with Graham thought prior investigations as he had been listed in other cases. It should be noted that Agent Booth and Agent Oliver were not together when they spoke to Palm Beach Gardens Police Detectives, and both independently identified Graham. Both Detectives stated they have been familiar with Graham based on prior investigations dating back to 2017. Both interactions with Agent Oliver and Booth were recorded using an agency issued body worn camera. The footage was later uploaded to Evidence.com During law enforcement's investigation it was learned that Graham is a convicted felon. Devon Jamal Graham has 30 felony arrests and has been adjudicated guilty for felony charges seven (7) times. Detectives are aware that Graham resides at 1620 W 13TH ST Riviera Beach, Florida 33404. Detectives know this from Agent Oliver and Booth who stated they have seen Graham at this residence in the past. Detectives also know that Graham is on active probation in the State of Florida for Possession of a firearm by a convicted felon. Detective Jordan Leskow (ID 429) spoke to Graham's Probation Officer who told him that Graham lives at 1620 W 13TH ST Riviera Beach, Florida 33404. Graham's Probation Officer last checked Graham's residence on February 13, 2024. Graham has the address of 1620 W 13TH ST Riviera Beach, Florida 33404 listed on Florida Department of Highway Safety and Motor Vehicle (DHSMV) Driver and Vehicle Information Database (DAVID) which shows that this address is registered on his Florida Driver's License. Further surveillance footage obtained from The Gardens Mall Security showed that Devon Graham and the unknown black male with the green sweater arrived at the mall in 2022 Black Nissan Maxima bearing Floride temporary license plate of DNM5304. The footage shows Graham exiting the vehicle from the driver's side. The footage also shows Graham and the unknown black male in the green sweater entering the mall then returning back to

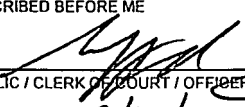

the vehicle for several minutes. They are then seen returning back to the interior of the mall. It should be noted that after the shooting, Devon Graham and the unknown male in the green sweater left the mall on foot and did not return to the vehicle. The vehicle was later towed to the Palm Beach Gardens Police Department for processing. While processing the passenger compartment of the vehicle, two firearms and a large quantity of drugs were found. A credit card with Devon Graham's name was also found inside the vehicle. One of the firearms was an AK-47 model Draco 7.62 chambered in 7.62x39mm bearing serial number DF-7197-20-ROA. The second firearm was a Glock Model 26 chambered in 9mm bearing serial number BDWG532. It should be noted that when processing the vehicle, the front driver's side seat was found reclined far back. The AK47 was located on the rear passenger floorboard which would have been easily seen and within immediate reach of Devon Graham while seated in the driver seat of the vehicle. Due to the identification of Devon Graham (shooter) made by Agents Oliver and Booth along with the address provided by the probation officer, A search warrant was drafted for the residence at 1620 W 13TH ST Riviera Beach, Florida 33404. The warrant was then granted and signed by a Palm Beach County Judge. The warrant was served on the residence on 02/15/2024. Multiple firearms were found at the residence as well as a credit card and birth certificate belonging to Devon Graham. Present at the residence was Debra Bell DOB:01/28/1968 (homeowner and mother of Devon) and Albert Graham DOB:06/10/1988 (brother to Devon). Due to the above facts, and identification made by Agents Oliver and Booth, I find probable cause to charge Devon Jamal Graham DOB: 03/11/1995 with Possession of firearms or Ammunition by a convicted felon Per F.S.S 790.23 (1) (A) for the firearms recovered from the vehicle Devon Graham was driving and left at the Gardens Mall. A warrant request will be forwarded to the Palm Beach County State Attorneys Office for review.
