INSTRUCTIONS TO VOTER

The following are instructions on how to vote your ballot. Please follow these instructions precisely, otherwise, your ballot may not be counted.

- 1. Verify that there are initials of an election official at the bottom of the ballot.
- 2. Verify that there are no voting marks on the ballot.
- 3. Use blue or black pen to mark the ballot.
- 4. Fill in the oval completely () next to either "FOR said bonds and tax" or "AGAINST said bonds and tax". Circling or placing other marks outside of the oval will not suffice.
- 5. Do not overvote or your vote will not be counted.
- 6. Do not cross out or erase. If you make a mistake, write "VOID" across the face of the ballot and call the Sarpy County Election Commissioner for instructions.
- 7. After voting, insert the ballot into the *Return Identification Envelope* and then complete, sign and seal the *Return Identification Envelope*.
- 8. Any person physically unable to sign the envelope must make his/her "mark" and have a witness write the voter's name and sign on the witness line below.
- 9. Failure to complete and sign the *Return Identification Envelope* will cause the ballot to be rejected.
- 10. Place postage on the envelope (\$0.63).
- 11. Mail or deliver your ballot to the Election Commissioner of Sarpy County, 1102 E. 1st Street, Ste #1, Papillion, NE 68046. Your ballot must be in the possession of the Sarpy County Election Commissioner by 5:00 p.m. on Tuesday, May 9, 2023.

"Shall Sarpy County School District 0027 (Papillion La Vista Community Schools), in the State of Nebraska, issue the Bonds of said District in the principal amount not to exceed One Hundred Twenty-Nine Million Nine Hundred Thousand Dollars (\$129,900,000) for the purpose of paying the costs of:

- improvements to safety and security for all schools including the construction, acquisition and installation,
- constructing additions, improvements, repairs and renovations to existing schools and program facilities,
- updating and enlarging older existing classrooms, bringing them to a current standard,
- constructing a new elementary school to serve projected enrollment growth,
- constructing a new facility for the Young Adult Transition Program that serves students with disabilities,
- providing furniture, equipment and technology for such schools and program facilities, and
- acquisition and preparation of land sites for future schools and program facilities;

said bonds to be issued in one or more series, at such time or times as may be determined by the Board of Education, to bear interest at such rate or rates as may be determined by the Board of Education and to become due at such time or times as may be fixed by the Board of Education; and

Shall the School District cause to be levied and collected annually a special levy of taxes against all the taxable property in the School District sufficient in rate and amount to pay the interest on and principal of said Bonds as the same become due?"
