NARRATIVE:

On Tuesday, April 6th 2021, at approximately 1600 hours, I initiated this case as a result of a separate investigation involving [REDACTED]. After [REDACTED] arrest for the other case (PBSO case # 21-049077), sixteen-year-old [REDACTED] reported he had been sexually battered by [REDACTED] who he identified as twenty-seven-year-old [REDACTED]. Victim Advocate Maura Smith was assigned to this case and advised she would schedule a forensic interview for [REDACTED].

On Wednesday, April 14th 2021, at approximately 0800 hours, I went to the Child Protection Team (CPT) Office to attend multiple previously scheduled forensic interviews, to include [REDACTED].

The summary of the paraphrased information learned from the forensic interview with Case Coordinator (CC) Tracy Piendle interview was documented as follows: Sixteen-year-old [REDACTED] told Senior Case Coordinator Tracy Piendle he was inappropriately touched by [REDACTED] identified as [REDACTED] whom he referred to by his first name of [REDACTED] throughout the interview.

Once [REDACTED] acknowledged his understanding between the truth and a lie, he agreed to tell the truth during this interview. She then advised him of the video and audio recording activated equipment.

[REDACTED] acknowledged he was present today to talk about experiences with his [REDACTED] whom he identified as [REDACTED]. [REDACTED] currently attends the [REDACTED]. He said [REDACTED] had been babysitting him since he was eight years old and described him as a "pedophile." [REDACTED] said [REDACTED] was doing "inappropriate stuff" to him and instructed [REDACTED] to keep it a secret, regarding phone and in person sexual activities. While attending

and fourteen years old, started his unwanted criminal sexual behavior towards . described would start by "dipping his finger" in the hole (rectum) which would cause him to "get hard" (erection). would instruct him not to tell anyone about this, and told him if he told anyone "he would get arrested and go to jail." told CC Piendle "would dip his finger in my butt" advising this occurred several times on bed, while was at school. said it was painful when inserted his finger into his butt.

continued explaining he would be laying down on his bed in his bedroom with beside him, also on his back. would instruct to remove his pants and underwear, exposing his genitalia and buttocks. Afterwards, would direct to maneuver himself on to his hands/forearms and knees facing down towards the bed. would then reposition himself behind and crouch over him while he was on all fours described as doggy style.

At a later time during the interview, stated would go to the bathroom and get some lotion to put on his finger (rubbed his hands together with the lotion, which imitated) prior to digitally penetrating his rectum with his finger. After using the lotion, would return the lotion to the bathroom. also complained when inserted his finger inside him it hurt. said neither inserted anything other than his finger inside rectum nor ever requested perform oral sex on .

then mimicked his movements/position on the bed, and went down on the floor positioning himself on his knees and elbows/forearms, recreating the aforementioned description for CC Piendle. would then tell to get his thing hard referring to his penis, explaining it would feel good and to use lotion. also described his penis as his private parts.

continued explaining would then put his mouth on penis and perform oral sex acts on him. advised performed oral sex on him multiple times in his bedroom, bedroom, and in loft, while was home in a different room. said would perform oral sex on him to make his penis hard. then mimicked movements by moving his cupped hand up and down on the tip of his shoe explaining how would masturbate himself. Although was unable to recall what was doing with his hands while he was performing oral sex on him, which he repeated occurred many times.

When would stop, would instruct him to brush his teeth and put his pajamas on. Sometimes would tell to stop which would inquire "ok you don't want to do it anymore" and would proceed to redirect his attention to his phone, away from. advised he would ejaculate when he masturbated himself and failed to remember if anything came out as a result of Lewd or Lascivious acts, when asked if anything came out of his penis. At a later time, during the interview, recalled ejaculating one time after being instructed to by differentiating between urine and ejaculate. He said he was communicating with

on Face Time and [REDACTED] wanted to see the ejaculate come out of [REDACTED] penis. Although [REDACTED] didn't see [REDACTED] ejaculate he remained on Face Time with him until he climaxed. [REDACTED] said this happened on multiple occasions, through Face Time. At a later time during the interview, [REDACTED] said [REDACTED] expressed his appreciation telling [REDACTED] "it was awesome, perfect" when he showed him the ejaculate after it he climaxed and that [REDACTED] had witnessed him ejaculating.

[REDACTED] continued describing masturbating himself when he would talk to [REDACTED] on Face Time. [REDACTED] said [REDACTED] would instruct him to masturbate his penis by "pulling on it" and showed him how to masturbate by flipping the camera's view to [REDACTED] and masturbating himself as an example for how [REDACTED] should do it. [REDACTED] then imitated [REDACTED] hand movements in an up and down motion to show CC Piendle how [REDACTED] provided a live example for [REDACTED] to do to himself. [REDACTED] said he didn't observe anything come out of [REDACTED] penis while he masturbated himself for [REDACTED] [REDACTED] then requested [REDACTED] turn the camera towards himself and make himself hard. [REDACTED] continued explaining if he defied [REDACTED] instructions/request, [REDACTED] would stop talking to him and hang up.

[REDACTED] then began talking about [REDACTED] infatuation with giving him wedgies, describing [REDACTED] grabbing and pulling his underwear up above the belt line of his pants, and also did it to one of his unidentified friends. [REDACTED] also gave wedgies to [REDACTED] and [REDACTED].

[REDACTED] then spoke about hearing [REDACTED] and [REDACTED] report [REDACTED] unwanted sexual criminal behavior to Juno Beach Police Officers, because of his recent arrest announced on television. [REDACTED] also advised he joked around with [REDACTED] and told him he would tell on him regarding the criminal sexual activity which took place between them. [REDACTED] replied by instructing him not to tell anyone.

[REDACTED] disclosed the majority of their contact was on Social media and some texting on Instagram. [REDACTED] described some of their conversations were about upcoming movies. However, [REDACTED] requested [REDACTED] delete all messages in his phone to avoid getting in trouble without providing details of the message content. Approximately three years ago he requested to see [REDACTED] penis while talking on Face Time. When [REDACTED] fulfilled his request he "screen-shotted it." [REDACTED] instructed [REDACTED] to delete it and not to joke about something like that, describing [REDACTED] was serious when talking to him about this.

[REDACTED] advised he recently received a new phone for his sixteenth birthday, an I-phone 11 which replaced his I-Phone 10 he had during the aforementioned communication with [REDACTED].

[REDACTED] then began describing [REDACTED] using two cell phones to talk to him. One he thought was an Android and the other an Apple product I-Phone which he used to Face Time him. [REDACTED] added he and [REDACTED] communicated by text, "insta" (Instagram) and "snap" (Snapchat). All video and live talking through the phone was on the social media platform Face Time. [REDACTED] recalled the I-Phone [REDACTED] had was covered with a dark cover and had a small crack in the screen from dropping it. He remembered the




phone details because [redacted] let him use it to view super hero characters on a phone. Towards the end of the interview, [redacted] expressed his concerns/curiosity to CC Piendle regarding [redacted] access and ability to watch this video.

Based on my investigation probable cause was established to charge [redacted] who did unlawfully engage in an act that would be sexual battery with [redacted], a child 12 years of age or older but less than 18 years of age, while [redacted] was in a position of familial or custodial authority over [redacted] by digitally penetrating [redacted] rectum with his finger in addition to performing oral sex on him, pursuant to Florida Statute 794.011(8)(b).

Probable cause was also established to charge [redacted] who did intentionally touch the genitals, genital area, or buttocks, or the clothing covering them of [redacted], a victim 12 years old or older but less than 16, in a lewd and lascivious manner {or} did force or entice [redacted] to so touch [redacted] in that [redacted] did touch and masturbate [redacted] penis and [redacted], was 18 years of age or older, Pursuant to Florida Statute 800.04(5)(a)and(b).

Probable cause was also established to charge [redacted] who did intentionally expose the genitals in a lewd or lascivious manner {or} intentionally expose and masturbate his penis, a sexual act that did not involve actual physical or sexual contact with the victim, including, but not limited to, the simulation of any act involving sexual activity, live over a computer on-line service, Internet service, or local bulletin board service and [redacted] a person 18 years of age or older, knew or should have known or had reason to believe that the transmission was viewed on a computer or television monitor by [redacted] a person in Florida who was less than 16 years of age, Pursuant to Florida Statute 800.04(7)(b).
