NARRATIVE:

On Wednesday, April 14th 2021, at approximately 0800 hours, I went to the Child Protection Team (CPT) Office to attend multiple previously scheduled forensic interviews.

The summary of the paraphrased information learned from the forensic interview with Case Coordinator (CC) Tracy Piendle interview was documented as follows:

_____ was escorted to the interview room # 1 and sat down across from CC Piendle. _____ was diagnosed with and suffers from _____

_____ acknowledged his understanding between the truth and a lie and the black board was used as an example to confirm he understood the difference between the truth and a lie. _____ then agreed to tell the truth and was made aware of the audio and video cameras recording the interview. _____ advised he was cooperating with the forensic interview because he was inappropriately touched by his babysitter, identified as _____ whom he referred to by his first name of _____ throughout the interview.

_____ continued explaining, when _____ were little _____ would enter their bedroom and touch him inappropriately. _____ recently learned _____ was arrested for traveling to meet a child for sexual intentions.

_____ described the first time _____ touched him was when _____ was seated next to _____ on the floor of their living room. "He touched my" and pointed his finger towards his crotch area, and added _____ put his finger up his buttocks. _____ identified when he pointed to his crotch he was referring to his penis which he called a "pee pee."

██████████ also described ██████████ regularly giving him "wedgies" which was described as ██████████ grabbing his underwear from behind and pulling them in an upward motion exposing his underwear above his beltline exerting pressure on his genitalia which resulted in what ██████████ called a "rug burn" feeling.

██████████ said ██████████ also used his hand to touch his "pee pee" while imitating ██████████ movements with his hand clenched in a fist and moved it in an up and down motion. Furthermore, he advised ██████████ removed his pants and underwear before touching and masturbating ██████████

██████████ continued explaining ██████████ would then "flip" him over before inserting his finger into ██████████ anus. ██████████ described being positioned face down towards the floor while being supported by his knees and elbows/arms. ██████████ removed his pants and underwear before inserting a finger into ██████████ anus which he said hurt. ██████████ said ██████████ performed this unwanted sexual activity on multiple occasions without being able to definitively advise when they occurred except for recalling last year when he was twelve years of age.

██████████ then described a similar unwanted sexual encounter when he and ██████████ were in his bedroom, laying on his bed. He described ██████████ got close to him, making him feel uncomfortable, while both he and ██████████ laid on their backs next to one another. ██████████ then removed his pants and underwear and touch ██████████ "pee-pee" in a masturbatory manner.

At a later time during the interview, ██████████ explained on more than one time when ██████████ would masturbate him and white stuff would come out of his penis. ██████████ would then use tissues to wipe the ejaculate off of him and discard the soiled tissues in the toilet. ██████████ explained his "pee pee" changed, stating "it went from straight to down" imitating with his hands. That happened when ██████████ masturbated him and white stuff (ejaculate) came out of his penis.

Afterwards, ██████████ would position ██████████ on his knees and arms before inserting his finger into his rectum, in the same way he described ██████████ did in the living room.

██████████ again stated ██████████ repeated this unwanted sexual activity multiple times and continued until ██████████ was arrested without providing dates and or times.

██████████ described at a later time during the interview that one time, ██████████ placed his mouth on his penis and performed oral sex on ██████████ while he laid on the bed.

██████████ opened his mouth and imitated ██████████ with an up and down movement with his head imitating ██████████ mouth on his "pee-pee" in addition to using his hand.

██████████ also mimicked ██████████ hand motion moving his hand up and down to further demonstrate ██████████ actions to CC Piendle.

██████████ expressed his fear that ██████████ would hit him if he told anyone about ██████████ described lewd or lascivious conduct. Furthermore, ██████████ told ██████████ not to tell anyone about the unwanted sexual activity. ██████████ also disclosed he was aware ██████████ sexually violated ██████████ whom he described as ██████████ also advised ██████████ neither requested nor forced him to perform oral sex on ██████████

██████████ also advised ██████████ would request him on the social media platform of Instagram to talk, but he would deny the contact. ██████████ stated it was weird for a babysitter to follow him on Instagram. ██████████ continued he didn't want a babysitter following him on Instagram. ██████████ avoided contact with ██████████ except through text messaging because he was either busy with household chores or homework. He then expressed his desire not to hang out with ██████████ because he felt like ██████████ was touching him inappropriately explaining why would he want to hang out with ██████████. He added he never argued or fought with him either.

██████████ continued describing what he categorized as uncomfortable things ██████████ did to him exampling ██████████ requesting he log into FaceTime and expose ██████████ "pee-pee" (penis) to ██████████ through the social media platform of FaceTime. ██████████ said if he failed to show ██████████ his penis he would end the FaceTime contact and tell him good night. ██████████ also recalled an isolated time when ██████████ requested they both change into their pajamas simultaneously after removing all of their clothing while in each other's presence, without any sexual related interaction.

██████████ also advised ██████████ would enter his bedroom while he was changing clothes and would walk over to and sit on his bed and watch him change without doing anything inappropriate stating it was okay because he had seen him naked before. Additionally, ██████████ advised he had never sent or received pictures of their genitalia to one another on a cell phone. He advised all nudity observed was over FaceTime or in person.

Without prompting, ██████████ sent ██████████ a text one week before he was arrested, telling him he no longer wanted to hang out with him anymore. ██████████ replied "oh wow that hurts" and asked ██████████ why he sent that message to him. ██████████ also downloaded multiple pictures from the internet with the slogan "No Means No."

██████████ said he became anxious and nervous when his mother asked for his cell phone and the password to it, because ██████████ was texting him and he couldn't remember the details of the messages between them. He advised he was scared his mother would find out about what ██████████ was doing to him. He expressed his relief that ██████████ was now incarcerated. ██████████ said he blocked him from contact on his phone in addition to deleting messages and content regarding ██████████.

██████████ then described being around five years old and in kindergarten when ██████████ started babysitting him while attending ██████████. ██████████ also advised he thought ██████████ first started the "inappropriate" behavior when he was twelve years old and changed his answer to eleven years of age was when ██████████ started the aforementioned criminal sexual behavior.

██████████ described ██████████ as "nice." He then spoke about talking to ██████████ regularly, recalling one time when he overheard ██████████ talking to ██████████ on the phone while ██████████ was in Alabama.

██████████ also described observing ██████████ "pee-pee" (penis) being exposed when talking to him while communicating on FaceTime. ██████████ stated he exposed himself




to him on Face time while his penis was erect without performing any masturbatory actions.

Based on my investigation probable cause was established to charge [REDACTED], who did unlawfully engage in an act that would be sexual battery with [REDACTED], a child 12 years of age or older but less than 18 years of age, while [REDACTED] was in a position of familial or custodial authority over [REDACTED], by digitally penetrating [REDACTED] rectum with his finger in addition to performing oral sex on him, pursuant to Florida Statute 794.011(8)(b).

Probable cause was also established to charge [REDACTED] who did intentionally touch the genitals, genital area, or buttocks, or the clothing covering them of [REDACTED], a victim 12 years old or older but less than 16, in a lewd and lascivious manner {or} did force or entice [REDACTED] to so touch [REDACTED], in that [REDACTED] did touch and masturbate [REDACTED] penis and [REDACTED], was 18 years of age or older, Pursuant to Florida Statute 800.04(5)(a)and(b).

Probable cause was also established to charge [REDACTED] who did intentionally expose the genitals in a lewd or lascivious manner {or} intentionally with a described erection, a sexual act that did not involve actual physical or sexual contact with the victim, including, but not limited to, the simulation of any act involving sexual activity, live over a computer on-line service, Internet service, or local bulletin board service and [REDACTED] a person 18 years of age or older, knew or should have known or had reason to believe that the transmission was viewed on a computer or television monitor by [REDACTED], a person in Florida who was less than 16 years of age, Pursuant to Florida Statute 800.04(7)(b).
