UPON ARRIVAL, I MET AND SPOKE WITH ROBERT BOGDANOFF, W/M D.O.B 10-03-51, WHO STATED THE FOLLOWING: HE IS THE EARLY VOTING SITE SUPERVISOR. THIS MORNING HE PLACED A SIGN OUT INDICATING WHERE THE CANDIDATES CAN DISPLAY THEIR SIGNS 150 FEET FROM THE FRONT DOOR ENTRANCE. BOGDANOFF SAID HE THEN WENT INSIDE THE LIBRARY TO PERFORM HIS DUTIES. BOGDANOFF SAID WHEN HE RETURNED OUTSIDE, HE NOTICED THAT SUPPORTERS OF DAVID IRVING SHINER HAD A TENT WITH SIGNAGE VIOLATING THE 150 FEET DISTANCE MARK. BOGDANOFF SAID THAT HE ASKED A MALE SUBJECT WHO WAS AT THE DAVID IRVING SHINER TENT TO MOVE THE TENT BACK. HE REFUSED. BOGDANOFF SAID HE THEN CALLED THE POLICE.

SGT. PIPER ID# 24985 AND I ARRIVED ON SCENE. BOGDANOFF SHOWED US WHERE HE PLACED THE BOUNDARY SIGN THAT THE CANDIDATES COULD NOT CROSS. I NOTICED THE DAVID IRVING SHINER TENT WAS IN FRONT OF THE BOUNDARY SIGN BOGDANOFF PLACED. I THEN MET AND SPOKE WITH PETER CAVANAUGH, W/M, WHO WAS AT THE DAVID

ON 10/19/2020, AT APPROXIMATELY 1605 HOURS, I ARRIVED AT, 1951 ROYAL FERN DR, WELLINGTON FL, THE WELLINGTON LIBRARY, TO INVESTIGATE A SUSPICIOUS PERSON COMPLAINT. IT WAS ALLEGED BY AN ANONYMOUS COMPLAINANT THAT A WHITE MALE STANDING BY A LIMOUSINE WAS YELLING THROUGH A MEGAPHONE CAUSING A DISTURBANCE AT THE POLLING STATION. I DID OBSERVE THE MALE IN QUESTION WHO WAS OUTSIDE THE RESTRICTED ELECTION SOLICITATION AREA AND MUSIC WAS IN FACT BEING PLAYED THROUGH A PORTABLE SPEAKER THEN FURTHER AMPLIFIED THROUGH A MEGAPHONE IN THE DIRECTION OF THE CROWD WAITING IN LINE IN THE PARKING LOT. FURTHER FOLLOW UP REVEALED SEVERAL COMPLAINTS WERE MADE TO ELECTION OFFICIALS WHO SAID THAT HIS ACTIONS DID NOT CONSTITUTE ANY ELECTION INTERFERENCE VIOLATIONS AS HE WAS OUTSIDE THE RESTRICTED AREA. I THEN INFORMED THE MALE WHO WAS IDENTIFIED AS RYAN MERMER OF THE VILLAGE OF WELLINGTON NOISE ORDINANCE REGARDING AMPLIFIED SOUND DEVICES. I INFORMED MR. MERMER THAT AT THIS TIME THIS WAS AN ANONYMOUS COMPLAINT AND THAT I ONLY WANTED TO EDUCATE HIM OF THE VILLAGE ORDINANCE WHICH HE SAID HE NOW UNDERSTOOD AND DID AGREE TO VOLUNTARILY TURN THE MUSIC AND MEGAPHONE DOWN TO HOPEFULLY A MORE TOLERABLE LEVEL.

HARRIS DIRECTED ME TO A BLUE TENT NEAR THE ENTRANCE WITH TWO WHITE FEMALES UNDERNEATH IT. SHE STATED THAT THEY ARE OUTSIDE THE 150FT LIMIT, BUT ARE IMPEDING TRAFFIC. THIS ROADWAY BLOCKAGE OCCURS WHEN THEY TRY TO HAND OUT MATERIAL TO PEOPLE ARRIVING BY STEPPING IN FRONT OF VEHICLES AND WAVING THEM TO STOP. HARRIS STATED THAT SHE HAS ALSO BEEN APPROACHED BY VOTERS WHO STATED THEY BELIEVED THEM TO BE OFFICIAL STAFF AND THAT IS WHY THEY STOPPED. IT SHOULD BE NOTED THAT WHILE TALKING TO HARRIS, I DID OBSERVE THE FEMALES IN QUESTION ENTER THE ROADWAY TO FLAG CARS TO STOP AND THEN HANDED THEM

A SECOND CALLER WHO IDENTIFIED THEMSELVES AS MICHELLE THOMPSON, THE CITY OF GREENACRES'S SERVICE DEPARTMENT DIRECTOR, STATED CONCERNS AS WELL. AT THIS TIME I MADE CONTACT WITH BOTH FEMALES AND ADVISED THEM THAT WHILE THEY ARE FINE TO REMAIN AT THEIR CURRENT LOCATION, THEY CAN'T BLOCK THE ENTRANCE OR ENTER THE ROADWAY TO STOP VEHICLES. THE PAIR BECAME AGITATED BUT APPEARED TO LISTEN. HARRIS ADVISED THAT IT WOULD BE PREFERRED IF THEY MOVED INTO THE PARKING LOT SLIGHTLY TO AVOID ANY TRAFFIC ISSUES. THE COUPLE AGREED TO MOVE APPROXIMATELY 20 FEET WEST INTO THE LOT WHICH IS STILL OUTSIDE THE 150FT LIMIT.

BEFORE LEAVING THE SCENE I INFORMED HARRIS OF THE PAIR'S WILLINGNESS TO COMPLY AND FORWARDED MY CASE NUMBER TO SGT. GRAHAM. THIS CALL WAS CLEARED WITHOUT FURTHER INCIDENT AND THIS CONCLUDES MY INVOLVEMENT IN THIS CASE.

SUPERVISOR B/F MAUREEN W. HARRISON 05/20/1065. I MADE CONTACT WITH HARRISON
WHO PROVIDED ME WITH THE FOLLOWING INFORMATION:
HARRISON ADVISED THAT SHE HAS BEEN RECEIVING COMPLAINTS FROM VOTERS ABOUT AN
UNKNOWN W/F (LATER IDENTIFIED AS JANE A. JUSTICE 06/13/1956) WALKING UP TO
THEM AND ASKING WHO THEY ARE VOTING FOR. HARRISON CONTINUED TO ADVISE THAT
WHEN THE VOTERS WOULD TELL JUSTICE WHO THEY WERE VOTING FOR, JUSTICE WOULD
EITHER MAKE A SOUND OR QUESTION THEM IF THEY WERE VOTING FOR SOMEONE JUSTICE
DID NOT AGREE WITH. HARRISON STATED THAT THE VOTERS ALSO COMPLAINED HOW
JUSTICE WOULD STOP EVERY VEHICLE IN THE ROADWAY THAT WAS ENTERING THE PARKING
LOT TO HAND OUT FLIERS AND TALK TO THE OCCUPANTS. HARRISON REQUESTED THAT I

AFFECT THE POLLING SITE LOCATED AT THE LANTANA LIBRARY - 4020 LANTANA RD. DUE
TO THE POTENTIAL OF AN OUTAGE DURING POLLING, I WAS DISPATCHED TO NOTIFY THE
SUPERVISOR ON SCENE. WHEN I ARRIVED I MET WITH BRUCE FONG, THE SITE
SUPERVISOR. I MADE HIM AWARE OF THE POTENTIAL POWER OUTAGE, AT WHICH POINT HE
BEGAN TO MAKE NOTIFICATIONS.
I REMAINED ON SCENE UNTIL FPL COMPLETED THEIR WORK. DURING THAT TIME, THE
POWER AT THE POLLING STATION DIDN'T APPEAR TO HAVE ANY POWER OUTAGES. ONCE I
WAS NOTIFIED OF THAT FPL WAS DONE WITH MANIPULATING THE GRID AND NO OUTAGES
