I, Brad Lancaster, a Detective with the Kansas City Kansas Police Department, being of lawful age, having first duly sworn upon my oath, do hereby depose and state:

On 11/25/2015, Officers of the Kansas City, KS Police Department responded to 5201 N 99<sup>th</sup> Street, Kansas City, Wyandotte County, Kansas in regards to a domestic disturbance. Officers determined that the felony crimes of Aggravated Assault and Aggravated Battery had likely occurred. The victim, Heather Jones, had injuries consistent with being beaten and choked. Heather reported that the suspect, Michael Jones, had fired a gun at her while outside the home. Michael was taken into custody while driving away from the residence, in a gold 2009 GMC Yukon, as officers arrived on the scene.

While speaking to Detective Lancaster, Heather alleged that Michael's 7 year old son A.J. had died in the home on or about 09/28/2015 and that Michael disposed of his body on the property, in an effort to conceal the death and severe child abuse.

On 11/26/2015, officers of the Kansas City, KS Police Department executed a valid search warrant for the residence, curtilage and outbuildings on the property commonly known as 5201 N 99<sup>th</sup> Street. Officers

discovered human remains that were consistent in size with that of a 7 year old child, stored in the exact manner and location described by Michael. A subsequent autopsy performed by Dr. [REDACTED] confirmed these findings.

During the investigation, Heather discussed being an avid user of Facebook and having numerous conversations and pictures stored on her accounts. Investigators identified two accounts with the username Heather Jones, which they associated to her and which Heather herself verified were her personal accounts. Each contains photos of the Heather Jones linked to this investigation.

On 11/29/2015, investigators spoke to [REDACTED] who advised she had been a member of a private Facebook page titled "Fuck everyone else!". [REDACTED] was no longer a member of that group due to the nature of conversations taking place, but her friend, [REDACTED], is still a member. [REDACTED] responded to the KCKPD CID, where she called [REDACTED] on the phone. [REDACTED] provided [REDACTED] with her Facebook login information for the explicit purpose of accessing the private Facebook group "Fuck everyone else!". One specific post was initiated from the Facebook account known to be associated to Heather Jones. In subsequent interviews, Heather would acknowledge making these posts. This post, dated 12/25/2014 and geotagged near Piper, K.S, states:

"I have a psychopath I'm giving away for free today!!! He broke out last night and fucked my kitchen and everything I had baked up!!! I'm beyond pissed and he's running laps round my pool and doing push ups till I'm tired unless someone wants him!!!"

Heather's replies to her own post include:

"I can't shoot him unfortunately but I can work the shit outta him til I feel better!! And Merry Christmas to you too [REDACTED]" —dated 12/25/14 at 0924 hours.

"I'm soooo beyond done with this kid!!! Last night he chased me with a fucking kitchen knife trying to stab me til I jumped the countar in pain and all and tackled his ass!!" —dated 12/25/14 at 0925 hours.

"[REDACTED] yall sure you don't want him?? I'll pay child support" —dated 12/25/14 at 0930 hours.

"Seriously!! He's for real a psychopath I'm soon not kidding!! Everyday with child is like being on guard in a prison yard!!" —dated 12/25/14 at 0935 hours.

"His bio mom fucked this kid up like seriously!! He kills everything he comes in contact with and has to be restrained 95% of the time" —dated 12/25/14 at 0939 hours.

[REDACTED] replies:

"Heather is he the push up kid?? Lmfao from ur security camera when I was like wtf is that??? Lmao poor kid and god bless u for taking him in!!!" —dated 12/25/14 at 1004 hours.

[REDACTED] responds:

"Merry Christmas but I can't take him. [REDACTED] would have no problems pulling a [REDACTED] and having him look at flowers..." —dated 12/25/14 at 1008 hours

[REDACTED] responds:

"The flowers in the attic? [REDACTED] lmao" --12/25/14 at 1014 hours

Heather Jones responds:

"Walking dead "look at the pretty flowers" yea I'm bout to pull that shit!!! AGAIN like not even 8 minutes ago he flipped my 4 month old out her bassinnet while I went pee!!!"—12/25/14 at 1032 hours.

Detective Lancaster recognized this as an obvious reference to Episode 14 of Season 4 of The Walking Dead, titled "The Grove", which originally aired on 03/16/2014. In this episode, the adult character Carol decides the juvenile character Lizzie has become too dangerous, after she had killed another child, Mika.

Carol decides she has to kill Lizzie. Carol walks Lizzie to a flower bed and tells her three times, "Just look at the flowers." before shooting the child 'Lizzie' in the back of the head and killing her.

The message thread continues at length with Heather making comments that include:

--"pain compliance does not work"

--"I've tried leather belts and that shit don't work"

--"Recently started using ace bandages and splints out of my medical bag my ass too tired for that last night when I was ready to lay down lil bastard!! I'm more mad at myself for slippin"

--"I carry guns and a badge I cuff is lil ass and he unhinged a pair of my police issued handcuffs and still to this day I can't figure out how he did it!! He didn't give 2 fucks and prefers to be in a locked down institution than the freedom of home that he doesn't get because of his choosing and no facility in ks or mo will keep him or take him because he is so young"

--"He has no contact with my other 7 kids NONE at all!!!"

On 12/28/2014 at 2002 hours, Heather replied to a photo posted by [REDACTED]. That reply states, "Scared to look at my phone afraid I might be the next [REDACTED] and have to feed some pigs a body!!!"

On 03/02/2016, [REDACTED] contacted Detective Lancaster and notified him that she had gained access to Heather Jones' primary Facebook account, at Heather's request, to preserve photographs. [REDACTED] advised that through a series of phone calls which Heather placed from the Wyandotte County Jail and letters sent via USPS Mail, that Heather gave a lengthy list of email accounts and possible passwords, asking [REDACTED] to access email accounts, PayPal accounts and Facebook accounts, to manage money and preserve data. Pursuant to Heather's request, [REDACTED] began to download photos from Heather's Facebook account. While doing so, she looked for photos within Facebook messages sent to numerous Facebook accounts. One of those accounts, titled Mike Jones, contained roughly 7,000 messages. Within that conversation, [REDACTED] described a large amount of messages which include text and photographs that detail the restraint, confinement, torture, abuse, physical punishment and injuries of A.J. [REDACTED] advised she wanted to share this information with the KCKPD for the investigation.

On 03/03/2016, Detective Lancaster met with [REDACTED]s at her home in [REDACTED], KS. [REDACTED] logged into Heather Jones primary Facebook account and scrolled through the conversation between this account and one Mike Jones Facebook account. This account for Mike Jones contains a profile picture with a "PAPERCHASE PROMOTIONS" emblem. During the investigation, it became known to Detective Lancaster that PAPERCHASE PROMOTIONS was a business venture operated by Michael Jones. [REDACTED] scrolled as far back as 12/23/2014, however, the message history predates this point. From 12/23/2014 to April, 2015, Heather and Mike repeatedly talk about A.J. The conversations include numerous photos which include A.J. naked in the shower with a mouth injury that Heather claims is from him removing the shower door, multiple photos of A.J. strapped to the inversion table, including covering his face and eyes, numerous photos showing severe swelling to A.J.'s limbs, open sores on his limbs which appear to be from restraint methods also visible in photos, a photo of A.J. handcuffed and shackled to the inversion table while sitting on the floor in the closet and photos of A.J. standing outside, arms raised and barefoot with pants and a short sleeve shirt on, (the message accompanying these photos is from mid December, 2014). Numerous photos of various restraint methods they were considering for A.J., to include inversion tables, straight jacket, restraint bed, restraint belt, full body enclosure and a restraint band. They repeatedly discussed how they restrained A.J., including handcuffs, shackles, ace bandage and straps. One photo shows a closeup of A.J.'s lips swollen and bloody, sent by Heather. Mike replies that the injuries could be from "me" (Mike) popping "him" (A.J.).

The last message from this conversation visible is from April 2014. [REDACTED] showed a second conversation from the same Facebook account belonging to Heather, to a second Mike Jones Facebook

account, which messages that begin in late 2014. They discuss A.J. in this conversation. The Facebook profile picture for this account is the business logo for Mike Jones Bail Bonds, the LLC company operated by Michael and Heather Jones.
