**COUNT ONE**

On or about and between June 1, 2025 and December 22, 2025,  
in the County of Placer, the crime of MURDER, in violation of  
Penal Code section 187(a), a Felony, was committed by RETUQUEL  
DUPREE & JESSICA LEANN SAVANGSY, who did unlawfully, and with  
malice aforethought murder A.S.(age 7), a human being.

It is further alleged that the above offense is a serious  
felony within the meaning of Penal Code section 1192.7(c)(1).

It is further alleged that the above offense is a violent felony within the meaning of Penal Code section 667.5(c)(1).

COUNT TWO

On or about and between June 1, 2025 and December 22, 2025, in the County of Placer, the crime of TORTURE, in violation of Penal Code section 206, a Felony, was committed by RETUQUEL DUPREE & JESSICA LEANN SAVANGSY, who did unlawfully and with the intent to cause cruel and extreme pain and suffering for the purpose of revenge, extortion, persuasion and for a sadistic purpose, inflict great bodily injury, as defined in Penal Code section 12022.7, upon A.S., (age 7).

It is further alleged that the above offense is a serious felony within the meaning of Penal Code section 1192.7(c)(1).

It is further alleged that the above offense is a violent felony within the meaning of Penal Code section 667.5(c)(1).

COUNT THREE

On or about and between June 1, 2025 and December 22, 2025,  
in the County of Placer, the crime of TORTURE, in violation of  
Penal Code section 206, a Felony, was committed by RETUQUEL  
DUPREE & JESSICA LEANN SAVANGSY, who did unlawfully and with the

1 intent to cause cruel and extreme pain and suffering for the  
2 purpose of revenge, extortion, persuasion and for a sadistic  
3 purpose, inflict great bodily injury, as defined in Penal Code  
4 section 12022.7, upon A.S., (age 5).

5 It is further alleged that the above offense is a serious  
6 felony within the meaning of Penal Code section 1192.7(c)(1).
