It is further alleged that the above offense is a violent felony within the meaning of Penal Code section 667.5(c)(1).

#### COUNT THREE

On or about and between June 1, 2025 and December 22, 2025, in the County of Placer, the crime of TORTURE, in violation of Penal Code section 206, a Felony, was committed by RETUQUEL DUPREE & JESSICA LEANN SAVANGSY, who did unlawfully and with the
