**RESOLUTION OF THE SACRAMENTO COUNTY BOARD OF SUPERVISORS
REAFFIRMING SUPPORT FOR SB54, THE CALIFORNIA VALUES ACT,
SUPPORTING CHANGES THAT FURTHER REDUCE COOPERATION
WITH FEDERAL IMMIGRATION ENFORCEMENT, AND PROHIBITING
COUNTY FUNDS OR RESOURCES TO ASSIST IN THE ENFORCEMENT OF
FEDERAL IMMIGRATION LAW**

WHEREAS, the County of Sacramento (“County”) is home to persons of diverse racial, ethnic, and national backgrounds, including a large immigrant population; and

WHEREAS, the County respects, upholds, and values equal protection and equal treatment for all of its residents, regardless of immigration status; and

WHEREAS, nurturing a relationship of trust, respect, and open communication between County employees and County residents is essential to the County's core mission of ensuring public health, safety, and welfare, all of which best serves the needs of everyone in the community, including immigrants; and

WHEREAS, the County ended its contract with Immigration and Customs Enforcement (ICE) for the Rio Cosumnes Correctional Facility in June 2018; and

WHEREAS, on November 17, 2020, the Sacramento County Board of Supervisors passed Resolution No. 2020-0773 declaring racism a public health crisis.

THEREFORE, BE IT RESOLVED AND ORDERED that, consistent with the policies and practices of numerous other jurisdictions around the country as well as California legislative authorities, and except as indicated herein, no County funded resources including property, personnel and labor resources shall be appropriated and/or utilized in order to assist, facilitate, or otherwise cooperate with federal

immigration authorities or persons or entities contracted for immigration enforcement purposes; and

BE IT FURTHER RESOLVED that, except as indicated herein, such restrictions shall include, but are not limited to (a) investigations pertaining to alleged acts amounting to offenses under federal civil and/or criminal immigration law, (b) notification or communication to federal immigration authorities of information related to a person's immigration status, country of birth, or a detainee's date, time or location of release, (c) transfer of custody to federal immigration authorities, whether direct or indirect, of a person on County and/or adjoining public or private property, (d) holding a person beyond the time they would otherwise be released from custody pursuant to a detainer request issued by federal immigration authorities, or on the basis of an administrative warrant, prior deportation order, or any other document or rationale related to immigration enforcement objectives, (e) any detention or arrest procedure effectuated by federal immigration authorities related to alleged violations of federal civil and/or criminal immigration law, (f) any interview, questioning or similar contact with a detainee by federal immigration authorities for the purpose of investigating or gathering of information related to the enforcement of federal civil and/or criminal immigration law, (g) allowing or facilitating access to any law enforcement information system or database, or any information contained therein, by federal immigration authorities, and (h) participating in any other federal immigration enforcement action, operation or procedure regardless of its stated purpose; and

BE IT FURTHER RESOLVED that, County property, personnel, time, labor, funds or other resources may not be appropriated and/or utilized to assist, facilitate, or

otherwise cooperate with federal immigration authorities or persons or entities contracted for immigration enforcement purposes if not duly authorized pursuant to a judicial warrant or judicial probable cause determination (as those terms are defined in Government Code section 7284.4), or as **permitted** and not otherwise prohibited by, any provision of federal, state or local law; and

BE IT FURTHER RESOLVED that, in the event the Sheriff or members of the Sheriff's Department disregard this resolution and assists in a civil and/or criminal immigration investigation, detention, arrest, targeted enforcement action, or any other collaboration prohibited by this resolution, **or provide cooperation in any way with federal immigration officials, as allowed in Government Code section 7282.5,** the Sheriff's Department shall be expected to explain the facts and circumstances giving rise to any/all actions taken in a written report describing such assistance, including a detailed account of the prohibited conduct, as well as the involvement of any County personnel or other resources, and also provide a summary, analyses and presentation of the written report to the Community Review Commission, the Inspector General, **County Counsel** and the Board of Supervisors within one week of any such prohibited conduct; and

BE IT FURTHER RESOLVED that any such communication required above shall also be placed upon the agenda at the next scheduled meeting of the Board of Supervisors; and

BE IT FURTHER RESOLVED that, in the event that there is a finding of the Sheriff's Department having violated this resolution by the Community Review Commission, Inspector General, and/or the Board of Supervisors, it may then, after having evaluated the written report and presentation as required by the clause above, require that the Sheriff articulate and identify corrective measures it has enacted and/or will enact to prevent further violations; and

BE IT FURTHER RESOLVED that, the County Executive, in consultation with the Office of County Counsel, shall prepare and issue a letter to impacted County departments advising them of this resolution as well as the duty to report to the Community Review Commission.
