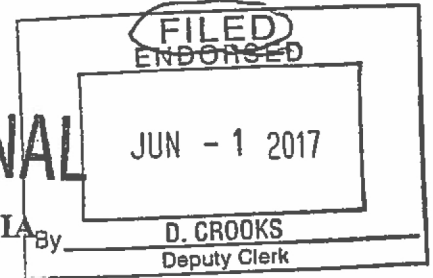

ARREST WARRANT STATEMENT OF PROBABLE CAUSE:

On 4-1-17 at approx. 2308 hours Sacramento Fire Department (SFD) paramedic unit Medic 57 responded to [REDACTED] on a report of a 19-year-old female who was having seizures, call #F17051280. When paramedics arrived, it was determined that the Patient, V- Doe, needed to be transported to the hospital for further medical treatment. The following personnel were assigned to Medic 57 that night: SFD Paramedic Jared Evans, SFD Paramedic Jerome Braddock, and Paramedic Intern Chad Morris.

On 4-16-17 Morris contacted SFD Paramedic Jim Anderson and advised him that on the above-mentioned call Evans made comments about V- Doe's breast and then placed his hand down her shirt and touched her breast. (Anderson serves as a liaison between the paramedic interns, American River College, and the SFD.)

On 4-18-17 I contacted Morris who stated that on the night of 4-1-17 he was working as a paramedic intern on SFD Medic 57 when they responded to a call of a 19-year-old female having seizures. He said that the patient, V- Doe, was "completely unresponsive to pain and verbal commands, she was out" and it was determined that she needed to be transported to the hospital. V- Doe was strapped to a gurney, placed in the back of the ambulance, and was transported to Kaiser South

hospital. Morris said that Braddock was driving, Evans was seated in the back at V- Doe's head, and he was seated on V-Doe's left side.

Morris said that while enroute to the hospital Evans motioned to V- Doe's breasts and told him to "take a look." Evans then placed his hand down the front of V- Doe's shirt and pulled her breast out of the top of her shirt / bra and said, "those are some big ass nipples." Evans then slid V- Doe's breast back into her shirt / bra. About a minute later Evans told Morris, "Sorry man, I had to." Morris said after that they had no further discussion about the incident.

On 4-24-17 I contacted V- Doe who stated that approx. 2 weeks ago she had a seizure at her house located at [REDACTED]. She said that she was placed in the back of an ambulance and was transported to the hospital. V- Doe said that while she was in the back of the ambulance her eyes were closed and she couldn't move, but she could hear the paramedics talking. She said that the paramedic sitting at her head, Evans, said "she has big tits" and she heard the other paramedic, Morris, say something back to him. V- Doe then felt a hand go down the top of her shirt and pull her right breast out of her shirt / bra. After a moment, the Suspect pushed her breast back into her shirt. V- Doe said that she couldn't see who touched her breast, but felt that it would have been the paramedic seated at her side, Morris, because she believes that she would have felt the arm of the paramedic seated at her head come over her shoulder if he was the one that touched her.

It should be noted that V- Doe was never given any details about the nature of the investigation prior to the interview.

On 4-28-17 Evans was interviewed with his attorney present and he denied touching V- Doe or making any comments about her breast. He also stated that Morris didn't make any comments about V- Doe's breasts and he didn't witness him touch her breasts. Evans further stated that he has never witnessed Morris inappropriately touch a patient or make inappropriate sexual comments about a patient during the time they have been together at the Fire Department.
