NARRATIVE	ON 07/31/2019 R/O OBSERVED A VEHICLE TRAVELLING AT A HIGH RATE OF SPEED ON CHAPPELLS HWY NEAR JOHN J. RUSHTON RD IN THE COUNTY OF SALUDA. R/O OBSERVED HIS RADAR THAT CONFIRMED THE VEHICLE WAS TRAVELLING AT 80MPH. THE VEHICLE PASSED BY R/O AND WAS A NEWER MODEL DODGE CHARGER. R/O TURNED AROUND ON THE VEHICLE BUT ONCE COMPLETELY TURNED AROUND AND ATTEMPTING TO CATCH UP WITH THE VEHICLE THE VEHICLE HAD DISSAPEARED. R/O KEPT DRIVING DOWN TO HWY 702 AND SAW NO SIGN OF THE VEHICLE AS R/O HAD CAUGHT UP WITH A FEW TRACTOR TRAILERS THAT HAD PASSED HIM LONG BEFORE COMING INTO CONTACT WITH THE CHARGER. R/O THEN TURNED AROUND AND CONTINUED BACK TOWARDS THE ORIGINAL TRAFFIC STOP ATTEMPT LOCATION AND OBSERVED THE SAME DODGE CHARGER PASS AGAIN AND R/O QUICKLY TURNED AROUND ON THE VEHICLE AND RAN THE TAG ON THE VEHICLE AS SC TAG# PDA737 BEFORE ATTEMPTING TO STOP THE VEHICLE. R/O INITIATED HIS BLUE LIGHTS AND VEHICLE CONTINUED TO DRIVE AT THE SAME RATE OF SPEED HEADED TOWARDS THE TOWN OF SALUDA. NARRATIVE

PULLED OVER. R/O THEN LEFT THE SIRENS ON AND WAS PASSING SEVERAL ROADS STILL HEADED TOWARDS THE TOWN OF SALUDA. R/O WAS THEN ADVISED BY DISPATCH THAT THE DRIVER OF THE VEHICLE HAD CONTACTED 911 AND ADVISED HE WAS NOT PULLING OVER UNTIL HE HAD REACHED FURTHER INTO TOWN WITH LIGHTS AS IT WAS UNSAFE. THE VEHICLE HAD THEN ENTERED TOWN LIMITS AND OFFICERS ROSE AND SHORTER ARRIVED ON SCENE AND CUT THE VEHICLE OFF FROM TRAVELLING ANY FURTHER INTO TOWN AS IT WAS ADVISED THAT THIS VEHICLE HAD DIPPED OFF ON THE ORIGINAL ATTEMPT TO STOP IT FOR SPEEDING.

THE DRIVER YAFARI WERTS WAS ASKED TO STEP OUT OF THE VEHICLE AND ASKED WHAT WAS GOING ON. HE EXPRESSED THAT HE WAS CONCERNED FOR HIS SAFETY AND THAT HE DID NOT KNOW THE ROAD AS IT WAS A BACK

ROAD AND IT WAS DARK. R/O ADVISED HIM IT WAS A MAIN HIGHWAY AND THAT HE SHOULD HAVE PULLED OVER BEFORE DRIVING SEVERAL MILES BEFORE STOPPING. R/O THEN PLACED THE SUBJECT UNDER ARREST FOR THE ORIGINAL CHARGE OF SPEEDING AND HE WAS READ HIS MIRANDA WARNINGS. R/O THEN SPOKE WITH HIM ABOUT THE ORIGINAL TRAFFIC STOP AND YAFARI DID STATE HE DID CUT DOWN ANOTHER STREET WHEN HE SAW R/O TURN AROUND ON HIM. HOWEVER YAFARI'S STORIES BEGAN MIXING UP AND NOT MAKING ANY SENSE. HE WAS THEN ASKED ABOUT THE WHITE POWDER ON THE HOOD OF HIS VEHICLE. R/O FIELD TESTED THE WHITE POWDER SUBSTANCE ON THE HOOD WITH A COCAINE KIT AND IT DID TEST POSITIVE WITH TWO KITS IN TWO DIFFERENT PLACES OF THE HOOD OF THE CAR. YAFARI STATED IT WAS BIRD POOP AND THAT HE HAD ATTEMPTED TO CLEAN IT UP ON MONDAY AT A CAR WASH IN NEWBERRY. HE THEN STATED HE HAD WENT TO CLINTON AND THAT'S WHERE HE WAS COMING FROM JUST NOW ON THE WAY BACK TO SCHOOL. R/O ADVISED HIM THE WHITE SUBSTANCE ALL OVER THE HOOD OF HIS CAR WAS STILL IN POWDER FORM AND MADE NO SENSE AS TO HOW IT WAS STILL THERE IF HE WASHED IT OFF AT A CAR WASH A FEW DAYS AGO. EVERYTHING ABOUT HIM AND INSIDE HIS VEHICLE MADE HIM APPEAR AS A CLEAN PERSON BUT THE HOOD OF HIS CAR WAS OUT OF PLACE. R/O ADVISED HIM DID TEST POSITIVE FOR A COCAINE SUBSTANCE. YAFARI ADVISED HE HAD NO IDEA ABOUT WHERE ANY OF THAT WOULD COME FROM.

SGT RODGERS TRANSPORTED YAFARI TO THE JAIL WITHOUT CAUSE. NICHOLS TOWING ARRIVED ON SCENE FOR THE VEHICLE.

R/O SCRAPED OFF AS MUCH OF THE WHITE POWDER SUBSTANCE FROM THE VEHICLE AS POSSIBLE. IT HAD APPEARED EITHER THE SUBSTANCE WAS THROWN ON THE VEHICLE AND HAD BEEN ATTEMPTED TO BE WASHED OFF BY THE WINDSHIELD WIPERS, AND WIPER FLUID AS THERE WAS WHITE POWDER SUBSTANCE AROUND THE AREAS OF THE WIPER FLUID DISPENSARY. R/O GATHERED APPROXIMATELY ONE GRAM OF THE SUBSTANCE AS SOME OF IT WAS STILL STUCK TO THE HOOD OF THE VEHICLE AND R/O DID NOT HAVE APPROPRIATE TOOLS TO GATHER THE SUBSTANCE BUT SCRAPED THE SUBSTANCE INTO A EVIDENCE BAG AND TRANSPORTED IT BACK TO THE SHERIFF'S OFFICE. THE WHITE SUBSTANCE WAS PLACED INTO A HEAT SEALED POUCH AND SENT TO SLED FOR FURTHER TESTING. PICTURES OF THE HOOD OF THE VEHICLE WERE TAKEN AND TAGGED INTO EVIDENCE.

YAFARI WAS THE ONLY SUBJECT IN THE VEHICLE. AN AFFIDAVIT WAS CREATED FOR POSSESSION OF COCAINE LESS THAN ONE GRAM AND SENT TO THE JAIL FOR THE JUDGE TO SIGN. A CITATION FOR SPEEDING WAS ALSO ISSUED.
