ORDER

On July 18, 2019, this Court held a status conference with counsel for all parties. During the conference, the parties agreed to continue the September 2019 trial, tentatively agreeing to December 2 – 5 and 9 – 10, 2019 as new trial dates. They also agreed to the following schedule:

By August 5, 2019, Defendants shall complete the production of the rolling discovery that they have agreed to produce.


By August 15, 2019, the parties shall file a joint pleading (or individual pleadings if necessary) with this court that addresses the following:

1. Confirmation that six days will be adequate for trial;
2. The scope of the December 2019 trial including any stipulations with respect to the evidence submitted during the September 2018 evidentiary hearing;
and
3. Confirmation of the parties' tentative agreement that this court's final order will not be issued until after New Hampshire's February 11, 2020 primary election

(the court's preliminary injunction would thereby remain in place until after the primary).
