Years of support and help is never enough, in the recent decade nothing, only shame. two kids fatherless eventually abandoned by the one responsible and all duty has gone way off track and must be righted. the few days left, this defendant must fix the obligation that he has grossly ignored of late. He must go and see to their needs and find what is lacking and fix it. He bost of helping those far and wide, yet two children stand neglected, adults now, but children The defendant must learn to plow a field with a donkey the same. and tend crops in Mexico to support those childr3en; or make bricks as teh children taught him to do 15 years ealier to provide for them.

If they are in need of a house, then he must build it for them, even if it takes 5 years, he is accustom to the challenge and duty.
