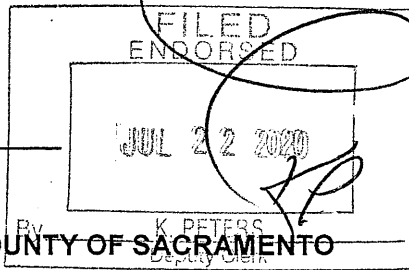

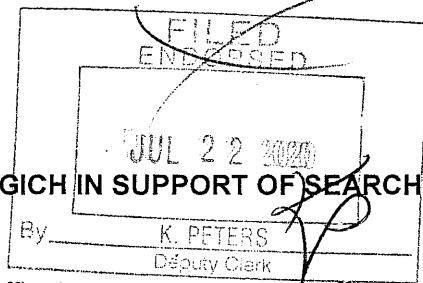

AFFIDAVIT OF NATE GRGICH IN SUPPORT OF SEARCH WARRANT

I, Nathaniel Grgich, Your Affiant, am a sworn peace officer in and for the State of California and have been so employed by the Sacramento Sheriff's Department since August 2004. I am currently assigned to the Federal Bureau of Investigation as a Task Force Officer for the Joint Terrorism Task Force as a Sergeant.

Prior to my assignment as a Sergeant, I was a Detective in Special Investigations and Intelligence Bureau and a Detective in the Threat Management Unit. Prior to being a detective I was assigned to the Sheriff's Department North Patrol Crisis Intervention Team as a Deputy. I was also assigned to the Sheriff's Department North Patrol Division as a Patrol Deputy from December 2013 to December 2017. Before my patrol assignment, I was assigned to the Sheriff's Department Main Jail Division.

I have held an ancillary assignment on the Critical Incident Negotiations Team (CINT) as a hostage negotiator since May 2015.

During the course of my employment as a Peace Officer, I have conducted several hundred preliminary and ongoing investigations of numerous crimes including but not limited to, homicide, robbery, kidnapping, burglary, conspiracy, theft, assault, battery, sexual assault, child abuse, elder abuse, domestic violence, forgery, fraud, financial crimes, identity theft, vehicle traffic violations, and alcohol/narcotics and other controlled substance violations.

I have written police reports, collected evidence, arrested and interviewed suspects, interviewed victims and witnesses, conducted no less than 10 field show-ups and no less than 5 photographic line ups, conducted undercover surveillance and testified in court regarding criminal violations. In the course of these investigations, I have made numerous probable cause arrests. I have also conducted numerous probation and parole searches.

I earned an Associates of Arts degree in University of Phoenix in 2013. I attended the Sacramento County Sheriff's Department Basic Peace Officer Academy and many other conferences and seminars sponsored by the Sacramento Public Safety Center, Sacramento Police Department, P.O.S.T., California Association of Hostage Negotiators and the Sacramento County Sheriff's Department. I have in excess of 500 hours of training including, but not limited to, the following: General Criminal Investigations, Terrorism, Criminal Street Gangs, Drug Recognition, Interview and Interrogation, Officer Survival.

I have received my Basic, Intermediate, and Advanced certificates from California Peace Officer Standards and Training.

I am aware of the following information either from personal observations, interviews and/or information that was relayed to me by other law enforcement officers based upon prior investigations and law enforcement reports.

Statement of Probable Cause

During the month of December 2019, your affiant began an investigation regarding graffiti which appeared to be motivated by hate/race.

During the investigation, I was able to identify a subject who was likely responsible for the

commission and/or orchestrating the act who was identified as **Andrew CASAREZ (01/09/1993)**. Andrew is a white male adult 6'04" tall, 230 lbs., with brown hair and green eyes. Your affiant conducted a computer check utilizing the Sacramento County Sheriff's Office Known Persons File (K.P.F.) K.P.F. listed an address of record for **Andrew** as **8888 Myhren Way**, Orangevale Ca. 95662.

Your affiant conducted a DMV check (Department of Motor Vehicles), which also identified Andrew's address of record as **8888 Myhren Way**, Orangevale Ca. 95662.

Casarez criminal history consists of an arrest for California Vehicle Code 23152 (A) (Driving under the influence of alcohol/drugs), and California Vehicle Code 23152(B) (Driving under the influence of alcohol greater than 0.08 percent).

Your affiant and/or other detectives involved in the investigation conducted surveillance of **8888 Myhren Way**. During surveillance your affiant and other detectives participating in the investigation personally observed **Casarez** arriving and departing from **8888 Myhren Way** on no fewer than four (4) separate occasions. During each occasion it appeared that **Casarez** had free unlimited access to the property (8888 Myhren Way). This activity has been consistent and Andrew has been observed entering/exiting the property boundaries of **8888 Myhren Way** as recent as June of 2020.

During the month of October of 2019 your affiant and/or other detectives participating in the investigation began monitoring hate based social media outlets, including but not limited to the "dark web". While monitoring, your affiant's attention later focused on an individual who used the moniker "Vic Mackey" of the "Bowl Patrol". Vic Mackey" was a fictional character in the FX series, "The Shield". In the series, Vic Mackey was portrayed in the ruthless racist detective in an experimental division who operated without boundaries. The Bowl Patrol is white supremacist group and the term **bowl** is based on the throwback bowl haircut which is now considered a symbol of hate by White Supremacists. "Vic Mackey", later to be identified as **Andrew CASAREZ**, even aired his own podcast titled "The Bowl cast"

During his podcasts and social media posts and blogs, "Vic" a.k.a. **Casarez** gave praise to and named the recent active shooters including Dylan Roof who carried out a mass shooting in June 2015 after entering a church and murdering (9) African American worshippers. **Casarez** also posts;

"There are those among a particularly repugnant circle of white supremacists who celebrate Roof and other who commit racial violence in order to spur on others to commit such acts. They called themselves the "Bowl Patrol"

On July 7, 2020 the infamous "Vic Mackey" was doxed and identified as **Andrew Richard CASAREZ** of Orangevale Ca. Doxed, short for (documents) is a commonly used street term used to describe the internet practice of researching anonymous posts, and then publicly broadcasting the user's true identity. **(SEE ATTACHMENT #1)**

On July 7, 2020, your affiant and/or other detectives participating in the investigation arrived at **8888 Myhren Way** in an attempt to speak with Andrew. Upon knocking at the front door detectives were greeted by an elderly male identified as Arturo Casarez who is **Casarez's** father.

Detectives were told that if we wished to speak with **Andrew** we would have to go through his attorney, even though he has no known pending criminal charges.

A search of the Automated Firearms System revealed the following firearms registered to **Casarez** and are believed to be located at his residence:

- 9MM "CZ"-USA Semi-Automatic pistol, serial #B810950

It was also discovered during the course of the investigation that **Casarez** talked about "needing to get another AR (AR-15)" this was posted on 01-30-2018 and is available for review upon request. It is known to your affiant that members of the white supremacy movement go out of their way to obtain "ghost guns." These groups seek these guns as a way to be prepared for a sought after "race war." These groups are known to have multiple unregistered firearms and countless rounds of ammunition.

Based on your affiants training and experience, your affiant is aware that when bloggers are doxed, meaning their true identity is finally revealed, bloggers are often faced with the dilemma of admitting they are a fraud, or they are expected to carry out an act of violence to retain their loyal followers, demonstrating their dedication and loyalty to their shared cause.

During the investigation **Casarez's** posts have continued to promote hatred based on race, religion, ethnicity, and sexual orientation. **Casarez** recent posts, coupled with being "dosed"

As a result of our current social climate, coupled with COVID 19, your affiant and other detectives have seen a significant increase in crimes committed based on hate, race, religion, and sexual orientation. When apprehended and/or interviewed many of the individuals have expressed feelings of frustration, feelings of isolation, and feeling helpless against COVID 19 and unsure of their future.

Your affiant believes **Casarez's** recent posts, the expectation to prove his loyalty as a result of being "dosed", are indicative of random acts of hatred carried out by a "Lone Wolf attacker." Motivated by his ideology and support of white supremacy. As a result of **Casarez's** posts, blogs, and podcasts, your affiant questions **Casarez's** mental stability. **Casarez's** behavior suggests he is dangerous to others and his posts, blogs, and podcasts demonstrate that he is likely to use his recently purchased firearm dangerously in the present or very near future.

Recent nation wide experiences with mass shootings have demonstrated the need for Gun Violence Restraining Orders (GVRO) and your affiant believes **Casarez** recent behavior coupled with his access to firearm(s) make him a realistic threat to the community and a viable candidate for a Gun Violence Restraining Order.

Your affiant is aware that once obtaining firearms, subjects often retain and cherish these items, especially in light of our current social climate. Your affiant is also aware that the residence is and/or vehicles are common locations to recover the items sought by this warrant, therefore I request a search warrant be issued for the following location.

THE PREMISES OF:

8888 Myhren Way, Orangevale Ca. 95662 located within the County of Sacramento, State of California. 8888 Myhren Way is a single-story single structure located on the south side of the street faces north. 8888 Myhren Way is gray in color with white trim around the doors and windows. Any items tending to establish the identity of persons who have dominion and control of the location, premises, automobiles, or items to be seized, including delivered mail, whether inside the location or in the mail box/s, bills, utility bills, telephone bills, miscellaneous addressed mail, personal letters, personal identification, purchase receipts, rent receipts, sales receipts, tax statements, payroll check stubs, keys and receipts for safe deposit box(s), keys and receipts for rental storage space, keys and receipts for post office box or mail drop rentals, ignition keys, car door and trunk keys, vehicle ownership certificates or "pink slips," and/or vehicle registration slips.
