STATEMENT

Our decision was never about the issue of abortion. It was always about ending the continued outside interference by the donor in the operations of The University of Alabama School of Law. As the attached emails factually establish, the donor attempted to influence:

1. Student admissions;
2. Scholarship awards;
3. The hiring and firing of faculty; and
4. The employment status of the law school dean.

The donor even sought to shield these emails from public view for reasons that are now obvious.

These emails also clearly establish that Chancellor St. John's recommendation to refund all monies and rename the law school came on May 25 – 4 days prior to any public comment by the donor about abortion. The donor's continuing effort to rewrite history by injecting one of society's most emotional, divisive issues into this decision is especially distasteful. These facts should finally set the record straight.

Stuart: We had a good conversation. But the same issues with Mark remain. They are amplified when I read the candidates for the endowed chair in constitutional law. Four weeks ago, I asked Mark what was the status of the search. He casually replied that he had three or four that he was looking into. Well. That was not true. He had done extensive work, and had already spoken with all FIVE. After our conversation, you forced him to send to me the resumes on all five. He would not do it without you ordering him. Had I been part of the process, I would have gone to what I said in my speech and what I told you and him. I wanted a renowned Constitutional law professor. Someone to make academic waves... These are nice additions to a 3880 faculty with an insecure dean-but they are hardly nationally stature constitutional law figures. I believe Mark, you and I come from different concepts. I want the best law school, not a mediocre law school, whose ranking is a simple mathematical manipulation. I also know you have never dealt with a gift of my size-either for endowed professor or for a something as large as to change the name of the law school. You are unprepared. Mark will always be a small town, insecure dean. The outside world frightens him. I do not like any of these candidates for an endowed professorship-they are not the caliber or known ..as I specified and Mark agreed. So please do not associate my name with any of the people, if they are hired. This could have been avoided if Mark was secure. If you would look at this objectively-look at what you have forced Mark to do, whether with switching from decreasing to increasing school size to choosing my endowed professorship with no discussion with me-you would come to my conclusion. You seem to think the quid pro quo is I give you the largest sum and commitment in the school's history and you have no return consideration as your end of the transaction. "Thanks for the money--Good-Bye." You just were not prepared. So process the return of the payments (\$10MM) made in advance. And , if you want to tell the board of regents for the state, fine. Hugh

Dr. Bell, Chad,

I'm forwarding another missive from Hugh, which I received yesterday.

I am inclining toward responding tomorrow with something like the suggested message below. I should mention a couple of things to which I don't propose to respond.

One is his offer of ██████████ as a coordinator for prospective students. Our Admissions Office does well on that front. I do not believe ██████████ would be the best person to step into that role. But even if she were, I would not want a person in the house whose institutional loyalty might be suspect. I won't say these things (except maybe the first) in a message to Hugh.

Another is his desire to have free rein to wander into classrooms. I don't want to be unduly constraining, but I would not want him sitting in on classes without the professor's prior express consent. This is for reasons of academic freedom, given the special place of the classroom in the academy. It is also in candid recognition of Hugh's professed desire to fire ten professors. I do not want my faculty subjected to the scrutiny of someone who may be motivated by a desire to get rid of them.

I'd be grateful for your thoughts.

Thank you for the message.

The project for the Library is speculative at present. There are no bids and no architectural plans at present. Under standard UA processes, we can't solicit plans for a project – much less bids – until the money is in place (or at least predictably secure). We're not at that stage yet.

We will, of course, welcome you in November. I'm sorry to hear that you feel you've been controlled in your visits here. Our guiding motives have always been to respond to your preferences and to provide meaningful opportunities for interaction, subject to the superior coordinating authority of Central Administration and to the effective operation of the School of Law.

We run a fiscally prudent shop, and we coordinate transparently with OAA. As I mentioned in my previous message, I believe we can grow. But we need to do so intelligently and consistent with the best interest of the School of Law.

Second message....

Frankly, I think his assumptions and analysis are flawed. I also think he misunderstands the mission and fiscal logic of a university, the environment in which the Law School operates, the nature of decision making in a public academic institution, and relationship between the School of Law and the University.

I worry, too, that his logic will convert the Endowment for Excellence into a recipe for mediocrity. And it may well blow up the Law School. If one wanted to see Florida or Georgia leapfrog Alabama, this would be one way to do it.

As for balance sheets, we are completely transparent. I've shared our monthly fiscal reports with Kevin and Matt. I feel confident in our numbers. We do get help from UA on scholarships, for which we're enormously grateful. The rest of the books should be in balance. I can bring my Director of Finance for a conversation, if useful.

As for the search for a chair-holder, I'm happy to involve him, solicit advice, and get recommendations and preferences. But we'll be in trouble with accrediting bodies – and vulnerable in the various courts of public opinion – if we are ceding responsibility for choosing chair-holders (or any tenure-line faculty) to non-academics.

In response to his first message, I suggested to Hugh that we talk Friday next week. This will permit me to meet with Chad et al. on Thursday at 3:00, before a conversation with Hugh, if it happens. If you'd like to discuss before next Thursday, I'm happy to talk.

Just so you know, I've quietly consulted with [REDACTED] and [REDACTED] about what's going on with Hugh. They are treating the information with the utmost discretion and confidentiality. They are trusted and trustworthy advisors.

Let me explain the role I had in the business school when Kay Palin replaced Mike Harden. The search picked three candidates. They showed the three to me and asked which I liked. I chose Kay for a number of reasons, especially the diversity of her background. The school picked Kay. My input was a courtesy but it was an acknowledgement of my involvement and commitment. The school did not get \$16MM from my father's estate except when they agreed to my terms after 2 years of litigating. It culminated in a meeting in my home city with the President and he and I negotiated the closing. I separately have donated over \$6.5MM. I expect the

same protocol at the law school. I really don't care if the faculty likes, dislikes me. There are too many and you analyze the 60% grant scholarship numbers and your instate students pay effectively \$1,980. The school could drop 210 students and would have the same revenue as now. Mark, you are also the safe choice in applications. You have 1500 applicants, and extend acceptances to 30%-however only 6% accept. That means only 20% of applicants accepted chose Alabama...ergo--safe choice, see if better school accepts and that happens 24% out of 30. I can take you through the law school's finances, but you are losing a lot of money. You have a ratio of teacher/students that is ridiculous and you need to increase the student body or reduce teachers and support staff. I can take you through all. However, I would ask you to include me as I am the biggest donor and I have a certain set of skills that can help. To date, I have been feted, and kept in the dark. I could give a crap about newspaper articles or even the name on the law school. I want the school to operate the best and for now, you need to forget the ratings. Hugh
