The Grand Jury of said County charge that, before the finding of this indictment, Wendy Pamela Bailey, whose name is otherwise unknown to the Grand Jury, being the natural parent, step-parent, adoptive parent, legal guardian, custodian, or other person who has the permanent or temporary care or custody or responsibility for the supervision of K.R.C. (DoB: 4/13/2023), a child under the age of six years, did torture, willfully abuse, cruelly beat, or otherwise willfully maltreat the said K.R.C. by acts taking place on more than two occasions, in violation of Section 26-15-3.1 of *The Code of Alabama* (1975),

COUNT 2

The Grand Jury of said County charge that, before the finding of this indictment, Wendy Pamela Bailey, whose name is otherwise unknown to the Grand Jury, did commit the crime of Assault in the First Degree, pursuant to Section 13A-6-20 of the Code of Alabama (1975), to-wit: in the course of and in furtherance of the commission or attempted commission of any felony clearly dangerous to human life, to-wit: Aggravated Child Abuse, in violation of Section 26-15-3.1 of The Code of Alabama (1975), and in doing so, the said Wendy Pamela Bailey did cause serious physical injury to another person, to-wit: K.R.C. (DoB: 4/13/2023), the said K.R.C. being the child of the said Wendy Pamela Bailey, in violation of Section 13A-6-130 of The Code of Alabama (1975),

COUNT 3

The Grand Jury of said County charge that, before the finding of this indictment, Wendy Pamela Bailey, whose name is otherwise unknown to the Grand Jury, did commit the crime of Assault in the First Degree, pursuant to Section 13A-6-20 of the *Code of Alabama* (1975), to-wit: by binding and/or tying K.R.C. (DoB: 4/13/2023), with ligature(s), and/or by other unlawful means, in a manner and fashion wherein the said K.R.C.'s person was restrained and/or suspended from a ceiling and/or from another unknown elevated inanimate object(s), a better description of which is otherwise unknown to the Grand Jury, and in the course of and in furtherance of the commission or attempted commission of any felony clearly dangerous to human life, to-wit: Aggravated Child Abuse, in violation of Section 26-15-3.1 of *The Code of Alabama* (1975), and in doing so, the said Wendy Pamela Bailey did cause serious physical injury to another person, to-wit: K.R.C. (DoB: 4/13/2023), the said K.R.C. being the child of the said Wendy Pamela Bailey, in violation of Section 13A-6-130 of *The Code of Alabama* (1975),

(DoB: 4/13/2023), the said K.R.C. being the child of the said Wendy Pamela Bailey, in violation of Section 13A-6-130 of The Code of Alabama (1975),
