Attached hereto is a contour overlay map demonstrating the above-referenced predicted percentage of population within the noise limited service contour served by WESH's original 1.0 signal that is served by the Host Station.

The Licensee's affiliated station, WMTW(DT), Poland Spring, Maine (Facility ID No. 73288), which has not transitioned to 3.0, currently broadcasts its primary programming stream in 1080i resolution and four (4) multicast streams each in 480i resolution, which are more programming streams than the above-referenced programming streams for KQCA. Accordingly, the Licensee is not seeking to license more capacity on the Host Station than WESH would use if it were still operating its own facility in 1.0.

WESH schedules at least three-hours per week of core programming on its primary stream, and therefore does not currently, and does not intend to, rely on its non-primary multicast streams

for compliance with the Commission's children's television programming requirements. Accordingly, WESH's compliance with the Commission's children's television programming requirements and viewers' access to the station's core programming is not affected by the broadcast of its multicast streams from the Host Station. In any event, as noted above, WESH's multicast streams are carried on a Host Station that serves at least 95 percent of the predicted population served by WESH's original 1.0 signal.

The Licensee has provided the required notification to viewers and the relevant MVPD distributors.
