To participate, watch WBAL-TV during the Sweepstakes Period, Monday through Friday between the hours of 3:00pm and 4:00pm. Each afternoon/night of the Sweepstakes will have a separate entry period (each an “Entry Period”), and each Entry Period will begin at

3:00pm and end at 11:59pm of that same day. A Keyword will be announced during the “Tamron Hall Show” aired between 3:00pm and 4:00pm. Viewers must watch for the Keyword, because knowledge of the Keyword is necessary in order to enter.

TO ENTER: After the Keyword is announced during The Tamron Hall Show, participants may log onto www.facebook.com/wbaltv11, enter the Keyword, your name, age, mailing address, valid email address, and telephone or mobile phone number. Limit one entry per person per each Entry Period. All entries must be received during each Entry Period.

Should news events or technical issues disrupt or cancel the regularly scheduled broadcast of “Tamron Hall” during the 3:00PM broadcast time during this period, that day’s “Daily Word” announcement will be eliminated from the Sweepstakes offering.
