Official Rules

- 1. GENERAL:** No purchase necessary. MAKING A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING. Void where prohibited or restricted by law. The Red Mountain Theatre “Fiddler on the Roof” Sweepstakes (“Sweeps”) is sponsored by WVTM 13 TV and Red Mountain Theatre. This Sweeps is subject to all applicable federal, state, and local regulations.

The Promotion Period begins May 26th, 2017 at 12:01 a.m., and ends at 11:59 p.m. on June 8th, 2017 (“Promotion Period”). All times refer to Central Time (“CT”).

- 2. PRIZES AND ODDS OF WINNING:** Five (5) Prize Winners will be randomly selected from all entries received during the Promotion Period on June 9th, 2017.

Prize Winners will receive two (2) vouchers for tickets to see Fiddler on the Roof by the Red Mountain Theatre. Vouchers are good for any show during Fiddler on the Roofs 2017 runtime. Show begins on June 9th and runs through June 23rd, 2017. Fiddler on the Roof will be presented at the Dorothy Jemison Day Theater in Birmingham, AL. Winners can check on individual show times and show dates by visiting redmountaintheatre.org/our-season/fiddler-on-the-roof/. Dates and seat location of Winner’s attendance depend on availability at the time of booking.

Approximate Prize Value (“ARV”) of Prize: \$72 (\$36 per ticket)

Total Approximate Retail Value (“ARV”) of Prizes: \$360

All Prize details will be determined by Sponsors in their sole discretion. If a Prize element is not available for any reason, as determined by Sponsors in their sole discretion, the remaining elements of Prize shall be awarded and shall constitute full satisfaction of Sponsors’ Prize obligation to Winner and no additional compensation will be awarded. Additional restrictions may apply. Sponsors reserve the right to substitute a similar prize (or Prize element) of comparable or greater value for any reason at their sole discretion. All taxes and other unspecified expenses, costs, or fees associated with the acceptance and/or use of Prize are the sole responsibility of Winner and their guests. Winner and guests must follow Red Mountain Theatre Company rules at all times during prize redemption or forfeit prize. Prize cannot be transferred by Winner or redeemed for cash and is valid only for the items detailed above, with no substitution of Prize by Winner. Winners will be contacted by phone or email by a WVTM13 employee or agent of Sponsor(s). Winner is subject to verification. Prize is non-transferable by the Winner.

- 3. ELIGIBILITY:** Sweeps is offered only to legal U.S. residents who are 18 years of age or older at the time of entry. Sweeps is offered only to Alabama residents who reside within the Birmingham-Anniston-Tuscaloosa Designated Market Area (“DMA”) as determined by Nielsen Media Research Services. Current and former employees of WVTM13-TV, Hearst Television Inc., Hearst Stations Inc., Red Mountain Theatre Company (Together, “Sponsor”), and current employees of Hearst Corporation, WooBox, and each of their respective

parents, subsidiaries, affiliates, franchisees, licenses, directors, owners, employees and agents, their parent, subsidiary, and affiliated companies, and their advertising or promotional agencies (collectively, the “Sweeps Entities”), and the immediate families or members of the same households of such individuals are not eligible. The term “immediate families” refers to spouses, parents, children, siblings, grandparents, and grandchildren. No groups, clubs, or organizations may participate in this Sweeps or reproduce or distribute any portion of these Rules to their members. Proof of age, identity, and eligibility must be furnished to Sponsors upon request. All entry form information must be complete and accurate. Viewers may enter by going to www.facebook.com/WVTM13, clicking on the Sweepstakes tab and following the instructions to access, complete, and submit an electronic entry during the Promotion Period. To enter the Sweeps you must have a valid Facebook account.

In the event of a dispute over the identity of an online entrant, entry will be deemed submitted by the authorized account holder of the email address at time of entry. Limit one (1) entry per person. Sponsors may not verify receipt of entries. Entries become property of Sponsors. Incomplete entries are ineligible. Potential Winner must respond to notification within twenty-four (24) hours of initial notification, or Prize may be forfeited and a new Winner will be randomly selected by Sponsor. Winner is required to sign and return appropriate forms and/or documentation, including but not limited to an Affidavit of Eligibility, a Liability Release and/or where legally permissible a Publicity Release within ten (10) days following the date of first attempted notification. Winner hereby further agrees to sign any documents necessary to transfer copyright of the entry to Sponsor within ten (10) days following the date of first attempted notification. Failure to sign and return such forms within the requisite timeframe could result in disqualification.
